The subsequent filing of the Articles of Incorporation for this joint authority will allow financing working capital; acquiring, holding, constructing, financing, improving, maintaining and operating, owning or leasing, either in the capacity of lessor or lessee, projects and providing financing for insurance reserve; and any other lawful purpose for parks, recreation grounds, and facilities as set forth in 53 Pa.C.S. §5607(a)(4). Pursuant to the Municipal Authorities Act, 53 Pa.C.S., Chapter 56, the Township together with the Borough of Gettysburg will file the Articles of Incorporation for Gettysburg Area Recreation Authority with the Secretary of the Commonwealth on June 7, 2013.

CHAPTER 56; SETTING FORTH AND AUTHORIZING EXECUTION OF ARTICLES OF INCORPORATION; APPOINTING AND FIXING THE TERMS OF THE FIRST MEMBERS OF THE BOARD OF SUCH AUTHORITY; AUTHORIZING ALL OTHER NECESSARY ACTION; AND REPEALING ALL INCONSISTENT ORDINANCES OR PARTS OF ORDINANCES."

The Ordinance signifies the desire and intent of the Borough of Gettysburg to establish a joint authority with Cumberland Township to be known as the "Gettysburg Area Recreation Authority" for the purpose of promoting and developing recreation and park opportunities for residents of the Borough of Gettysburg and Cumberland Township, The Ordinance also authorizes the Borough Council President or Vice President and the Borough Secretary or such other appropriate officers of the Borough of Gettysburg to execute and file the Articles of Incorporation for the "Gettysburg Area Recreation Authority" with the Secretary of the Commonwealth of Pennsylvania and to take any and all other actions necessary or desirable to effectuate said incorporation. The Ordinance and the Articles of Incorporation include the appointment of the initial members of the Board of the Authority by the Borough of Gettysburg and set forth their respective terms of office. Pursuant to the Ordinance and the Articles of Incorporation, the Gettysburg Area Recreation Authority shall be authorized and shall have the powers and purposes of financing working capital; acquiring, holding, constructing, financing, improving, maintaining and operating, owning or leasing, either in the capacity of lessor or lessee, projects and providing financing for insurance reserves; and any other lawful power or purpose for parks, recreation, grounds and facilities, as set forth in Section 5607(a)(4) of the Municipality Authorities Act. The Articles of Incorporation for the creation of the Gettysburg Area Recreation Authority shall be filed by the Borough of Gettysburg and Cumberland Township with the Secretary of the Commonwealth on June 7, 2013 consistent with the provisions of the Municipality Authorities Act.
