

### ARTICLES OF AMENDMENT

NOTICE HEREBY IS GIVEN that the Board of Northern Tier Solid Waste Authority (the "Authority"), a Pennsylvania municipality authority having its registered office at P.O. Box 10, Burlington, Pennsylvania, has adopted a resolution proposing certain amendments to its Articles of Incorporation; the Authority has submitted the proposed amendments to the Commissioners of Bradford County, the Commissioners of Sullivan County and the Commissioners of Tioga County, Pennsylvania (the "Commissioners"), the Commissioners, by Resolution of each respective County, duly adopted, has approved the amendments to the Articles of Incorporation of the Authority; the Authority intends to file Articles of Amendment to its Articles of Incorporation with the Secretary of the Commonwealth of Pennsylvania on November 22, 2019 or soon thereafter: such Articles of Amendment are to be filed under provisions of the Pennsylvania Municipality Authorities Act, 53 Pa. C.S. Ch. 56, as amended and supplemented; and the nature and character of such proposed amendments are to amend the Articles of Incorporation to increase the term of existence of the Authority and revise the purposes and powers of such Authority, by adding the following paragraphs to the Articles of Incorporation:

"4. Purposes and Powers of Authority. The Authority shall have all the powers and purposes of a municipality authority granted under the Municipality Authorities Act."

"9. The term of existence of the Authority shall be extended in accordance with Section 5605(a)(2) of the Municipality Authorities Act and shall not exceed fifty (50) years from the date of approval of the Articles of Amendment." CHRISTOPHER R. LANTZ,
