### **OPINION AND ORDER**

By: Conrad, J.

Before the court is the Motion for Judgment on the Pleadings filed by Patrick Industries, Inc., which seeks to strike all of Plaintiff's allegations as to it based on employer immunity afforded to it under the Pennsylvania Workers' Compensation Act.<sup>1</sup> For the reasons that follow, the Motion will be granted.

#### **History of the Case**

This matter arises out of a workplace injury that occurred on July 25, 2023, when Plaintiff's left hand got caught in the roller of a laminating coater causing her serious and permanent injury. Plaintiff commenced this action by complaint filed on July 16, 2024. On September 4, 2024, Defendant Patrick Industries, Inc. ("Patrick") filed preliminary objections. On September 25, 2024, Plaintiff filed a first amended complaint. On September 27, 2024, Plaintiff and Defendant Finzer Roller entered into a stipulation whereby Plaintiff agreed to dismiss its claims for punitive damages against Finzer Roller at Counts II, III, and IV without prejudice.

On October 9, 2024, Finzer Roller filed its answer, new matter and a cross claim against Patrick and Harlan Machinery Company. Plaintiff filed a reply to Finzer Roller's new matter on October 9, 2024. It does not appear that Patrick filed an answer to Finzer Roller's cross claim.

On December 4, 2024, Patrick filed an answer and new matter to Plaintiff's first amended complaint. Plaintiff filed a reply to Patrick's answer with new matter<sup>2</sup> and on December 6, 2024, Finzer Roller filed an answer to Patrick's cross claim. No other pleadings have been filed to date although docket entries show service has been made on defendants Harlan Machinery Company and Rota Dyne.

On January 13, 2025, Patrick filed its Motion for Judgment on the Pleadings. On January 23, 2025, Plaintiff filed her response. A reply brief was filed by Patrick on February 17, 2025. The docket also shows a motion to compel discovery filed by Plaintiff in January and responded to by Patrick in February, 2025; however, counsel for the parties have not submitted their discovery dispute pursuant to Lancaster County local rules of court.<sup>3</sup>

Plaintiff's first amended complaint identifies all the defendants as being "in the business of designing, manufacturing, assembling, selling, distributing, transporting, delivering, maintaining, inspective, and/or installing laminate coater products." (See first amended complaint paragraphs 4, 5, 9, 11, 13). The Plaintiff further alleges that the "equipment as designed, manufactured, assembled, sold, distributed, transported, delivered, and/or installed was defective because it lacked any proper guarding, the safety bar and/or emergency stop system were defective and failed to stop the rollers, and there was no method for cleaning the coater without facing risk of injury." (See first amended complaint paragraph 14).

With regard to the manner in which the Plaintiff's injury was sustained, the facts allege:

- 18. On July 25, 2023, Plaintiff was cleaning the coater as she was trained to do, while the rollers were in motion, with no guard on the machine, and with no proper tools to keep her hand away from the rollers.
- 20. On July 25, 2023, the Plaintiff, by herself and with no operator partner, was scraping the bottom roller of the board coater while it was running with her left hand and a short, hand-held scraper, when her hand was caught in between the underside of a plate where a board enters the coater and a bottom moving roller.
- 21. The Plaintiff's left hand got caught in the moving roller and when she pulled the safety bar to spread apart the rollers and/or stop the roller, the roller continued to spin. A coworker came over and pulled the safety bar and again nothing happened. Ultimately, the coworker was able to free the Plaintiff's hand from the roller by brute force and the Plaintiff was life-flighted for medical care.

The first amended complaint contains four counts: Count 1 (Negligence under the Dual Capacity Doctrine against Patrick); Count 2 (Strict Liability for Defective Design, Manufacturing, and Failure to Warn against Defendants Patrick, Harlan, Finzer, and Rotation); Count

The court also notes that it did not become aware of the pending motion for judgment on the pleadings until July 3, 2025, when the Prothonotary generated a civil case tracking report showing cases that have been pending disposition for greater than 90 days. The Prothonotary has no mechanism to know when a file should be brought to chambers unless a Praecipe for Disposition is filed and chambers is unaware that any action is needed unless the file is brought to chambers.

3 (Breach of Warranty against Defendants Patrick, Harlan, Finzer and Rotation); and Count 4 (Negligence and Recklessness against all defendants).

Patrick's motion asserts that Plaintiff has failed to state a legally valid cause of action against Patrick because of the exclusivity provision of the Act. Plaintiff argues that the motion should be denied because she alleges two exceptions to the Act.

### **Discussion**

Pennsylvania Rule of Civil Procedure 1034(a) authorizes entry of judgment on the pleadings after the pleadings are closed, but within such time as not to delay trial. "A motion for judgment on the pleadings is similar to a demurrer. It may be entered when there are no disputed issues of fact and the moving party is entitled to judgment as a matter of law." *Mellon Bank, N.A. v. National Union Ins. Co.*, 768 A.2d 865, 868 (Pa. Super. 2001) (citations omitted). Further, since a motion for judgment on the pleadings is not a motion for summary judgment, no affidavit or depositions may be considered, nor is any matter before the court except the pleadings. *See Bogojavlensky v. Logan*, 181 Pa. Super. 312, 124 A.2d 412 (1956).

The court "must accept as true all well pleaded statements of fact of the party against whom the motion is granted and consider against him only those facts that he specifically admits. The court will grant such a motion only when the moving party's right to succeed is certain and the case is so free from doubt that a trial would clearly be a fruitless exercise. *John T. Gallaher Timber Transfer v. Hamilton*, 932 A.2d 963, 967 (Pa. Super. 2007).

In this case, the trial court is asked to determine whether the immunity provision of the Act bars Plaintiff's claim against Patrick. This provision states:

(a) The liability of an employer under this act shall be exclusive and in place of any and all other liability to such employes, his legal representative, husband or wife, parents, dependents, next of kin or anyone otherwise entitled to damages in any action at law or otherwise on account of any injury or death....

#### 77 Pa. C.S.A. § 481(a).

As has been oft stated by our courts, "[t]he Act reflects a compromise that has prevailed in Pennsylvania for decades: in exchange for their mandatory contributions to a no-fault insurance program, employers avoid the risks and uncertainties of defending against lawsuits arising from such injuries." *Franczyk v. Home Depot, Inc.*, 292 A.3d 852, 853 (Pa. 2023). The Court in that case further stated that only a few narrow exceptions have been recognized over the Act's long history. *See Id.* 

Plaintiff argues two exceptions to the Act: First, that Patrick has a "dual capacity," as an employer and as a designer, manufacturer, etc., of the laminate coaters which subjects him to liability in tort. Second, that Patrick engaged in gross or reckless conduct which is an exception

to the Act's immunity provision.

### A. Dual Capacity Exception.

The "dual capacity" doctrine is described as follows: Under this doctrine, an employer normally shielded from tort liability by the exclusive remedy principle may become liable in tort to his own employee if he occupies, in addition to his capacity as employer, a second capacity that confers on him obligations independent of those imposed on him as employer.

Budzichowski v. Bell Telephone Co., of Pennsylvania, 503 Pa. 160, 167, 469 A.2d 111, 114 (1983) (citing 21 Larson, Workmen's Compensation Law, Section 72.8, p. 14-112 (1976)).

In *Budzichowski* the Court held that the employer, Bell, was not operating in a "dual capacity" when the doctors employed by it were "persons in the same employ" as the injured employee. The facts of the case show that the employee was injured after falling when he was trying to ward off a customer's dog while installing a phone at the customer's residence. He reported to the Bell Medical Dispensary for treatment where the doctors diagnosed him with an inguinal strain and hip strain. Because he continued to experience pain, he consulted an orthopedical surgeon six months later and learned that the bone in the head of his right femur had deteriorated and he required a bone graft operation.

Suit was brought against the doctors who treated his injuries at the dispensary and the employer. The employer filed a motion for summary judgment alleging that the doctors were its full-time employees the same as the injured employee. The trial court granted the motion and the Superior Court affirmed.

The Supreme Court affirmed and rejected the employee's argument that Bell was not immune from suit under the exclusivity provisions of the Act because when the negligence was committed, Bell was not acting as an employer but in a "dual capacity" as a provider of health care. The employee relied on the Court's decision in Tatrai v. Presbyterian University Hospital, 497 Pa. 247, 439 A.2d 1162 (1982) where the Court held that an employee of the hospital who became ill at work could sue her employer when she was injured in the emergency room where she went for treatment for her illness. The Court distinguished *Tatrai* on the basis that the employer was a hospital that served the general public unlike the dispensary that treated only Bell employees. The Court further explained its reasoning in Tatrai saying the treatment provided to the employee would have been provided absent the employment relationship. Budzichowski, 503 Pa. at 168, 469 A.2d at 115. Applying this distinction to the case at bar, the Court found that Bell, as the employer, was not operating in a "dual capacity" but instead was acting only as the employer. Thus, the Court concluded that the only remedy the employee had for his work-related injuries was provided by the Act.

Plaintiff argues that Patrick owes a duty to Plaintiff that is separate from the work relationship because the Defendant is in the business of designing and maintaining coaters. The argument is belied by the activity in which the Plaintiff was engaged at the time of the injury, which was cleaning a coater on behalf of her employer, Patrick, with the injury occurring at her place of employment.

Plaintiff is unlike the employee in *Tatrai*, who was treating for an illness at the emergency department of her employer, a public hospital, when she was injured. Here, while the allegations in Plaintiff's first amended complaint are cleverly contorted in an attempt to disguise the fact that Plaintiff was engaged in the performance of her job at the time of her injury, it is still an inescapable conclusion when viewing the pleading in its entirety. Thus, the "dual capacity" exception does not apply.<sup>4</sup>

### B. Gross or Reckless Conduct Exception.

Plaintiff also argues that intentional conduct rising to recklessness is an exception to Worker's Compensation immunity. She alleges facts which would support a finding of recklessness such as not having guards for the coater machine, not providing safety equipment for the task of cleaning the machine, and forcing employees to continue to engage in a dangerous activity of cleaning the machine without stopping the moving rollers even after the OSHA investigation that resulted in a fine for the workplace accident.

There is no carve out in the Act itself for an employee to bring suit against an employer for reckless or even intentional acts. Further, the case law on this issue has not been helpful to an employee who has suffered such an injury at the hands of a less than scrupulous employer.

One of the few cases finding for the employee under such circumstances was the Pennsylvania Supreme Court's decision in *Martin v. Lancaster Battery Co.*, 530 Pa. 11, 606 A.2d 444 (1992). In that case the Court held that an employee is not limited to the remedies under the Workmen's Compensation Act and could bring a common law action against his employer for fraudulent misrepresentation. The fact show that the employer was required by Federal safety regulations to test employees due to their work environment exposing them to lead. The employer falsified the results of the employee's blood tests over a three-year period until the employee was diagnosed with lead toxicity, lead neuropathy, hypertension, gout, and renal insufficiency. The severity of his condition would have been substantially reduced had his employer promptly and accurately reported the elevated levels of lead in the employee's blood.

The Court explained that the employee was not seeking compensa-

The plaintiff in Heath brought a product's liability claim against the employer who was also a manufacturer of the equipment, a chicken saw, causing the employee's injury.

tion for the work injury itself but rather was seeking compensation for an aggravation of a pre-existing work injury caused by the delay in treatment due to the employer's fraudulent misrepresentation. The Court stated:

There is a difference between employers who tolerate workplace conditions that will result in a certain number of injuries or illnesses and those who actively mislead employees already suffering as the victims of workplace hazards, thereby precluding such employees from limiting their contact with the hazard and from receiving prompt medical attention and care.

Id., 530 Pa. at 18, 606 A.2d at 448.

Most recently the Supreme Court in *Franczyk v. Home Depot*, held that the Act's exclusivity provision barred an employee from bringing suit for negligence against her employer after she was bitten by a customer's dog at work and the employer prohibited her from obtaining information from the dog owner or from witnesses to the dog bite so she could bring suit against the dog owner. The employee's claim against her employer asserted that the employer failed to investigate the dog bite incident and it allowed the dog owner and witnesses to leave without first obtaining identifying information about the dog owner.

In support of her civil claim against her employer, the employee contended that the injury she sustained was distinct from and arising after the workplace injury and that the employer's wrongful conduct caused that harm. The Court nevertheless concluded that Section 411's definition of "injury in the course of employment" suggests a categorical ban against any worker's claim for damages that is not among those specifically excepted," *Id.* at 857, and the Court was unwilling to find any exception to the Act's statutory language based upon the facts of the case.

The Court also distinguished the facts of *Martin*, which Franczyk argued was like her case, by explaining that Franczyk was not seeking damages for the underlying injury but rather for the distinct harm she suffered when her employer failed to take reasonable steps to enable her to pursue a third-party claim against the dog owner. The Court concluded that the asserted injury was "intertwined' inextricably" with the workplace injury and the only way that her damages could be determined would be to require a trial within a trial and then try to imagine what a jury would award as damages against the dog owner. *Id.* at 862. This, according to the Court, was the sort of claim the Act is to prevent.

Here, Plaintiff likewise relies on Martin but does not articulate how

The terms "injury" and "personal injury" as used in this act, shall be construed to mean an injury to an employe, regardless of [her] previous physical condition, . . . arising in the course of [her] employment and related thereto . . . . The term "injury arising in the course of [her] employment," as used in this article, shall not include an injury caused by an act of a third person intended to injury the employe because of reasons person to [her] as an employe or because of [her] employment; nor shall it include injuries sustained while the employe is operating a motor vehicle provider by the employer; . . . but shall include all other injuries sustained while the employe is actually engaged in the furtherance of the business or affairs of the employer . . . . *Id.* (citing 77 P.S. § 411(1)).

the facts of her case are similar to the facts of that case, especially as she has not sustained any type of separate injury arising after the workplace injury. Plaintiff merely concludes that intentional conduct, rising to the level of recklessness, is an exception to Worker's Compensation immunity without fully developing her argument for this assertion.<sup>6</sup>

Accordingly, the court hereby enters the following:

The Court in Franczyk briefly mentions several other cases in which the Court found the Act was the exclusive remedy even when there was an intentional act done by the employer. See Poyser v. Newman & Co., 514 Pa. 32, 522 A.2d 548 (1987) (employer's intentional act of disregarding safety regulations does not trigger an exception to exclusivity); Kuney v. PMA Insurance Co., 525 Pa. 171, 578 A.2d 1285 (1990) (dismissing employee's civil claim for emotional distress after employer willfully refused to pay workers' compensation benefits for total disability benefits).
