## Cody v. Cody

Divorce - Petition to enforce - Prenuptial agreement - Separation agreement - Duress

- 1. Settlement agreements, whether pre-nuptial or post-nuptial, are contracts and thus governed by the same rules of law used in determining the validity of contracts.
- 2. Absent fraud, misrepresentation, or duress, parties are generally bound by the terms of their agreements.
- 3. Courts have rejected the assertion that economic disclosure cannot be waived because the party waiving disclosure does not know the extent of what is being waived.
- 4. Duress is defined as that degree of restraint or danger, either actually inflicted or threatened and impending, which is sufficient in severity or apprehension to overcome the mind of a person of ordinary firmness.
- 5. In the absence of threats of actual bodily harm, there can be no duress where the contracting party is free to consult with counsel.
- 6. Where spouses desire to settle and determine their respective property rights finally and for all time, their agreement should be construed as a postnuptial agreement, rather than as a separation agreement that is terminated by a subsequent reconciliation of the parties.
- 7. A separation agreement generally provides for a separation and for the spouse's support during that separation, and subsequent reconciliation and cohabitation presumably ends the deed of separation.
- 8. Whether the parties have abandoned their contract is a question of intent as determined from their statements, their conduct and all surrounding circumstances.
- 9. The parties to an agreement may always rescind or abandon it, and even where a written contract prohibits a non-written modification, it may be modified by subsequent oral agreement.
- 10. Plaintiff filed a petition to enforce prenuptial agreement and separation agreement, to strike certain counts of the counter-complaint in divorce, and for special relief. Defendant filed a petition to set aside premarital agreement and requesting declaratory judgment. Following a hearing on the matters, the Court <u>Held</u> that the prenuptial agreement was enforceable, the separation agreement was unenforceable, and all other relief was denied without prejudice to raise them before the Hearing Officer in equitable distribution.

## **ORDER and MEMORANDUM**

AND NOW, this 17th day of March, 2021, after a hearing on March 1, 2021 on (1) Plaintiff's Petition to Enforce Prenuptial Agreement and Separation Agreement, to Strike Counts IV and V of the Counter-Complaint in Divorce and for Special Relief, filed December 7, 2020, and on (2) Defendant's Petition to Set Aside Premarital Agreement Pursuant to 23 Pa.C.S.A. [sic] § 3106 and Requesting Declaratory Judgment Pursuant to 42 Pa.C.S.A. [sic] § 7533, filed January 28, 2021, it hereby **ORDERED**, as follows:

1. The Prenuptial Agreement between the parties made on November 21, 2018 is enforceable;

2. The Separation Agreement between the parties made on February 17, 2020 is unenforceable; and

3. All other requests for relief are denied without prejudice to each party's right to raise them before the Hearing Officer in Equitable Distribution as appropriate.

#### **MEMORANDUM**

#### I. <u>Regarding the Prenuptial Agreement</u>

The Prenuptial Agreement is enforceable. It is on its face a binding prenuptial agreement between Plaintiff/Husband and Defendant/Wife. It was signed by Defendant/Wife on November 15, 2018 and by Plaintiff/Husband on November 21, 2018. Defendant/Wife attacked the Prenuptial Agreement on two (2) grounds. Defendant/Wife argued first that "she was not provided a fair and reasonable disclosure of Husband's property or financial obligations. Petition, 1/28/21, ¶ 10. Defendant/ Wife argued second that "she did not execute the Agreement voluntarily." Petition, 1/28/21, ¶18.

"Settlement agreements, whether pre-nuptial or post-nuptial, are contracts and thus governed by the same rules of law used in determining the validity of contracts." Lewis v. Lewis, 234 A.3d 706, 714 (Pa.Super. 2020) (citing Adams v. Adams, 848 A.2d 991, 993 (Pa. Super. 2004) and Stackhouse v. Zaretsky, 900 A.2d 383, 386 (Pa. Super. 2006)). "Absent fraud, misrepresentation, or duress, parties are generally bound by the terms of their agreements." Lewis, 234 A.3d at 714 (citing Adams, 848 A.2d at 993 and Simeone v. Simeone, 581 A.2d 162, 165 (Pa. 1990)). Here, Defendant/Wife failed to prove misrepresentation. The Prenuptial Agreement recites: "The parties have disclosed to their satisfaction all assets and liabilities that each may have and voluntarily and expressly waive any rights to further disclosure of property or financial obligations of each other beyond the disclosure that has already been provided." Prenuptial Agreement, Exhibit P-3, ¶ H. Defendant/Wife argued that the express waiver language is inoperative in this case because there was no disclosure at all and thus there was the nonoccurrence of the condition precedent that there be at least some disclosure. The problem with that argument is it presumes that the provision requires disclosure when it requires only satisfaction. The provision allows that parties could be satisfied with a disclosure of nothing at all and thus it operates as a waiver the same when there is disclosure and when there is not disclosure. Upon that reading this court could presume that there was no disclosure and still this court was bound to find a legally operative waiver. Accord Lugg v. Lugg, 64 A.3d 1109, 1112 (Pa.Super. 2013) ("Similarly, we must reject the assertion that economic disclosure cannot be waived because the party waiving disclosure does not know the extent of what is being waived.").

Second, Defendant/Wife failed to prove that her signing of the Prenuptial Agreement was involuntary. Duress is defined as "that degree of restraint or danger, either actually inflicted or threatened and impending, which is sufficient in severity or apprehension to overcome the mind of a person of ordinary firmness." <u>Lewis</u>, 234 A.3d at 715 (quoting <u>Carrier v. William Penn Broadcasting Co.</u>, 233 A.2d 519, 521 (Pa. 1967). "Moreover, in the absence of threats of actual bodily harm there can be no duress where the contracting party is free to consult with counsel." <u>Id</u>. The Supe-

rior Court has concluded that "[d]aily badgering and one and one-half hours of 'pressure and negotiations' does not rise to the level of coercion necessary to find duress." Lugg v. Lugg, 64 A.3d 1109, 1113-1114 (Pa. Super. 2013).

Here, the credible evidence established the absence of threats of bodily harm. Here, Plaintiff/Husband testified that he presented the Prenuptial Agreement thirty (30) days in advance and Defendant/Wife testified that she had a few weeks to review the Prenuptial Agreement. This court could not find that Defendant/Wife signed the Prenuptial Agreement under duress.

## II. Regarding the Separation Agreement

Preliminarily it should be noted that the Separation Agreement is not a separation agreement, strictly speaking. Where spouses desire to settle and determine their respective property rights finally and for all time, their agreement should be construed as a postnuptial agreement, rather than as a separation agreement that is terminated by a subsequent reconciliation of the parties. Vaccarello v. Vaccarello, 757 A.2d 909, 911 (Pa. 2000). See also Makowski v. Makowski, 62 A.2d 71, 73 (Pa.Super. 1948) ("A separation agreement generally provides for a separation and for the [spouse's] support during that separation, and subsequent reconciliation and cohabitation presumably ends the deed of separation.") (citing In re Henkel's Estate, 59 Pa.Super. 633 (1915)). Here, the Separation Agreement made on February 17, 2020 recites that it may be incorporated into a divorce decree and it addresses spousal maintenance, assets, debts, equitable distribution, rights of inheritance, and pensions, among other things. It is clear from the face of the document that the parties anticipated no further disposition of their rights. Moreover, the parties agreed that reconciliation alone would be insufficient to terminate the Separation Agreement. See Separation Agreement, Exhibit P-4, ¶ 23. Under these circumstances, the Separation Agreement is a postnuptial agreement and not a separation agreement discharged by the parties' reconciliation.

However, this court has concluded that the Separation Agreement is nevertheless unenforceable. "Whether the parties have abandoned their contract is a question of intent as determined from their statements, their conduct and all surrounding circumstances." <u>Makowski v. Makowski</u>, 62 A.2d 71, 73 (Pa.Super. 1948) (citing <u>In re Ray's</u> <u>Estate</u>, 156 A. 64 (Pa. 1931); <u>Zlotziver v. Zlotziver</u>, 49 A.2d 779 (Pa. 1946)). The parties to an agreement may always rescind or abandon it, and even where a written contract prohibits a non-written modification, it may be modified by subsequent oral agreement. <u>Kirk v. Brentwood Manor Homes, Inc.</u>, 159 A.2d 48 (Pa.Super. 1960). Here, the court credited the testimony from Defendant/Wife that the parties reconciled and thereupon resolved to make their marriage work and that Plaintiff/Husband sent a text to inform Defendant/Wife that he has shredded the Separation Agreement and that it is destroyed. It was that unequivocal and unmistakable manifestation of intent to abandon the Separation Agreement that is the basis of this court's ruling that the Separation Agreement is unenforceable.

Accordingly, for the reasons set forth above, this court will enter an order

ruling on the enforceability of the Prenuptial Agreement and the Separation Agreement in anticipation of proceedings before the Hearing Officer in Equitable Distribution consistent with this court's rulings.
