

Land Use Appeal – Dimensional Variance Request Denial

- 1. Before the Court is a Land Use Appeal filed by the Appellant, Wellington Investment Group, LLC.
- 2. Appellant filed a variance request with the Hearing Board, related to a proposed subdivision of the Property into 98 residential lots.
- 3. The decision issued by the Hearing Board stated that the variance request had been denied because Appellant had failed to present sufficient evidence to establish an "unnecessary hardship."
- 4. Appellant argues that the Hearing Board failed to analyze its requests under controlling precedent.
- 5. Although there is a lesser degree of proof required for dimensional variances, case law has determined that there is still a standard of hardship that must be established by the landowner for a variance to be granted
- 6. In reviewing a land use appeal, where the Court takes no additional evidence, it is limited in scope to a determination of whether the local agency abused its discretion or committed an error of law.
- 7. Because the Zoning Board decided that Wellington failed to meet even the lower burden for dimensional variances, the Court declined to reverse the Zoning Board's decision.

#### **MEMORANDUM OPINION**

Presently before the Court is a Land Use Appeal filed by the Appellant, Wellington Investment Group, LLC ("Wellington"). The Appellee in this matter is Windsor Township Zoning Hearing Board ("Hearing Board"). This matter was further joined by an intervenor: Windsor Township ("Township"). For the reasons set forth herein, Wellington's Appeal is **DENIED** and the original ruling by the Windsor Township Zoning Hearing Board has been **UPHELD**.

#### FACTS AND PROCEDURAL HISTORY

The basic facts do not seem to be at much dispute between the parties. Wellington is the fee simple owner of a parcel of land located in Windsor Township consisting of approximately 28.95 acres. On August 3, 2020, Wellington filed a variance request with the Hearing Board, related to a proposed subdivision of the Property into 98 residential lots. A total of three variance requests were made by Wellington. A hearing was held on August 26, 2020, before the Hearing Board. After the hearing, a written decision denying the requested variances was issued on September 21, 2020.

On October 19, 2020, Wellington filed an Appeal in the York County Court of Common Pleas asking this Honorable Court to reverse the decision of the Hearing Board and grant the variances previously requested. Both parties filed memoranda. This matter was then assigned to the undersigned judge.

#### DISCUSSION

The primary issue at hand is whether or not the Hearing Board abused its discretion and committed errors of law by denying the variances sought by Wellington.

In reviewing a land use appeal, where this Court takes no additional evidence, it is limited in scope to a determination of whether the local agency abused its discretion or committed an error of law. Kassouf v. Township of Scott, 883 A.2d 463 (Pa. 2005). "An abuse of discretion is not merely an error of judgement, but is rather the overriding or misapplication of the law, or the exercise of judgement that is manifestly unreasonable, or the result of bias, prejudice, ill-will or partiality, as shown by the evidence of record." Com. V. Hyland, 875 A.2d 1175 (quoting Com. V. Carter, 861 A.2d. 957 (Pa.Super. 2004) (en banc)). This Court may conclude that the board abused its discretion only if the findings are not supported by substantial evidence. Valley View Civic Assoc. v. Zoning Board of Adjustment, 462 A.2d 637 (Pa. 1983). The Pennsylvania Supreme Court describes substantial evidence as being "relevant evidence as a reasonable mind might accept as adequate to support a conclusion." Id.

A court may not substitute its interpretation of the evidence for that of the zoning hearing board. *Taliaferro v. Darby Township* Zoning Hearing Board, 873 A.2d 807 (2005). It is the function of the board, not the court, to weigh the evidence before it. Id. The board is the sole judge of the credibility of witnesses and the weight afforded to their testimony. Id. Assuming that the record contains substantial evidence, the court is bound by the board's findings that result from resolutions of credibility and conflicting testimony rather than a capricious disregard of evidence. Id. The fact that the Board's findings may be contrary to an unimpressive amount of evidence and testimony does not show that the Board's findings are unsupported by substantial evidence. Lower Allen Citizens Action Group, Inc. v. Lower Allen Twp. Zoning Hearing Bd., 93 Pa.Cmwlth. 96, 500 A.2d 1253 (1985) (citing Kells v. Unemp't Comp. Bd. Of Review, 32 Pa.Cmwlth. 142, 378 A.2d 495 (1977)).

In the present matter, Wellington filed their appeal on October 19, 2020, on the Hearing Board's decision to deny its request for variances relating to parcel of land at issue. In order to establish the right to a variance, applicants must show that the zoning ordinance uniquely burdens the property with an unnecessary hardship and that the variance would not adversely affect the public health, safety, or welfare. <u>Vanguard v. Zoning Hearing</u> <u>Board</u>, 568 A.2d 703 (Pa.Cmwlth., 1989). The decision issued by the Hearing Board stated that the request had been denied because Wellington had failed to present sufficient evidence to establish an "unnecessary hardship."

Wellington argues that the Hearing Board failed to analyze its requests under controlling precedent. The three separate variances requested by Wellington were classified as dimensional variances, which according to case law require a lesser degree of proof of hardship. <u>See Hertzberg v. Zoning Bd. of Adjustment</u> <u>of the City of Pittsburgh</u>, 554 Pa. 249, 721 A.2d 43 (1998). Specifically, Wellington argues that Hearing Board should have considered other indicia of hardship, including economic detriments and the characteristics of the surrounding neighborhood. <u>Id.</u>

The Zoning Board argues that although <u>Hertzberg</u> lowered the degree of proof of hardship necessary, the landowner must still prove that a hardship would exist without the variance being granted. Subsequent case law specifically states that <u>Hertzberg</u> did not alter the principle that a substantial burden must still attend to all dimensional variance cases. <u>Yeager v. Zoning Hearing Board of the City of Allentown</u>, 779 A.2d 595 (Pa. Cmwlth., 2001). As such, although there is a lesser degree of proof required for dimensional variances, case law has determined that there is still a standard of hardship that must be established by the landowner for a variance to be granted. Because the Zoning Board decided that Wellington failed to meet even the lower burden for dimensional variances, this Court declines to reverse the Zoning Board's decision. Therefore, the appeal filed by Wellington is **DENIED**.

#### **CONCLUSION**

In summary, this Court finds that the Windsor Township Zoning Hearing Board did not abuse its discretion or commit an error of law. For the reasons laid out above, the appeal filed by Wellington Investment Group, LLC is **DENIED** and the original ruling by the Windsor Township Zoning Hearing Board has been **UPHELD**.
