

OPINION

This case is before the Court on Defendant's Preliminary Objections to Plaintiff's Complaint. For the reasons set forth herein, Defendant's Preliminary Objection of Sovereign Immunity is **OVERRULED**. Plaintiff has conceded Defendant's second Preliminary Objection against the York County Board of Commissioners.

FACTS AND PROCEDURAL HISTORY

Plaintiff was an inmate at the Prison and housed in the work release dorm area on December 17, 2016. Plaintiff alleges that while she lay sleeping in the work release dorm, prison workers "performed maintenance of the property and applied insect control treatments to the floors, walls, and windows of the areas surrounding Plaintiff's sleeping quarters." The actions of the maintenance workers resulted in the release of a swarm of venomous spiders that attacked Plaintiff, biting her and causing bilateral narrow angle glaucoma, diplopia, facial lacerations, abrasions, scarring, and severe shock to the nervous system. Plaintiff alleges that Defendant was negligent in the care, custody, and control of real property at the York County Prison.

On July 20, 2018, Plaintiff filed their Complaint against Defendant. On September 18, 2018, Defendant filed Preliminary Objections and a Brief in Support. On October 12, 2018, Plaintiff filed a Brief in Opposition. This case was listed for One Judge Disposition on March 28, 2019, and assigned to this Court on April 3, 2019.

DISCUSSION

Preliminary Objections may be filed by any party to any pleading on the grounds of legal insufficiency. Pa.R.Civ.P. 1028(2)(4). Preliminary objections in the form of a demurrer tests the legal sufficiency of a pleading. *Ins. Adjustment Bureau, Inc. v. Allstate Ins. Co.*, 860 A.2d 1038, 1041 (Pa. Super. 2004). Preliminary objections, which if sustained, would result in the dismissal of a cause of action should only be sustained where it is "clear and free from doubt." *Bower v. Bower*, 611 A.2d 181, 182 (Pa. 1992). Furthermore, preliminary objections should be granted "only where it appears with certainty that, upon the facts averred, the law will not allow the plaintiff to recover." *Snare v. Ebensburg Power Co.*, 637 A.2d 296 (Pa. Super 1993).

In ruling on preliminary objections, all material facts in the complaint and all references that could be reasonably deduced from, must be accepted as true. *Bilt-Rite Contractors, Inc. v. The Architectural Studio,* 866 A.2d 270, 272 (Pa. 2005). A trial court may sustain a demurrer, and thereby dismiss a claim, only when the law is clear that a plaintiff is not entitled to recovery. *HCB Contractors v. Liberty Place Hotel Associates*, 652 A.2d 1278, 1279 (Pa. 1995). If there is any doubt as to whether the demurer should be sustained, then it should be overruled. *Bruno v. Erie Ins. Co.*, 106 A.3d 48, 56 (Pa. 2014).

The defense of governmental immunity may be raised by Preliminary Objections. *Gallagher v. City of Philadelphia*, 597 A.2d 747 (Pa. Cmwlth. 1991)

Under the Political Subdivision Tort Claims Act, local government agencies are immune from liability for their negligence unless their actions fall within an exception enumerated by statute and would otherwise subject them to liability. *Grieff v. Reisinger*, 693 A.2d 195, 197 (Pa. 1997) (citing 42 Pa.C.S.A. §§ 8541-42). Section 8542(b)(3) of the Tort Immunity Act waives immunity where the local agency was negligent in the "care, custody or control of real property" in its possession. *Snyder v. N. Allegheny Sch. Dist.*, 722 A.2d 239, 245 (Pa. Cmwlth. 1998) (citing 42 Pa.C.S.A. § 8542(b)(3)). To maintain a negligence claim under the real property exception the injured party must prove that the injury resulted from a dangerous condition arising from the care, custody, and control of the real property by a local government agency. *Mellon v. City of Philadelphia Zoo*, 760 A.2d 921, 924 (Pa. Cmwlth. 2000).

The Pennsylvania Supreme Court has provided two models for determining when the real property exception to governmental immunity applies. *Repko v. Chichester Sch. Dist.*, 904 A.2d 1036, 1040 (Pa. Cmwlth. 2006). At the outset, we note that our appellate courts have recognized that determining which approach to use can be challenging. *Id.*

The Blocker v. City of Philadelphia Approach

Under the *Blocker* approach, if the injury is caused by the real property, including a fixture, the real property exception applies; if the injury is caused by personalty, which is not attached to the real estate, the real property exception does not apply. *Blocker v. City of Philadelphia*, 763 A.2d 373, 375 (Pa. 2000). In *Blocker*, the plaintiff was injured when the bleachers on which she was sitting collapsed. She fell backwards to the ground and sustained injuries to her body. Because the bleachers were not affixed to the real estate, the Court held that the cause of the plaintiff's injury was from the personalty, which was not part of the real estate and the negligent maintenance of it, did not fall within the real property exception to immunity.

The Grieff v. Reisinger Approach

Under the *Grieff* approach, it is whether the injury is caused by the negligent care, custody, or control of the real property itself that determines if the exception applies. *Grieff* at 197. A claim under the real property exception to governmental immunity must arise from the property itself, or the care, custody, or control of it. *Wilson v. Norristown Area Sch. Dist.*, 783 A.2d 871, 877 (Pa. Cmwlth. 2001). The real property exception to governmental immunity is unavailable when the claim arises from the negligent maintenance of personalty. *Mandakis v Borough of Matamoras*, 74 A.3d 301, 305 (Pa. Cmwlth. 2013). Cases that follow the *Grieff* model, are clearly related to the maintenance of real property. *Gillingham v. Cnty. Of Delaware*, 154 A.3d 875, 879 (Pa. Cmwlth. 2017).

Defendant argues that the *Blocker* approach should be used and that because the spiders are not fixtures, the real property exception to governmental immunity does not apply. Defendant also argues that it was not the negligent care, custody, or control of real property, but the negligent care of the spiders that caused the injury. Defendant is correct that spiders are not fixtures, but they are obviously not personalty either. The *Blocker* approach has no applicability here.

Spiders and the care and maintenance of the real property are more analogous to the facts set forth in *Grieff*. In *Grieff* the fire chief poured paint thinner onto the floor in an attempt to clean up paint. The paint thinner caught fire and caused damage to the Plaintiff. The fire was not a fixture or the real property. The fire chief was not negligent in his care of the fire. He was negligent in his care, custody, or control of the real property that led to the fire that damaged the plaintiff. Here, the maintenance workers were not there to care for spiders as Defendant argues. They were there for the care and maintenance of the real property. No matter how tenuous Plaintiff's Claim may be, it was Defendant's alleged negligent maintenance of the real property that led to Plaintiff's injuries. This falls within the real property exception to governmental immunity under the *Grieff* method. Plaintiff's Preliminary Objections is **OVERRULED**.

CONCLUSION

Plaintiff's Claim falls within the real property exception to governmental immunity under 42 Pa.C.S.A. § 8542(b)(3). Therefore, Defendant's Preliminary Objection is **OVERRULED**.
