## Philips Brothers Electrical vs. Mid-Atlantic Engine Supply vs. Greenwich Terminals, et al

Preliminary objections – Pa.R.C.P. 2252 – Unjust enrichment – Joinder of additional defendants

- Pursuant to Pa.R.C.P. 2252, any party may join as a third-party defendant any
  person not a party to an action who may be solely liable for the plaintiff's damages, or liable to or with the original defendant on any cause of action arising
  out of the transaction or occurrence or series of transactions or occurrences upon
  which the plaintiff's underlying cause of action against the original defendant is
  based.
- 2. Rule 2252 supports joinder of non-parties in four distinct circumstances. The first circumstance involves joinder based upon the third-party defendant being solely liable to the plaintiff. Joinder in this scenario is permitted where the original defendant alleges that the third-party defendant rather than the original defendant did the acts complained of in the plaintiff's complaint; in other words, a claim the plaintiff could have asserted against the third-party defendant in a direct suit.
- 3. If the statute of limitations would prevent a direct suit by a plaintiff against a third-party defendant, then joinder of the third-party defendant is improper on the ground that he is alone liable to the plaintiff, because, in sole liability claims, the original defendant essentially asserts a cause of action against the third-party defendant on the plaintiff's behalf.
- 4. The second circumstance allowing joinder is when the plaintiff's underlying action against the original defendant sounds in tort, and the original defendant asserts that the third-party defendant is jointly or severally liable with the original defendant to the plaintiff on a claim for contribution.
- 5. Contribution is available whenever two or more persons are jointly or severally liable in tort, irrespective of the theory by which tort liability is imposed.
- 6. Under the third circumstance allowing joinder, an original defendant may join a third-party defendant by asserting that the third-party defendant is liable to the original defendant on a claim for indemnity, to the extent that there is a common law or contractual basis for such a claim.
- 7. The fourth circumstance allowing joinder involves any independent cause of action the original defendant possesses against the third-party defendant, provided that the claim arises out of the plaintiff's underlying action against original defendant. Joinder on this basis constitutes an independent action between the original defendant and third-party defendant.
- 8. Contribution is a cause of action that arises among joint-tortfeasors, whereas indemnity is a cause of action that may arise by contract or by operation of law between one tortfeasor and another vicariously liable tortfeasor.

Philips Brothers Electrical vs. Mid-Atlantic Engine Supply vs. Greenwich
Terminals, et al 37 (2021)]

Plaintiff entered a lease with Defendant to provide Defendant with equipment for a rental fee. Defendant advised Plaintiff the equipment was smoking. Plaintiff determined the equipment was damaged by improper use and took the equipment out of service for four months for repairs and sued Defendant for repair costs, lost rental income, etc. Defendant alleging Additional Defendants operated the equipment and sued them on a variety of claims, including unjust enrichment. As Additional Defendants do not argue Plaintiff was prohibited from asserting claims against them for unjust enrichment, Defendant may attempt to transfer the liability for the cost of repairing the equipment by alleging that Additional Defendants are solely liable for Plaintiff's damages on a theory of unjust enrichment. Accordingly, Additional Defendants' preliminary objections are overruled to the extent that Defendant's unjust enrichment claims are based on Additional Defendants' sole liability to Plaintiff. As to Defendant's unjust enrichment claim which seeks to hold Additional Defendants liable for the equipment repair costs only to the extent Plaintiff successfully holds Defendant liable for the same injury, because those allegations do not set forth facts that would constitute an independent theory of unjust enrichment liability as between Defendant and Additional Defendants, the preliminary objections are sustained in part.

It is further **ORDERED** that Additional Defendants are granted leave to file an Answer to Defendant's Third Amended Joinder Complaint, as construed by this Court, within twenty (20) days of the entry of this Order on the docket.

Additional Defendants Greenwich Terminals, LLC and Holt Logistics, Corp. (collectively "Additional Defendants") raise preliminary objections in the nature of a demurrer to the claims against them for

unjust enrichment asserted in the third amended joinder complaint filed by Defendant Mid-Atlantic Engine Supply Corporation ("Mid-Atlantic"). Upon review, the objections are sustained in part and overruled in part, as more fully explained below.

The relevant facts and procedural history of this case are as follows. On January 3, 2008, Plaintiff Philips Brothers Electrical Contractors, Inc. ("Plaintiff") and Mid-Atlantic entered into a written lease agreement whereby Plaintiff agreed to provide Mid-Atlantic with certain "equipment" in exchange for a rental fee. See, Compl., at  $\P$  6 – 8. On June 7, 2018, while the equipment was in Mid-Atlantic's possession, Mid-Atlantic contacted Plaintiff "to advise that the [e]quipment was 'smoking.'"  $\underline{Id}$ , at  $\P$  9. Plaintiff subsequently determined that the equipment had been damaged as a result of "improper use" and "over speeding."  $\underline{Id}$ , at  $\P$  11 – 12. Ultimately, the equipment was taken "out of service" for nearly four months for repairs.  $\underline{Id}$ , at  $\P$  18.

On January 23, 2019, Plaintiff commenced this action against Mid-Atlantic seeking to recover the costs associated with repairing the equipment, including labor charges, replacement parts, hauling fees, as well as lost rental income. Plaintiff alleged damages in excess of \$175,000. In its complaint, Plaintiff asserted claims against Mid-Atlantic for breach of contract and unjust enrichment.

Mid-Atlantic joined Additional Defendants to this action on January 10, 2020. Following a series of preliminary objections, Mid-Atlantic filed a third-amended joinder complaint on July 24, 2020, alleging that, contrary to the averments of Plaintiff's complaint, it never "took possession of the leased equipment" from Plaintiff, nor was it the "end user" of the equipment. Joinder Compl., at ¶ 5. Rather, Mid-Atlantic arranged for Plaintiff to deliver the equipment directly to Additional Defendants at a marine terminal located in Philadelphia, where it was "installed and operated" by Additional Defendants. Id., at ¶ 13. Based on these allegations, Mid-Atlantic asserted claims against Additional Defendants for negligence, breach of contract, unjust enrichment, and "common law indemnification and contribution." See, Id., pp. 18 – 19. Regarding its breach of contract claims, Mid-Atlantic averred that it leased the equipment to Additional Defendants pursuant to a "verbal contract" that required Additional Defendants to pay rent on a month-to-month basis and to return the equipment to Plaintiff "in substantially the same condition as it was in at the start of the lease term." Id., at ¶¶ 36, 44, 53, 61. Similarly, regarding its unjust enrichment claims, Mid-Atlantic averred that the equipment was "in the possession of" Additional Defendants at the time it was damaged, and that the latter would be "unjustly enriched" if they failed to "provid[e] compensation for the cost of any alleged repairs, replacement and/or loss of equipment service or value." Id., at ¶¶ 72, 75, 82, 85.

Additional Defendants filed preliminary objections in the nature of a demurrer to Mid-Atlantic's unjust enrichment claims on August 10, 2020. Therein, Additional Defendants contend that, pursuant to the allegations of the joinder complaint, the only "benefit" conferred on them by Mid-Atlantic "was the arrangement for the rental/use of the leased equipment[.]" Obj., at ¶ 45. They contend that such allegations do not state a legally cognizable claim for unjust enrichment because Mid-Atlantic failed to aver that it conferred a "direct benefit" on Additional Defendants which was "related to the alleged costs to repair the leased equipment[.]" Id., at ¶ 50. In its response in opposition, Mid-Atlantic generally argues the averments of its joinder complaint adequately state claims against Additional Defendants for unjust enrichment.

#### **Analysis**

Additional Defendants were brought into this action as third-party defendants pursuant to the procedures set forth in Pa. R.C.P. 2250 et seq. While the parties' competing arguments largely ignore this fact, the Court examines the legal sufficiency of Mid-Atlantic's unjust enrichment claims by first considering the bases upon which a defendant may implead a non-party as a third-party defendant.

Pursuant to Pennsylvania Rule of Civil Procedure 2252, "any party" may join as a third-party defendant any person not a party to an action who may be "solely liable" for the plaintiff's damages, or "liable to or with" the original defendant "on any cause of action arising out of the transaction or occurrence or series of transactions or occurrences upon which the [plaintiff's] underlying cause of action against the [original defendant] is based." Pa. R.C.P. 2252(a)(1)-(2). Legal authorities in this Commonwealth have interpreted the language of Rule 2252 as supporting joinder of non-parties in four distinct circumstances. See, e.g., Svetz for Svetz v. Land Tool Co., 513 A.2d 403, 405 (Pa. Super. 1986). First, an original defendant may join a third-party defendant on the basis that the third-party defendant is "solely liable" to the plaintiff. Joinder in this scenario is permitted "where the [original defendant] alleges that the [third-party] defendant rather than the [original defendant] did the acts complained of"

in the plaintiff's complaint. 7 Goodrich Amram 2d § 2252(a):10. For joinder predicated on sole liability to be proper, the claim asserted by the original defendant against the third-party defendant must be a claim the plaintiff *could have* asserted against the third-party defendant in a direct suit. See, e.g., 3 Standard Pennsylvania Practice 2d § 14:224 (Explaining that "[i]f a plaintiff has no cause of action against a person sought to be joined as [a third-party] defendant, that person may not be brought in upon an allegation that the person is solely liable to the plaintiff."); cf., Oviatt v. Automated Entrance Sys. Co., 583 A.2d 1223, 1228 (Pa. Super. 1990) ("If the statute of limitations [would prevent] a direct suit by a plaintiff against [a third-party] defendant, [then] joinder of the [third-party] defendant is improper on the ground that he is alone liable to the plaintiff."). In short, in sole liability claims, the original defendant essentially asserts a cause of action against the third-party defendant on the plaintiff's behalf.

Second, when the plaintiff's underlying action against the original defendant sounds in tort, joinder under Rule 2252 is allowed where the original defendant asserts that the third-party defendant is jointly or severally "liable with" the original defendant to the plaintiff on a claim for contribution. See, e.g., Svetz for Svetz, 513 A.2d at 408 ("Contribution is available whenever two or more persons are jointly or severally liable in tort, irrespective of the theory by which tort liability is imposed."). Third, an original defendant may join a third-party defendant under Rule 2252 by asserting that the third-party defendant is "liable to" the original defendant on a claim for indemnity, to the extent that there is a common law or contractual bases for such a claim. See generally, 3 Standard Pennsylvania Practice 2d § 14:251 ("The duty of indemnification may arise from contract or by operation of law.").

Finally, an original defendant may join a third-party defendant on any independent cause of action the original defendant possesses against the third-party defendant, provided that the claim "arises out of" the plaintiff's underlying action against original defendant. See, e.g., DiLauro v. One Bala Ave. Assocs., 515 A.2d 939, 944 (Pa. Super. 1986) (Explaining that Rule 2252 "permits joinder where the party to be joined may be liable to the [original defendant] separately on an independent cause of action which arose out of the same transaction(s) or occurrence(s) as the plaintiff's original cause of action.") (cleaned up). Significantly, unlike joinder predicated upon claims for sole liability, contribution, or indemnity—each of which attempt to transfer some or all of the liability for the plaintiff's injury from the original defendant to the third-party defendant—joinder on this basis constitutes an independent action between the original defendant and third-party defendant.

Having surveyed the different bases for joinder under Rule 2252, the Court returns to Mid-Atlantic claims against Additional Defendants for unjust enrichment. As an initial matter, joinder predicated on a claim for either contribution or indemnity is irrelevant for purposes of examining Additional Defendants' preliminary objections, as each of those claims are distinct causes of action. See generally, Lampkin v. Gappa, 2012 WL 947164, at \*4 (E.D. Pa. Mar. 21, 2012) ("[C]ontribution is a cause of action that arises among joint-tortfeasors[, whereas] [i]ndemnity is a cause of action that may arise by [contract or by] operation of law between one tortfeasor and another vicariously liable tortfeasor[.]"). Accordingly, to the extent Mid-Atlantic's unjust enrichment claims are legally sufficient under Rule 2252, they must be predicated on either Additional Defendants' "sole liability" to Plaintiff or as standalone claims asserted by Mid-Atlantic against Additional Defendants. See discussion, supra.

Here, Plaintiff filed a complaint to recover the costs associated with repairing the equipment Plaintiff alleges it leased to Mid-Atlantic. In Mid-Atlantic's third-amended joinder complaint, it asserts that Additional Defendants are responsible to pay for the "cost of any alleged repairs, replacement and/ or loss of equipment service or value" because Additional Defendants, inter alia, possessed and used the equipment at the time it was damaged. Joinder Compl., at ¶¶ 75, 85. As explained above, when joinder is predicated on sole liability to the plaintiff, the claims the original defendant asserts against the third-party defendant are claims the plaintiff could have brought against the third-party defendant in a direct suit. Accord, Pa. R.C.P. 2255(d) (Providing that the plaintiff "shall recover from [a third-party] defendant found liable to the plaintiff alone ... as though such [third-party] defendant had been joined as a [original] defendant and duly served[,] and the initial pleading of the plaintiff had averred such liability."). In this case, Additional Defendants do not argue or otherwise suggest that Plaintiff was prohibited from asserting claims against them for unjust enrichment directly in either an original action or as part of its underlying complaint. Therefore, the fact that the claims were interposed by Mid-Atlantic in a joinder complaint rather than by Plaintiff directly is inconsequential for purposes of their legal sufficiency. Under Rule 2252, Mid-Atlantic may attempt to transfer the liability for the cost of repairing the equipment by alleging that Additional Defendants are "solely liable" for Plaintiff's damages on a theory of unjust enrichment. See, Joinder Comp., at Addendum Clauses, pp. 16 - 17 (Alleging that Additional Defendants are "solely ... liable to Plaintiff ..."). Accordingly, Additional Defendants' pre-

liminary objections are **overruled** to the extent that Mid-Atlantic's unjust enrichment claims are based on Additional Defendants' sole liability to Plaintiff.

Mid-Atlantic's claims are, however, legally insufficient to the extent it predicates joinder of Additional Defendants on an independent theory of unjust enrichment. As described above, Rule 2252 permits an original defendant to implead a third-party defendant on any cause of action the original defendant possesses against the third-party defendant, subject to the limitation that the original defendant's claim arises out of the plaintiff's underlying cause of action. Significantly, in such a case, the third-party defendant's alleged liability runs directly to the original defendant, regardless of whether the original defendant is found liable to the plaintiff. See, e.g., Pa. R.C.P. 2252, Ex. Cmt. 1990 (Explaining that joinder may be based on a third-party defendant's "liability to the defendant on a cause of action arising out of the transaction or occurrence upon which plaintiff's action is based.") (emphasis added). Here, Mid-Atlantic does not aver facts to indicate that Additional Defendants are liable to it for unjust enrichment regardless of Mid-Atlantic's liability to Plaintiff. Instead, it avers that "[i]f the allegations of Plaintiff's [c]omplaint are true," then Additional Defendants are "liable to Mid-Atlantic" for unjust enrichment and must compensate it "in full" for the cost incurred by Plaintiff to repair the equipment. See, <u>Joinder Compl.</u>, at  $\P 75 - 77$ ; 85 - 87. In other words, Mid-Atlantic's unjust enrichment claims seek to hold Additional Defendants liable for the equipment repair costs only to the extent Plaintiff successfully holds Mid-Atlantic liable for the same injury. Conversely, if Plaintiff's action against Mid-Atlantic is unsuccessful, then there is no scenario in which Additional Defendants would be liable to Mid-Atlantic for the cost to repair the equipment.

In sum, the allegations of the third amended joinder complaint do not set forth facts that would constitute an independent theory of unjust enrichment liability as between Mid-Atlantic and Additional Defendants. Accordingly, Additional Defendants' preliminary objections are **sustained** to the extent Mid-Atlantic seeks to hold Additional Defendants directly liable to it on a theory of unjust enrichment.

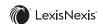
