#### **DISCUSSION AND ADDITIONAL FINDINGS OF FACT**

#### Wrongful Termination

WCASD did not have cause to terminate ERS for the reasons stated in its Termination Letter.

According to WCASD, the most significant failure of ERS was the delayed development of the Contractors' Construction Schedule. WCASD blamed ERS for not developing a schedule until December, 2018 and asserts this failure as a "for cause" reason for termination. The Court finds that ERS was not responsible for the timing of the submission of the Contractors' Construction Schedule and this was not a valid reason for termination.

ERS's ability to prepare the Contractors' Construction Schedule was dependent upon all other prime contractors adhering to their respective contractual obligations, which included providing scheduling information to ERS. The Contract acknowledged this dependence in the provisions which outline the process and procedure for creating the baseline schedule and provide the ability to withhold payment for work until the schedule was competed. Ultimately, the electrical contractor, not ERS, prevented the Contractors' Construction Schedule from being submitted on time due to its failure to provide the required information as contracted. Aware of the delay, WCASD had the obligation to invoke its contractual powers to compel the electrical contractor to honor its obligations. WCASD did not so and it cannot now justify terminating ERS's Contract for any schedule delay.

WCASD acknowledged that the electrical prime contractor was the biggest obstacle to preparing the schedule. Yet, WCASD refused to intervene when ERS asked for assistance. WCASD was the only Project participant with the contractual authority to compel the other prime contractors to cooperate in developing the schedule.

WCASD also claimed in its Termination Letter that ERS's schedule updates contained errors. The evidence showed, however, that the updates were based on the information provided by the other prime contractors. If the prime contractors provided erroneous information, then the update would surely include erroneous information.

ERS demonstrated at trial that Phase 1A Substantial Completion having been reached on August 26, 2018 rather than August 15, 2018, was not the fault of ERS. It was instead a byproduct of the failures of several other prime contractors to timely complete their scope of work. By way of example, and as noted *supra*, containment for the shotblasting was not removed until July 11, 2018, just over one month before the scheduled Phase 1A Substantial Completion date. The plumbing contractor, therefore, could not move forward until abatement had been completed. Only then, could the plumbing contractor begin demolishing concrete floors in the corridor and the bathrooms and removing existing pipes to make way for extensive under slab sanitary waste piping. This piping was to service separate boys and girls

group bathrooms, two single bathrooms in the lobby, a bathroom in the health suite, a bathroom in the principal's office and several sinks in the health suite and exam room. ERS's work, which was conditioned upon completion of work by other prime contractors, necessarily was delayed.

ERS likewise proved at trial that it was not responsible for the delays to the Phase 1B Substantial Completion milestone as of the date of its termination. The evidence at trial demonstrated that the Architect's failure to coordinate its design documents resulted in Contract Documents that included several errors. These errors hampered the construction and its completion through no fault of ERS. Errors came to light regarding the steel beams in the Gym Lobby, the elevator, an unspecified card reader, the pour stops, the relocation of RTU-1 due to lead paint on the beams, and undocumented site conditions and undocumented underground utilities, just to name a few.

In addition, the was no credible evidence to suggest that ERS failed to provide appropriate supervision over the Project, to provide a sufficient number of skilled workers or to offer additional work hours and days. ERS was keenly aware that time was of the essence and it performed its work accordingly.

Finally, the evidence did not support WCASD's contention that ERS did not perform its work in accordance with its Contract. Although WCASD cited concrete that did not meet the Contract required 28-day compressive strength requirements as defective work that justified termination, ERS did not place the defective concrete. Rather, the plumbing contractor placed the defective concrete, yet was not terminated. With respect to floor flatness and levelness results, which were also given as reasons for termination, the evidence at trial was clear that WCASD never requested that the concrete pours be removed and replaced. It also failed to give ERS the opportunity to perform any corrective measures as provided for in the Contract. WCASD, however, later accepted the floors after corrective measures were performed. Moreover, ERS never refused to perform work or to correct non-conforming work when brought to its attention. To the contrary, WCASD's Termination Letter acknowledges that ERS began correcting the Phase 1A punch list items within a week or two after receipt of the same and the October 24, 2018 meeting minutes confirmed this fact.

#### Damages

As a result of WCASD's breach of the Contract, ERS suffered economic damages. The damages for which ERS seeks recovery are delineated in Exhibit P-386. The court agrees that ERS is entitled to some, but not all, of the damages set forth therein.

#### Direct Damages

Generally, damages for breach of contract include the amount of money that will put the non-breaching party in the position it would have been in if the breach had not occurred. This includes not only damages that directly result from the breach, but also those damages that were foreseeable at the time the parties entered into their contract, also referred to as consequential damages. ERS seeks to recover both direct and consequential damages in this action.

The direct damages resulting from WCASD's breach to which ERS is entitled are the following:

Work invoiced but not paid	\$665,700.59
Retainage	\$353,594.94

#### **Consequential Damages**

As for consequential damages, ERS seeks to recover, lost profits, personnel costs, payments to sureties and control costs. ERS is entitled only to its lost profits pursuant to the Contract's terms.

Under Pennsylvania law, a contract does not necessarily have to identify consequential damages for such damages to be recoverable. *See, e.g., Condo. Ass'n Court of Old Swedes v. Stein–O'Brien*, 973 A.2d 475, 483 (Pa. Cmwlth. 2009) (stating, "[w]here the consequential damages are 'foreseeable' and were contemplated by 'the parties at the time they made the contract,' they will be awarded in order to put the victim of the contract breach in the same position as if there had been performance, not breach.")(persuasive authority). Pennsylvania law recognizes, however, that in a commercial setting a contractual provision excluding liability for special, indirect, and consequential damages is generally valid and enforceable. *Carll v. Terminix Int'l Co., L.P.,* 793 A.2d 921, 924 (Pa. Super. 2002)(citing *New York State Elec. & Gas Corp. v. Westinghouse Elec. Corp.,* 564 A.2d 919 (Pa. Super. 1989)). Courts, when analyzing such a provision, must look to the parties involved to ensure that there is no disparity between the entities in either bargaining power or sophistication. *Moscatiello v. Pittsburgh Contractors Equip. Co.,* 595 A.2d 1190 (Pa. Super. 1991).

This Contract contains a limitation clause for consequential damages. There is no question in this case that the parties are sophisticated business entities that are familiar with, and well versed in, the bidding and contractual process involved in such projects. There was no evidence offered at trial to suggest that the limitations clause in the Contract is anything other than valid and enforceable. What has been challenged by ERS, however, in seeking damages in the form of lost profits, personnel costs, payments to sureties and control costs, is the application of this clause to the claims asserted. It is that question to which the court turns next in its analysis.

Section 15.1.6 of the Contract - "Claims for Consequential Damages" - provides as follows:

The Contractor waives Claims against the Owner for consequential damages arising out of or relating to this Contract, including but not limited to, damages incurred by the Contractor for principal office expenses including the compensation of the personnel stationed there, for losses of financing, rental expenses, loss of use, business and reputation, and for a loss of profit, except for anticipated profit arising directly from the work.

"Claims" are defined in Section 15.1.1 as:

A Claim is a demand or assertion by one of the parties seeking, as a matter of right, payment of money, or other relief with respect to the terms of the Contract. The term "Claim" also includes other disputes and matters in question between the Owner and Contractor arising out of or relating to the contract. The responsibility to substantiate Claims shall rest with the party making the Claim. (emphasis added)

According to ERS, Section 15.1.6 applies only to claims made during the Contract, not to claims made post-termination. The court finds no merit in this argument. This contractual language is broad and all- encompassing in its application. The limitation applies to disputes "arising out of or related to the Contract". There can be no question that this dispute falls within this broadly drafted limitation clause. The cited contractual language makes it clear that ERS's request for consequential damages, with the exception of lost profits, is impermissible under the Contract.

WCASD acknowledges that lost profits are a recoverable form of damage under the Contract, but argues that ERS's lost profits figure is speculative and thus not recoverable. The court concludes otherwise.

Damages are considered remote or speculative only if there is uncertainty concerning the identification of the existence of damages rather than the ability to precisely calculate the amount or value of damages. There was sufficient evidence presented at trial which identified the existence of lost profits on the part of ERS.

ERS presented Douglas George as a witness to address ERS' damages. The court found him to be a credible witness on this issue. Mr. George currently serves as the President and Chief Executive Officer of ERS. He has been employed with ERS for twenty (20) years. A civil engineer, George testified that he has been involved with over 200 construction projects. He testified he was familiar with the Project and on numerous other occasions has calculated ERS's anticipated profits for a given contract. During his testimony, George presented a spreadsheet which he used to explain the underlying data from which the lost profit figure was calculated and the method of calculation. The court found his conclusions reasonable and his calculations to be reliable and far from speculative. The court will award ERS its lost profits in the amount of \$331,259.68.

The Prompt Payment Act

The Procurement Code provides prompt payment rules for government projects. *Clipper Pipe & Services, Inc. v. Ohio Cas. Ins. Co.*, 631 Pa. 682, 115 A. 3d 1278, 1283 – 84 (2015). The "Prompt Payment Act" ("PPA"), which is contained within the Commonwealth Procurement Code at 62 Pa.C.S.A.§3901 *et seq*, governs construction projects between a government agency and a contractor, where the contract involves competitive sealed bidding or competitive sealed proposals. *See* 62 Pa.C.S.A.§ 3901(a); F. *Zacherl, Inc. v. Flaherty Mech. Contractors, LLC*, 131 A. 3d 1030, 1044 (Pa. Cmwlth. 2016). Absent a good faith claim, the PPA mandates payment to a contractor when the contractor performs "in accordance with the provisions of the contract." 62 Pa.C.S.A. §3931(a) and 62 Pa.C.S.A. §3932(a). Furthermore, the PPA provides for an award of interest on payments not timely made. *See* 62 Pa.C.S.A. §1932(c). The formula for calculating this interest is set forth at 62 Pa.C.S.A. §1931(c).

The PPA provides for the right to seek penalties in the amount of 1% per month, costs, and a "reasonable attorney fee" for violations. *See* 62 Pa.C.S.A. §3935. An award of a penalty or attorneys' fees is discretionary, not mandatory. In determining whether a penalty or reasonable attorneys' fees should be awarded, a court must inquire into whether monies were withheld in bad faith, that is the withholding was arbitrary or vexatious. *See* 62 Pa.C.S.A. §3935(a); *Cummins v. Atlas R.R. Constr. Co.*, 814 A. 2d 742, 747 (Pa. Super. 2002). The terms "arbitrary" and "vexatious" are undefined in the PPA and should be considered by their "popular and plain everyday sense." Id. A trial court has "great latitude and discretion" in deciding whether to award penalties and attorney's fees under §3935. *Id.* 

Plaintiff met its burden of proof and established that WCASD violated the PPA. Its conduct was in bad faith, and as supported by the record evidence, can be considered nothing short of arbitrary and vexatious. ERS is entitled to penalties in the form of interest and reasonable attorneys' fees.

The evidence at trial overwhelmingly demonstrated that WCASD treated ERS differently, unfairly, and held it to standards not applied to other prime contractors. WCASD interpreted and enforced the Contract's terms one way when interacting with ERS and another, if at all, when interacting with the other prime contractors. WCASD ignored that the other prime contractors completed work after the Substantial Completion milestone date for Phase 1A. WCASD failed to terminate the other prime contractors for punch list work. WCASD did not require the asbestos abatement prime contractor to work more than four (4) days per week, even though its work was delaying the Project. WCASD did not terminate the plumbing prime contractor because it was his concrete, and not ERS's concrete, that had a low break value. WCASD did not withhold numerous payment applications or assess liquidated damage against the other prime contractors, as it did with ERS. WCASD took no adverse action against any of them.

Furthermore, WCASD's Project representative Kevin Campbell testified at trial

that the performance dates for Phase 1A constituted "deadlines." This testimony directly contradicted his deposition testimony wherein he testified that they were not; rather they were "milestones." Missing a "milestone" would not be a reason to terminate.

Another example may serve as an illustration: on June 6, 2018, there was a Construction Meeting to discuss the project and answer any questions. ERS learned that the day before, on June 5, 2018, WCASD issued a change order to the asbestos abatement contractor to change the method of asbestos abatement from chemical removal process to shotblasting removal process. Ms. Cunningham, WCASD's expert, opined that ERS "knew about this change prior to starting work and developing the Project Schedule [it sic], therefore was provided with this change in sufficient time to allow for it and the Project Schedule." (D-57, Expert Report of JBC Associates, Inc., p. 13). For WCASD, a day was sufficient notice; not so for the court.

In the midst of the Project's difficulties, Campbell came up with a five (5) page list of change items to send to ERS. In communicating the new items to the Architect, Groves told the Architect "I'm going to make them (ERS) work for everything." (Ex. P-201). Asked in court whether imposing these additional activities was retaliatory on the part of WCASD, Groves answered "Yes", it was in retaliation for ERS not producing an approved and signed schedule. This candor took the court's breath away. Groves knew very well that ERS had no contractual privity with the other primes, and no remedy to compel their compliance. Only WCASD did. Groves was asking the impossible, while continuing to plow ahead towards termination. He told ERS's representatives to get a lawyer.

Referring to the Termination Letter (Ex. R-316), Campbell agreed that he must know the facts supporting termination because it is such a "drastic remedy." He, however, admitted he did not know the facts as to why there was a delay in completing the items set out on page 3 of the Termination Letter.

After termination, Campbell decided to meet with ERS and Hartford, the bonding company, so that in court he could "say we have." (Ex. P-333). He expected no change in WCASD's position. His callous conclusion for the delays was simply "[ERS] must be hurting for pay." (Email Campbell to Groves, 10/11/18, P-182).

All of this conduct was punitive. There is no, and can be no, contractual support for it. WCASD wanted to go to court. Wish granted.

## CONCLUSIONS OF LAW

- 1. WCASD terminated ERS from the Project without cause.
- 2. WCASD's wrongful termination constituted a breach of the Contract.

3. WCASD's breach caused ERS to suffer damages, both direct and consequential.

4. ERS is entitled to direct damages in the amount of \$1,019,295.53.

5. The parties' contractual limitation on consequential damages is valid and

enforceable.

6. ERS is only entitled to consequential damages for lost profits.

- 7. ERS's lost profits calculation was reliable and not speculative.
- 8. ERS is entitled to lost profits in the amount of \$331,259.68.
- 9. WCASD violated the PPA.

10. Pursuant to the PPA, ERS is entitled to interest on unpaid invoices in the amount of \$84,380.37, through October 11, 2021, and thereafter until paid.

11. Pursuant to the PPA, ERS is entitled to interest on the withheld retainage in the amount of \$42,231.68, through October 11, 2021, and thereafter until paid.

12. WCASD acted in bad faith in terminating ERS without cause and in withholding payments for work rendered.

13. Pursuant to the PPA, ERS is entitled to penalties in the amount of 1% per month of the withheld amounts.

14. ERS is entitled to penalties for unpaid invoices though October 11, 2021 totaling \$217,283.54 and thereafter until paid.

15. Pursuant to the PPA, ERS is entitled to penalties on the withheld retainage in the amount of \$109,614.43, through October 11, 2021, and thereafter until paid.

16. Pursuant to the PPA, ERS is entitled to reasonable attorneys' fees, to be determined by the court.

An appropriate Order follows.

## Public Notice Appointment of New Magistrate Judge in the United States District Court for the Eastern District of Pennsylvania

The Judicial Conference of the United States has authorized the appointment of a full-time United States magistrate judge for the Eastern District of Pennsylvania at Reading or Philadelphia. The appointee may be required to preside at court sessions to be held at Reading, Philadelphia, Allentown, and Easton. The essential function of courts is to dispense justice. An important component of this function is the creation and maintenance of diversity in the court system. A community's belief that a court dispenses justice is heightened when the court reflects the community's diversity.

The duties of the position are demanding and wide-ranging, and will include, among others: (1) conduct of most preliminary proceedings in criminal cases; (2) trial and disposition of misdemeanor cases; (3) conduct of various pretrial matters and evidentiary proceedings on delegation from a district judge; and (4) trial and disposition of civil cases upon consent of the litigants. The basic authority of a United States magistrate judge is specified in 28 U.S.C. § 636.
