#### OPINION AND ORDER

LESKINEN, J. September 11, 2020

Before the Court is the Defendant's Omnibus Pretrial Motion in the nature of a Motion to Suppress. After careful review of the evidence and applicable law, the Court hereby denies the Motion.

#### STATEMENT OF FACTS

At the Preliminary Hearing, the Commonwealth submitted evidence of the following: At 2:22 am on January 4th, 2020, Pennsylvania State Police Troopers Wiskeman and Vittone conducted a traffic stop on a vehicle, during which the vehicle's operator informed them that he had just come from the Defendant's motel room at the Blue Mountain Motel where the Defendant was selling drugs and where he had been trying to help his friend buy drugs from the Defendant. During the traffic stop, the vehicle's operator received a phone call from the Defendant on his cell phone. The vehicle's operator placed his cell phone on speaker phone and Trooper Wiskeman heard the Defendant say that he was in his motel room selling crack cocaine to another individual and that he was about to leave his motel room with that individual as a passenger in her car. Troopers Wiskeman and Vittone got back in their patrol unit and began driving to the Blue Mountain Motel. On the way, they observed the Defendant riding in the passenger seat of a vehicle coming from the direction of the Blue Mountain Motel and stopped the vehicle. Following the stop, the Defendant consented to a search of his motel room. The Defendant properly completed and signed a Waiver of Rights and Consent to Search Form. The motel room contained crack cocaine, scales, and smoking devices. The Defendant was charged with Manufacture, Delivery, or Possession With Intent to Manufacture or Deliver {1}, Int Poss Contr Subst By Per Not Reg {2}, and Use/Poss Of Drug Paraph {3}.

#### CONCLUSIONS AT LAW

The Defendant argues in his Motion to Suppress that there existed no reasonable suspicion to stop the vehicle in which the Defendant was riding, that any consent given by the Defendant to search his motel room is "fruit of the poisonous tree," and that the Defendant was never read his Miranda Warnings.

#### Reasonable Suspicion

The Fourth Amendment of the U.S. Constitution and Article I, Section 8 of the Pennsylvania State Constitution protect individuals from unreasonable searches and seizures. Commonwealth v. McAdoo, 46 A.3d 781, 784 (Pa. Super. 2012). The police can stop and briefly detain an individual for investigative purposes if they have a reasonable suspicion supported by articulable facts that criminal activity "may be afoot." Com. v. Fell, 901 A.2d 542, 545 (Pa.Super.2006) (citing Terry v. Ohio, 392 U.S. 1, 30 (1968)). This assessment requires an evaluation of the totality of the circumstances. Com. v. Zhahir, 751 A.2d 1153, 1156 (Pa.2000). Among the factors to be considered in establishing a basis for reasonable suspicion are tips, the reliability of the informants, time, location, and suspicious activity. Com. v. Freeman, 757 A.2d 903, 908 (Pa.2000). The credibility of an informant may be established where the informant is personally involved in an illegal transaction so as to outweigh a lack of previous tips. Com. v. Neidig, 489 A.2d 921 (Pa.1985).

In this Case, Troopers Wiskeman and Vittone spotted the Defendant moments after having been informed by the operator of the vehicle involved in their previous traffic stop that he had just come from the Defendant's motel room where the Defendant was selling drugs and where he had been trying to help his friend buy drugs from the Defendant. The operator of the vehicle had never acted as an informant before, but his admission to being personally involved in an illegal transaction supports his reliability.

The vehicle's operator received a cell phone call from the Defendant, placed his cell phone on speaker phone, and allowed Trooper Wiskeman to listen. Trooper Wiskeman heard the Defendant say that he was in his motel room selling crack cocaine to another individual and that he was about to leave his motel room with that individual as a passenger in her car. The Pennsylvania Supreme Court has recently made it clear that circumstances such as these are no grounds for suppression. In Com. v. Spence, a first-time informant, (who had been picked up during a traffic stop) used his cell phone to set up a controlled buy wherein he placed his cell phone on speaker phone and allowed a State Trooper to listen. Com. v. Spence, 91 A.3d 44 (Pa.2014).

The time and location of the stop in this case also suggest that reasonable suspicion was present. The Defendant was spotted only minutes after the information was received, and in the vicinity of the Blue Mountain Motel. In Com. v. Jones, the Pennsylvania Supreme Court ruled that a tip from an informant who had personally been in a drug dealer's apartment and had seen him sell drugs was not stale, even after twenty four hours. Com. v. Jones, 668 A.2d 114, 116 (Pa.1995). In Com. v. Ogborne, the Pennsylvania Superior Court found that an informant's tip in the early evening that a drug dealer was in the possession of drugs was enough to establish reasonable suspicion to stop the drug dealer's vehicle when it was spotted at 11:20 pm. Com. v. Ogborne, 599

A.2d 656, 658 (Pa.Super.1991).

This Court finds that the totality of the circumstances in this case indicate that when Troopers Wiskeman and Vittone stopped the vehicle in which the Defendant was riding, they had reasonable suspicion supported by articulable facts that criminal activity was afoot.

#### Voluntariness of Consent

The voluntariness of a consent is determined by evaluating the totality of the circumstances. Com. v. Merbah, 411 A.2d 244, 247 (Pa.Super.1979). Consent is not voluntary if it is procured through force or coercion. Com. v. Hartford, 459 A.2d 815 (Pa.Super.1983).

The Defendant consented to a search of his motel room by properly completing and signing the Waiver of Rights and Consent to Search Form. The MVR shows that the Defendant talked to Troopers Wiskeman and Vittone for approximately twenty seven minutes before signing the Waiver of Rights and Consent to Search Form. The conversation took place outdoors between 2:56 am and 3.23 am. However, the MVR also shows that Troopers Wiskeman and Vittone treated the Defendant with courtesy, did not use force, and made it clear to the Defendant that not consenting to a search was an option. This Court finds that the totality of the circumstances indicate that the Defendant consented to the search of his motel room voluntarily.

#### Miranda

A defendant's inculpatory statement cannot be used unless the defendant knowingly, intelligently, and voluntarily waived the right to remain silent and be represented by counsel. Miranda v. Arizona, 384 U.S. 436 (1966). Although the Defendant raises Miranda in his Motion to Suppress, the Defendant made no inculpatory statements giving rise to these charges. This Court finds, therefore, that the Defendant's right to remain silent and be represented by counsel were not implicated in this case.

WHEREFORE, the Court issues the following Order:

#### **ORDER**

AND NOW, this 11th day of September, 2020, upon consideration of the Defendant's Omnibus Pretrial Motion in the nature of a Motion to Suppress, it is hereby ORDERED and DIRECTED that it is DENIED. The District Attorney's Office is hereby ORDERED to list this matter for trial.
