COMMONWEALTH VS. MUSE

- 1. It has long been the law in this Commonwealth that pat-downs or frisks are justified only for weapons. Intrusion into a pocket must be supported by reasonable fear that a weapon is present.
- 2. In a suppression proceeding, the Commonwealth bears the burden of establishing by a preponderance of the evidence the admissibility of those items the accused seeks to suppress.
 - 3. Either an arrest or custodial detention must be supported by probable cause.
- 4. A person may be arrested without a warrant based on probable cause for disorderly conduct when there is ongoing conduct that imperils the personal security of any person or endangers public or private property.
- 5. Suspicion is not a substitute for probable cause as grounds for an arrest or search and seizure. Police have probable cause where the facts and circumstances within the officer's knowledge are sufficient to warrant a person of reasonable caution and belief that an offense has been committed. The determination of whether there is probable cause is based on the totality of the circumstance.
- 6. A defendant has no standing to contest the search and seizure of items he has voluntarily abandoned. The theory of abandonment adopted by Pennsylvania applies so long as improper police conduct did not induce defendant's abandonment of his personal property.
- 7. Abandonment is predicated on intent, which is determined from words, acts, and all relevant circumstances existing at the time the property is purportedly deserted. The issue is not abandonment in the strict property-right sense, but whether the person prejudiced by the search had voluntarily discarded, left behind, or otherwise relinquished his interest in the property in question so that he could no longer retain a reasonable expectation of privacy with regard to it at the time of the search.
- 8. It is settled that a petition for writ of habeas corpus is the proper means for testing a pre-trial finding that the Commonwealth has sufficient evidence to establish a *prima facie* case.
- 9. A *prima facie* case consists of evidence, read in the light most favorable to the Commonwealth, that sufficiently establishes both the commission of a crime and that the accused is probably the perpetrator of that crime.
- 10. Inferences reasonably drawn from the record that would support a guilty verdict are to be given effect but suspicion and mere conjecture are not.
- 11. If the Commonwealth is unable to prove Defendant's actual possession of the drugs, it must prove constructive possession or joint constructive possession.
- 12. Evidence that defendant was one of a group of persons on the scene where contraband is found is sufficient to support the inference of constructive possession. The evidence must establish that defendant had conscious dominion over the contraband. To prove conscious dominion, the Commonwealth must present evidence to show that the defendant had both the power to control the contraband and intent to exercise control over it.

ADJUDICATION OF DEFENDANT'S OMNIBUS PRE-TRIAL MOTIONS

Defendant's Omnibus Pre-Trial Motions, which were filed June 20, 2009, and amended July 13, 2009, include motions to suppress and for a writ of habeas corpus. Defendant requests that a) the Court suppress evidence seized by the police, and b) dismiss all charges filed against him. The undersigned Senior Judge conducted an evidentiary hearing on July 24, 2009.

At the hearing, Commonwealth offered the testimony of two members of the Littlestown Borough Police Department, Clemet R. Smith and Douglas Hilyard. Defendant presented no evidence. At the conclusion of the hearing, both parties requested that the Court delay making findings of fact until written briefs were filed.

FACTUAL BACKGROUND IN NARRATIVE FORM

At approximately 11:40 p.m. on May 1, 2009, Officer Smith was on routine patrol in full uniform and in a marked police cruiser. He was traveling westbound on East King Street in Littlestown Borough, Adams County. Officer Smith heard what he described as loud and profane lyrics² coming from a vehicle parked at a fuel pump at a Sheetz convenience store. The officer drove his police vehicle into the Sheetz parking lot and pulled up beside Defendant's car,

^{&#}x27;Officer Smith was a part-time police officer with the Littlestown Borough Police Department at the time of the hearing, a position he has held for four years. Total police experience was 15 years and included West York Borough and Gettysburg Borough Police Departments. Officer Hilyard is a member of the Adams County Drug Task Force. He has been a police officer for six years and a member of the Drug Task Force for four. As a member of the Drug Task Force, Officer Hilyard has experience in identifying controlled substances and their packaging. He has dealt with pills and prescription narcotics.

²The officer apparently was referring to rap music played on a car stereo. He stated that it was lyrical in nature, but not music. Later, on cross-examination, he acquiesced to it being called music. He said a black female was uttering profane threats toward a black male. After asking what was wrong with the music, Defendant also asked, "don't children listen to that kind of music?" The officer responded, "absolutely not." Many people may find rap music unmusical and determine that it is especially inappropriate in a public place at that hour in Littlestown.

described as a white sedan.³ The officer stated that the rear passenger door was open and a pair of legs was protruding from within. He also said that a young white female was asleep in the front passenger seat⁴ and apparently owned the legs in question. The officer alighted from his vehicle to check on the passenger and noticed an African-American male, later identified as the Defendant, on the floor in the back of the vehicle working on something later determined to be the car's stereo system.

Officer Smith, intending to issue a citation for disorderly conduct, requested identification from Defendant. Defendant moved to the driver's seat in an effort to comply. He was unable to locate any form of identification and advised the officer that his identification might be in the trunk. Defendant exited the vehicle and proceeded to the trunk.

When Defendant got out of the car, Officer Smith noticed that a large prescription drug bottle fell out of the vehicle onto the parking lot and rolled to the back of the car. The officer said, "hey, you dropped your bottle. Hey, is that yours." Defendant continued to the rear of the vehicle without replying. Officer Smith picked up the bottle and gave it to Officer Hilyard, who had arrived at the scene.

Officer Hilyard testified that when he asked Defendant about the pill bottle, Defendant replied, "[w]hat bottle, man?" Looking at the label on the bottle, Officer Hilyard determined it belonged to a female. Before speaking to Defendant, the policeman opened the bottle and discovered pills of varying sizes, shapes, and colors. Believing that the pills inside the bottle were inconsistent with the labeling, Officer Hilyard advised Defendant that this was a violation of the drug act. Defendant told him that the pills belonged to a friend and said he would call her. Subsequently arrested, he did not contact the person.

Officer Hilyard said that he detained Defendant by handcuffing him (Officer Smith said Defendant was handcuffed to the rear of the police car), searching him, and placing him into the rear of his police cruiser. However, the officer informed Defendant that he was not under arrest. Although the officer testified that he "detained"

³ The Commonwealth's brief identifies the vehicle as a gold Acura, however, Officer Smith testified that the vehicle was a white sedan. This distinction is irrelevant to the determination of this Motion.

⁴The witness never explained how the young woman managed to have her legs and feet protrude from the rear door while she was in the front passenger's seat.

Defendant in order to determine what was in the pill bottle and Defendant's identity, he had in fact already looked in the bottle before handcuffing Defendant and testified that he had no reason at that point to believe that Defendant was armed and dangerous.

Other than an indication that pills of different sizes and descriptions were in the container and that a woman's name appeared thereon, no testimony was given about the pills or the label.

Citing concerns for officer safety and following standard procedure, Officer Hilyard patted down Defendant prior to placing him in the police cruiser. *Miranda* warnings were not administered. Officer Hilyard felt a large bulge in Defendant's front left pocket that was consistent with a large amount of cash. Officer Hilyard testified that the bulge did not feel like a weapon or contraband but seized \$1,970 in cash from the pocket. He said he took it for safekeeping. Defendant explained that he had just been paid for selling crabs and the officer testified that he believed the explanation.

Once he placed Defendant in his police cruiser, Officer Hilyard told Defendant that he was "going to take a look in the car there, do you mind?" Defendant responded that he had no problem with that. Asked if there were any other controlled substances in the vehicle, Defendant replied that there was not.⁵ The officer did not inform Defendant of his right to refuse to give his consent.

As Officer Hilyard commenced a search of the vehicle, Officer Smith woke the sleeping female to inform her of what was occurring. Officer Smith concluded that the purse was in her possession because it was between her legs but asked her if the purse was hers. The female, identified as Heather Jarockicave, responded in the affirmative. Officer Smith asked if she minded if he took a look inside the purse and she said *no*. His search of the purse turned up two baggies containing a white, chalky, and chunky substance. Based on their experience, both officers believed the substance to be crack cocaine. The only thing the car search yielded was a large amount of clothing and personal items. Neither officer discovered any other contraband in the vehicle.

⁵Neither Defendant nor the female passenger were *Mirandized* before questioning ensued and searches were conducted. Although Officer Smith testified the passenger understood that she had the right to withhold her consent to a search, the record does not support a finding that he informed her of this right. Testimony about her understanding the request for consensual search and her right to refuse was elicited by two leading questions, both answered with *yes* and neither objected to.

After the powder was found in Ms. Jarockicave's purse, Defendant was advised that he was under arrest for possession of crack cocaine and a misbranded bottle.

On June 3, 2009, a Criminal Information was filed against Defendant charging him with one count of Possession With Intent To Deliver A Controlled Substance (Cocaine) in violation of 35 P.S. § 780-113(a)(30);⁶ one count of Criminal Conspiracy in violation of 18 Pa.C.S. § 903(a)(1);⁷ one count of Possession Of A Controlled Substance in violation of 35 P.S. § 780-113(a)(16);⁸ and one count of Possession Of Misbranded Controlled Substance in violation of 35 P.S. § 780-113(a)(1).⁹

CONCLUSIONS OF LAW

- 1. Officer Smith acted properly when he approached Defendant and asked him to turn down the volume of his stereo system.
- 2. He also properly asked for identification.
- 3. The officer had the Defendant in view while the latter alighted from the vehicle and described nothing that would indicate that the Defendant personally dropped the pill container or attempted to throw away or discard evidence. He merely said that the container dropped from Defendant's vehicle when the latter alighted from it. Thus he could not have reasonably suspected that Defendant was attempting to throw away or discard evidence.
- 4. The most reasonable inference to be drawn from testimony is that Defendant's action in getting out of the car accidently caused the pill bottle to fall to the pavement.
- 5. Officer Hilyard had a right to detain Defendant and pat him down.
- 6. Lacking reasonable suspicion that Defendant was armed, the officer lacked the right to intrude into Defendant's pocket or to effectuate an arrest.
- 7. Even if Defendant were guilty of disorderly conduct, the violation would not support a warrantless arrest.

- 8. Mere possession of a pill container with several sizes and kinds of pills would not support probable cause to arrest Defendant.
- Commonwealth failed to establish valid consent by Defendant to a search of the vehicle. However, this is a moot point since nothing incriminating was found.
- 10. Although the undersigned might have some misgivings about Officer Smith's search of the purse, this Court is not justified in disregarding his statement that she understood her right to refuse consent and therefore rules that the search was consensual.
- 11. Defendant was subject to an unlawful search and seizure of the cash in his pocket.
- 12. The money seized must be suppressed.
- 13. Defendant is not entitled to have the purse's contents suppressed.
- 14. The circumstances of this case do not justify a finding of abandonment by Defendant of the pill container.
- 15. Officer Hilyard lacked probable cause to either open the pill container or to arrest Defendant. The contents must be suppressed.
- 16. Commonwealth has failed to establish Defendant's constructive possession of the purse and its contents.
- 17. Commonwealth has failed to establish Defendant's constructive possession of the pill container's contents.
- 18. The request for a writ of habeas corpus must be granted and the charges against Defendant must be dismissed.

DISCUSSION

Suppression

In many ways, the facts in this case resemble a classic situation involving an encounter that escalates to establishment of probable cause and a lawful arrest. A search of a purse indicated the presence of controlled substances. A pill container was dropped and rolled away. Defendant had a large amount of money in his pocket.

The problem with transition from suspicion to probable cause is the presence of several crucial gaps. Nothing indicates that the purse's contents were packaged consistent with sale. Really, nothing was said about the pill container at the hearing except that more than one type of pill was in it and the label showed a woman's name. Defendant's initial disavowal of knowledge about it was most likely due to just that, a lack of knowledge. The car was cluttered and Defendant could understandably have been unaware that a pill container fell out when he went searching for identification. He later acknowledged knowing the person whose name appeared on the label and said he would call her. Officer Hilyard opened the container based apparently on his understanding that having more than one size pill in a container was a crime. He seized money as a result of a pat down designed to determine if weapons were present.

The provisions of 35 P.S. §780-113(a) make it unlawful for a person to possess any drug, device, or cosmetic that is misbranded. No evidence at the hearing established this fact. All that was shown was that pills of indefinite character other than varying sizes were in a prescription pill container. People use such containers for many purposes. An average citizen going on vacation and using a container for all that person's vitamins and prescription medicines would justifiably be shocked if accused of possessing misbranded controlled substances. Superior Court has previously acknowledged these facts of life and held that more than suspicion is required to open such a container. *Com v. Kelly*, 409 A.2d 21 (Pa. Super. 1979).

It has long been the law in this Commonwealth that pat-downs or frisks are justified only for weapons. Intrusion into a pocket must be supported by reasonable fear that a weapon is present. Such a fear was not established. *Com v. Taylor*, 771 A.2d 1261 (Pa. 2001).

Defendant's consent to a search of his car was invalid because the facts fail to show he actually consented and also because of the officer's failure to give *Miranda* warnings and inform Defendant that he had a right to refuse consent. However, since nothing was discovered of an incriminating nature, these deficiencies are of no moment.

We have previously commented about misgivings concerning cocaine found in Ms. Jarockicave's purse. The law in this area is interesting, to say the least. Commonwealth concedes that Defendant has standing to contest that search. The question begs, however, what benefit exactly accrues from such standing? He certainly was in no position to effectively litigate the validity of Ms.

¹⁰That person's name was not revealed to the Court but surely the police knew it.

Jarockicave's consent without her cooperation. She was not called to dispute the officer's assertion and we cannot justify disregarding or disbelieving Officer Smith's testimony. Therefore, the Court denies the suppression motion with respect to the purse's contents.
