COMMONWEALTH OF PENNSYLVANIA VS. DALE BENNETT SWAIN

- 1. This Court did not have jurisdiction concerning Defendant's Motion to Vacate Sentence after thirty days from the date of sentence. Section 5505 plainly states a trial court has jurisdiction to modify a sentence within thirty days after its imposition. Failure of the court to act within that period generally results in a loss of jurisdiction to modify the sentence.

Defendant failed to raise and to preserve this issue in pretrial motions and failed to file post-sentence motions within ten days of sentence. Pennsylvania Supreme Court authority is clear that a new rule is to be applied retroactively to cases where the issue in question is "properly preserved at all stages of adjudication up to and including any direct appeal."

OPINION PURSUANT TO PA. R.A.P. 1925

The Defendant, Dale Bennett Swain (hereinafter referred to as "Defendant"), appeals this Court's entry of an Order of Court, dated August 1, 2016, and Amended Order of Court dated September 1, 2016, denying Defendant's Motion to Vacate Sentence.¹

On June 23, 2016, Defendant appeared with counsel and entered a *nolo contendere* plea to count one of the above-captioned case, driving under the influence of alcohol, a first offense, in violation of 75 Pa.C.S.A. § 3802(a)(1) of the Pennsylvania Vehicle Code as an ungraded misdemeanor. Defendant refused to provide a blood test and was sentenced under the enhanced penalties contained in § 3804(c) of the Pennsylvania Vehicle Code. Defendant was sentenced to serve 72 hours to 6 months in partial confinement at the Adams County Adult Correctional Complex.

On July 22, 2016, Defendant, through defense counsel, filed a Motion to Vacate Sentence in accordance with **Birchfield v. North Dakota**, 136 S. Ct. 2160 (2016). Relying on 42 Pa.C.S.A. § 5505, Defendant argued this Court had jurisdiction to "modify or rescind any order within thirty days after its entry, notwithstanding the prior termination of any term of Court, if no appeal from such order has been taken or allowed."

On July 28, 2016, the Honorable Michael A. George, President Judge of the Court of Common Pleas of Adams County, scheduled for August 25, 2016 a hearing before this Court on Defendant's Motion to Vacate Sentence. This Court heard argument on Defendant's Motion to Vacate Sentence on August 25, 2016. This Court denied Defendant's Motion to Vacate Sentence on September 1, 2016. ²

It should be noted that the instant Petition to Vacate Sentence is the first time Defendant raised the issue of the legality of the sentence imposed in this case. Specifically, Defendant failed to file post-sentence motions within ten days of Defendant's sentence in accordance with Pa.R.Crim.P. 720.

Initially, this Court notes that on August 25, 2016, this Court did not have jurisdiction to consider Defendant's Motion to Vacate Sentence. Defendant was sentenced on June 23, 2016 and defense counsel filed a Motion to Vacate Sentence on July 22, 2016. When this Court entertained argument on the Motion to Vacate Sentence on August 25, 2016, it was already past the 30 day time frame set forth in 42 Pa.C.S.A. § 5505. Therefore, this Court did not have jurisdiction concerning Defendant's Motion to Vacate Sentence after thirty days from the date of sentence. Section 5505 plainly states a trial court has jurisdiction to modify a sentence within thirty days after its imposition. Failure of the court to act within that period generally results in a loss of jurisdiction to modify the sentence. See **Commonwealth v. Bogden**, 528 A.2d 168, 169 – 170 (Pa. Super. 1987). Instantly, this was not a situation where there was an error in the sentencing order which was patent and obvious on the face of the order itself. **See Commonwealth v. Cole**, 263 A.2d 339 (Pa. 1970) and Commonwealth v. Holmes, 933 A.2d 57 (Pa. 2007).

Turning to the merits of Defendant's Petition to Vacate Sentence, it is evident Defendant is not entitled to the relief requested. The issue presented is whether the holding of **Birchfield** applies retroactively to this case where the **Birchfield** decision was rendered on the same date as Defendant's sentencing. Defendant failed to raise and to preserve this issue in pre-trial motions and failed to file post-sentence motions within ten days of sentence. Pennsylvania Supreme Court authority is clear that a new rule is to be applied retroactively to cases where the issue in question is "properly preserved at all stages of adjudication up to and including any direct appeal." Commonwealth v. Cabeza, 469 A.2d 146, 148 (Pa. 1983). Defendant did not file any pre-trial motion concerning the blood test refusal and enhanced penalty, nor did Defendant file post-sentence motions within ten days of sentence in accordance with Pa.R.Crim.P. 720. Accordingly, Defendant has failed to properly preserve the issue at all stages of adjudication in this case. Therefore, under Cabeza, the Birchfield holding does not apply retroactively to afford Defendant relief in this case.
