FOR VALUE RECEIVED, the undersigned, Robert Wilson (“Wilson” or “Maker”) gives this secured note (“Note”) and promise to pay to Penn Outdoor Services, LLC, (“Penn Outdoor” or “Payee”) at 2549 Industry Lane, East Norriton, PA 19403, or at such other place as the Payee may from time to time designate in writing, the sum of Thirty Thousand Dollars (\$30,000.00), lawful money of the United States, with interest, fees and principal as provided herein, and all outstanding amounts at the expiration of ninety (120) days from the date this Note is executed by Maker.

Interest

In addition to all other rights contained in this Note, if Maker defaults under any provision of this Note or otherwise and said default continues beyond any applicable notice and cure periods, then all outstanding payment obligations of Maker hereunder shall bear interest at the default rate of two percent (2%) per month (the “Default Rate”). The Default Rate shall also apply from the date of default until all outstanding obligations of Maker hereunder or any judgment thereon is paid in full. After

Payment Schedule

All outstanding unpaid principal, interest and fees must be paid in full no later than October 23, 2019, (“Due Date”) which is the ninety (120) day period required for repayment of the loan.
