- 1. Where a condemnor has relinquished its condemnation of a property, the Eminent Domain Code states that the condemnee shall be reimbursed by the condemnor for reasonable costs and expenses as provided in section 306(g) relating to preliminary objections.
- 2. Section 306(g) of the Eminent Domain Code states that if preliminary objections which have the effect of terminating the condemnation are sustained, the condemnor shall reimburse the condemnee for reasonable appraisal, attorney and engineering fees and other costs and expenses actually incurred because of the condemnation proceedings.
- 3. After relinquishment, a condemnor is required to pay fees, costs and expenses actually incurred because of the condemnation proceedings.
- 4. Where a term is undefined, the court may consult definitions in statutes, regulations, or the dictionary for guidance, although such definitions are not controlling.
- 5. A proceeding is generally defined as the form and manner of conducting judicial business before a court or judicial officer; regular and orderly progress in form of law, including all possible steps in an action from its commencement to the execution of judgment. The term commence is defined as to initiate by performing the first act; to institute or state.
- 6. Civil action in most jurisdictions is started by filing a complaint with the court.
- 7. In Pennsylvania, a condemnation proceeding shall be brought in the court of the county in which the property is located.
- Condemnation shall be affected only by the filing in court of a declaration of taking with the security required under section 303(a) of the Eminent Domain Code relating to security required.
- 9. The starting point for the accrual of fees and costs is the first statutory act required by the Eminent Domain Code to condemn the property, which is the filing of the Declaration.
- 10. In the event of relinquishment, the condemnor has no duty to make the condemnee whole. Condemnees are not entitled to an award for speculative damages, loss or injury or for any other category of damages not expressly provided by statute nor reimbursement for items such as loss rentals and interest on the various claims.
- 11. Collateral costs are not reimbursable under the Eminent Domain Code.
- 12. Condemnees are not entitled by statute or otherwise, to be reimbursed for: land planning fees; professional fees and costs incurred to investigate potential sites for relocation; professional fees and costs incurred to mitigate disruption and business

loss and to assist with reestablishment; nor lost management time of employees and employees of affiliated companies.

- 13. Recovery is limited to reasonable attorney and expert fees and costs. The reasonableness of an award is a matter committed to the sound discretion of the trial court and can be disturbed by an appellate court only upon a clear abuse of discretion.
- 14. Interest on costs and fees are not authorized by the Eminent Domain Code.
- 15. Condemnor school district relinquished its condemnation of the condemnees property. Condemnees filed a petition for reimbursement of costs associated with the condemnation proceeding. After a hearing, the Court <u>Held</u>, that the petition was granted and ordered the condemnor to pay condemnee \$51,514.00 for reimbursement of reasonable fees and costs within thirty days of the date of the Court's order.

### **MEMORANDUM AND ORDER**

This matter comes before the court on the Petition for Reimbursement Pursuant to 26 Pa.C.S. §§ 306(g) and 308(c), filed by Condemnees, Harry C. Miller, III, and County Propane, LLC, on June 1, 2022. Condemnor, Downingtown Area School District, filed its Answer to the Petition on June 21, 2022. Condemnees filed a memorandum of law in support of their Petition on September 27, 2024. Condemnor filed its memorandum of law in opposition to the Petition on October 21, 2024. A hearing was held on December 20, 2024. Thereafter, the parties submitted post-hearing memoranda. The matter is now ripe for decision. After consideration of all the filings, memoranda of law, and after hearing, the Petition is granted.

#### **DISCUSSION**

Where, as here, a condemnor has relinquished its condemnation of a property, the Eminent Domain Code (Code) states that, "the condemnee shall be reimbursed by the condemnor for reasonable costs and expenses as provided in section 306(g) (relating to preliminary objections)." 26 Pa.C.S. § 308(d). Section 306(g), in turn, states that, "if preliminary objections which have the effect of terminating the condemnation are sustained, the condemnor shall reimburse the condemnee for reasonable appraisal, attorney and engineering fees and other costs and expenses actually incurred because of the condemnation proceedings." 26 Pa.C.S. § 306(g)(1).

The parties do not dispute that Condemnor must reimburse Condemnees "for reasonable appraisal, attorney and engineering fees and other costs and expenses actually incurred because of the condemnation proceedings." *Id.* The parties' dispute arises with regard to three issues. The first is whether Condemnor's liability for reimbursement begins to accrue at the filing of the Declaration of Taking (Declaration) or when the intent to condemn is first made known to a property owner? The second is whether Condemnees are entitled to reimbursement of expenses without limitation on the type or nature of such expenses? Third, whether Condemnees legal fees are reasonable? Each issue shall be addressed in turn.

#### A. Time reimbursable expenses began to accrue.

The Declaration was filed in this matter on February 21, 2020. A Notice of Relinquishment was filed on June 4, 2020. The Code is clear that after relinquishment a condemnor is required to pay fees, costs and expenses "actually incurred **because of the condemnation proceedings.**" 26 Pa.C.S. § 306(g)(1) (emphasis added). The

term "condemnation proceedings" is not defined by the Code. Where, as here, a term is undefined the court, "may consult definitions in statutes, regulations, or the dictionary for guidance, although such definitions are not controlling." *Kuharchik Constr., Inc. v. Commonwealth*, 265 A.3d 829, 836 (Pa.Cmwlth. 2021) (extensive discussion on the appropriateness of utilizing a dictionary definition for an undefined term); *Hawes v. Bureau of Pro. & Occupational Affs., State Real Est. Comm'n*, 204 A.3d 1019 (Pa. Cmwlth. 2019) (utilizing dictionary to define the term "false representation").

Pennsylvania's Judicial Code definition of proceeding to include "every **declaration**, petition or other application **which may be made to a court** under law or usage or under special statutory authority, but the term does not include an action or an appeal." 42 Pa.C.S. § 102 (emphasis added). At the most fundamental level a proceeding is generally defined as, "the form and manner **of conducting judicial business before a court or judicial officer**. Regular and orderly progress in form of law, including all possible steps in an action **from its commencement** to the execution of judgment." BLACK'S LAW DICTIONARY 1083 (5th ed. 1979) (emphasis added). The term commence is, in turn, defined as "to initiate by performing the first act. To institute or state. *Civil action* in most jurisdictions is started by filing a complaint with the court." *Id.* at 243 (italics in original).

In Pennsylvania, "a condemnation proceeding shall be brought in the court of the county in which the property is located." 26 Pa.C.S. § 301(a). Condemnation, "shall be effected only by the filing in court of a declaration of taking with the security required under section 303(a) (relating to security required)." 26 Pa.C.S. § 302(a) (1). The condemnation proceedings in this matter were commenced by the filing of the Declaration as required by the Code. *See* 42 Pa.C.S. § 102 (defining proceeding to include a declaration made to court).

Condemnor takes the position that it should only be responsible for reimbursable expenses between the dates of the filing of the Declaration and Notice of Relinquishment. In support of this contention, Condemnor relies on *Pothos v. Urb. Redevelopment Auth. of Pittsburgh*, 374 A.2d 96, 98 (Pa.Cmwlth. 1977)<sup>1</sup> for the proposition that Condemnees have no right to recover losses and expenses resulting from the discontinuance of the proceeding. Condemnees do not appear to contest that there is no recovery for costs and expenses incurred post-relinquishment. Condemnees contend that they are entitled to costs and expenses incurred prior to the filing of the Declaration in this matter.

Condemnees rely on *Twp. of W. Orange v. 769 Assocs.*, LLC, 969 A.2d 1080, 1090 (N.J. 2009), a case from New Jersey to support their position that they are entitled to reimbursement for costs and expenses incurred prior to the filing of the Declaration. Condemnees further argue that because the New Jersey statutes governing eminent domain proceedings are similar to those in Pennsylvania, this court should be persuaded to conclude that Condemnees are entitled to all costs and expense incurred before the filing of the Declaration. Condemnees representation is, at best, inaccurate

and their reliance misplaced.

In the state of New Jersey, "no action to condemn shall be instituted unless the condemnor is unable to acquire such title or possession through bona fide negotiations with the prospective condemnee." N.J.S.A. 20:3-6 (Application of act). The *West Orange* court recognized the mandated negotiation phase as the starting point for considering reimbursable costs and expenses. That court specifically excluded collateral fees and expenses not directly related to the condemnation. *Id.* at 1090.

Pennsylvania does not mandate negotiations prior to the filing of a declaration of taking. *E.g., In re Sch. Dist. of Pittsburgh, Allegheny Cnty.*, 244 A.2d 42 (Pa. 1968) (no requirement that there be allegations in the declaration of an effort to negotiate a purchase). The court finds that the starting point for the accrual of fees and costs is the first statutory act required by the Code to condemn the Property, which is the filing of the Declaration.

### B. Reimbursable costs and expenses.

Condemnees claim that they are entitled to four classes of reimbursable fees and costs. The first is "professional fees and costs as a result of [Condemnor's] threatened and actual condemnation, including Attorneys' fees, appraisal fees and, [and] land planning fees." Petition at 6. The second is "professional fees and costs incurred as a result of having to investigate potential sites for relocation." *Id.* The third is "professional fees and costs incurred to mitigate disruption and business loss and to assist with reestablishment." *Id.* The fourth is "lost management time of County Propane employees and employees of affiliated companies." *Id.* 

Condemnee appears to take the position that it must be made whole for every expense or perceived expense it may have incurred prior to or during the condemnation proceedings in this matter. The law is clear that in the event of relinquishment, the condemnor has no duty to make the condemnee whole. *In re Condemnation by Com., Dept. of Transp.*, 709 A.2d 939, 944 (Pa.Cmwlth. 1998) (so stating in allowing reimbursement of, *inter alia*, attorney's fees, court costs and expenses, taxes, insurance premiums and costs of improvements). Condemnees are not entitled to "an award for speculative damages, loss or injury or for any other category of damages not expressly provided by statute" nor reimbursement for items such as "loss rentals and interest on the various claims." *Id.* at 944.

Although not directly on point, the discussion in R & J Holding Co. v. Redevelopment Authority of County of Montgomery, 885 A.2d 643 (Pa.Cmwlth. 2005), is instructive. In that case a declaration of taking was filed, but later declared invalid by the courts. Property owner sought the appointment of a board of view to assess compensation due on an alleged de facto taking. On appeal the Commonwealth Court found that based on the facts, the matter should be treated as a relinquishment and that the condemnee had already been reimbursed. In finding that the condemnee was limited to that reimbursement and no more, it made clear that "the Code does not require that a condemnee be made whole." *Id.* at 650.

In the present matter, the vast majority of the requested reimbursements predate

the filing of the Declaration in the first instance and are not reimbursable. Even if those costs and expenses did not predate the filing of the Declaration, they are collateral costs that are not reimbursable under the Code. *See* 26 Pa.C.S. § 308(d) (reimbursement upon relinquishment); 26 Pa.C.S. § 306(g)(1) (setting forth the items to be reimbursed); *R & J Holding Co. v. Redevelopment Authority of County of Montgomery*, 885 A.2d 643; *accord Twp. of W. Orange v. 769 Assocs.*, LLC, 969 A.2d 1080, 1090 (fees for prerogative writs and planning board meetings were not recoverable because they were collateral and not directly related condemnation).

Therefore, Condemnees are only entitled to reimbursement of fees and costs as a result of and directly related to the filing of the Declaration, including attorneys' fees and post-filing appraisal fees. Condemnees are not entitled by statute or otherwise, to be reimbursed for: land planning fees; professional fees and costs incurred to investigate potential sites for relocation; professional fees and costs incurred to mitigate disruption and business loss and to assist with reestablishment; nor lost management time of County Propane employees and employees of affiliated companies. Those claims are denied.

### C. Legal fees.

The parties do not dispute the hours worked or the quality of the work performed by counsel for Condemnees after the filing of the Declaration. The dispute arises over the hourly rates charged by Condemnees' attorneys for their work on the condemnation proceeding. The Code "does not require that a condemnee be made whole; rather, recovery is limited to reasonable attorney and expert fees and costs. The reasonableness of an award is a matter committed to the sound discretion of the trial court and can be disturbed by an appellate court only upon a clear abuse of discretion." *Twp. of Millcreek v. Angela Cres Tr. of June 25, 1998*, 142 A.3d 948, 956 (Pa.Cmwlth. 2016).

One of the issues in *Twp. of Millcreek*, was whether it was appropriate for the trial court to decrease legal fees to be paid to a condemnee based upon its finding that rates for legal services charged by a Philadelphia firm "were outside the normative rates charged" in that area of Pennsylvania. The Court found that in this regard, the trial court committed no error.

The court heard the testimony of Condemnee Miller who represented that he had paid Chester County attorneys legal fees for services in or around the same time period as those of his condemnation counsel. The Chester County legal fees ranged from a minimum of \$275.00 per hour charged by Arthur Sagnor, Esquire, to \$400.00 per hour charged by Lou Calogreco, Esquire, both experienced members of the bar. (Exh. P-1, P-2).<sup>2</sup> The Philadelphia firm of Blank Rome charged Condemnees \$650.00 per hour for Francis X. Crowley, Esquire, \$440.00 per hour for Samuel M. Ventresca, an associate, and \$950.00 per hour for Peter F. Kelsen. (Exh. P-18). Condemnee Miller represented that he had no choice but to hire Philadelphia counsel because the firms in Chester County had conflicts. The court did not find this testimony credible.

Mr. Crowley testified that he is a litigator and that Blank Rome has set his rate at \$650.00 per hour. There is no doubt that Mr. Crowley believes his time is worth \$650.00 per hour, and it is likely that Mr. Kelsen holds the same belief with regard to his hourly rate. It appears that Blank Rome sets its hourly rates to that which the market will bear in Philadelphia. Condemnees *chose* to pay those rates. However neither the market rates for legal services in Philadelphia nor Condemnees willingness to pay those rates renders them reasonable. These rates are well outside the normal range of fees charged in Chester County<sup>3</sup> and therefore, unreasonable. These rates will be normalized to what is reasonable in Chester County, by granting both Mr. Crowley and Mr. Kelsen a rate consistent with the highest Chester County rate for legal fees paid by Condemnees, \$400.00 per hour. The hourly rate charged by Mr. Ventresca, who at the time was a second or third year associate (Exh. P-1.E p.13), will be set at \$250.00 per hour, which is slightly below the lowest hourly fee of \$275.00 paid by Condemnees.

### D. Claim for payment of interest on amount of reimbursement.

Condemnees seek payment of interest on the amount of fees and costs to be reimbursed in this matter. The parties do not appear to have specifically addressed this issue, but Condemnees provide no citation to a case or statute to support their claim. Condemnees are not entitled to "an award for speculative damages, loss or injury or for any other category of damages not expressly provided by statute" nor reimbursement for items such as "loss rentals **and interest on the various claims**." *In re Condemnation by Com., Dept. of Transp.*, 709 A.2d 939, 944 (Pa.Cmwlth. 1998) (emphasis added).

Even under a more expansive just compensation analysis, interest would not be authorized. Chapter 7 of the Code states that, "during the period the condemnee remains in possession after the condemnation ... the condemnee shall not be entitled to compensation for delay in payment." 26 Pa.C.S. § 713(b)(2). Condemnees at all times remained in possession of the condemned property.

The Judicial Code states that "except as otherwise provided by another statute, a judgment for a specific sum of money shall bear interest at the lawful rate from the date of the verdict or award, or from the date of the judgment, if the judgment is not entered upon a verdict or award." 42 Pa.C.S. § 8101 (Interest on judgements). No judgement has been entered in this matter and there is no statutory basis for a claim for payment of interest.

Condemnees' claims for interest are denied.

E. Amounts to be reimbursed.

Condemnees are entitled to reasonable attorneys' fees from February 21, 2020

through and including June 4, 2020. The only attorneys providing legal services during that time frame were Blank Rome attorneys Mr. Crowley, Mr. Kelsen, and Mr. Ventresca. Mr. Crowley billed 31 hours, Mr. Ventresca 52.5, and Mr. Kelsen 0.7. (Exh. P-18 p. 435-450). Based on the hour rates set forth hereinabove, the reimbursable legal fees are:

Condemnees may also recover most of the appraisal fees paid to Clarion/Samuels. The October/December invoice predates the filing of the Declaration and is not reimbursable. (Exh. P-9 p. 369). The invoice for appraisal services for December 2019 through May of 2020, will be fully reimbursed in the amount of \$25,709.00.<sup>4</sup>

After consideration of the foregoing, and for all of the reasons stated, we enter this

### <u>ORDER</u>

AND NOW, this 27th day of January, 2025, upon review of the Petition for Reimbursement Pursuant to 26 Pa.C.S. §§ 306(g) and 308(c), filed by Condemnees, Harry C. Miller, III, and County Propane, LLC, for Reimbursement Pursuant to 26 Pa.C.S. §§ 306(g) and 308(c) (Petition) filed on June 1, 2022, the answer of Condemnor, the Downingtown Area School District, and after hearing, it is hereby ORDERED that the Petition is GRANTED.

It is FURTHER ORDERED that the Downingtown Area School District shall pay Condemnees \$51,514.00, for reimbursement of reasonable fees and costs, within thirty (30) days of the date of this Order.
