SUMMARY OF OPINION:

Defendant filed a preliminary objection under Pa.R.Civ.P. 1028(a)(2) seeking to dismiss the complaint for failure to comply with Pa.R.Civ.P. 1020(d) governing the compulsory joinder of claims. Plaintiff had filed an initial action seeking to recover damages resulting from defendant's sale of kitchen cabinets to plaintiff and their faulty installation by independent contractors. After securing a judgment which defendant paid, plaintiff filed a second action seeking damages relating to his hiring of another contractor, but a judgment was entered in favor of the defendant in that second action. Plaintiff then filed this third action demanding reimbursement of hotel costs incurred due to installation delays caused by the independent contractors.

Rule 1020(d) obligates litigants to file all causes of action arising from the same transaction or occurrence in a single action, regardless of the nature of the claim. Claims arise from the same "transaction or occurrence" if they involve either a common factual background or common factual or legal questions. Subdivision (d) of Rule 1020 expressly states that the "[f]ailure to join a cause of action as required by this subdivision shall be deemed a waiver of that cause of action as against all parties to the action." Since plaintiff failed to raise the instant damage claims in his earlier actions arising from the same transaction or occurrence, defendant's preliminary objection was sustained without prejudice to any claims that plaintiff sought to assert against the independent contractor installers.

SUMMARY OF OPINION:

The widow of a railroad worker instituted this litigation seeking wrongful death and survival damages under the FELA, and asserted that her husband contracted cancer and later died from continuous exposure to toxic substances during his railroad employment due to the railroad employer's failure to provide a reasonably safe work environment. The employer filed a motion for summary judgment seeking to dismiss the case on the ground that it was time-barred by the three-year statute of limitations for FELA claims, and alternatively demanded judgment on the basis that the widow could not prove that she suffered any "pecuniary loss" as a result of her husband's death.

Under the federal "discovery rule" that applies in FELA cases, the limitations period begins to run when the plaintiff or decedent knew, or in the exercise of reasonable diligence should have known, of both the occupational disease and its operative cause. The record indicated that although the decedent was first diagnosed with cancer on April 12, 2007, and later died on October 13, 2014, neither he nor his widow was ever advised by any health care provider, railroad representative, or other person that the cancer was possibly related to decedent's railroad work or his exposure to toxic substances. The evidence submitted for review reflected that a potential causal connection between the decedent's cancer and his railroad work was first mentioned to the widow by a co-worker of the decedent in the same year that she filed this FELA action. Since it was not clear and free from doubt that the widow or the decedent possessed critical facts to objectively discover his occupational disease and its cause more than three years before the suit was filed, the employer was not entitled to summary judgment based on the expiration of the statute of limitations. Under 45 U.S.C. § 51, the widow could recover wrongful death damages for the after-tax income that the decedent would have earned and contributed to her support if he had lived, as well as the pecuniary value of any household services that he would have provided to her. The widow could also seek damages in the survival action under 45 U.S.C. § 59 for any pain and suffering endured by the decedent as a result of his occupational disease. Triable issues of fact existed with respect to the wrongful death and survival damages recoverable, and as a result, the employer's motion for summary judgment was denied.
