AND NOW, this 19th day of July,
2021, at 8:50 a.m., upon consideration
of the Petition for Involuntary Termination
of Parental Rights of the Unknown
Natural Father of Minor Child
Z.A.S.-K. Born to Starr Aileen Kline,
and after hearing held thereon, the
Court by clear and convincing evidence
