#### OPINION AND ORDER

No. 697 of 2021

Leskinen, J. July 19, 2022

Before the Court is the Defendant's Motion For Return Of Property. After a careful review of the evidence and applicable case law, the Court hereby issues the following OPINION AND ORDER:

#### Factual Background

The Defendant seeks the return of a firearm and ammunition. The Defendant plead Guilty to six counts of Disorderly Conduct on February 9th, 2022. This Court sentenced the Defendant on the same day. The Sentence Order was clocked-in at the Clerk Of Courts Office on February 11th, 2022 at 9:54 am. The Defendant filed his Motion For Return Of Property on May 26th, 2022. Legal Standard

Pa.R.Crim.P. Rule 588(A) states:

A person aggrieved by a search and seizure, whether or not executed pursuant to a warrant, may move for the return of the property on the ground that he or she is entitled to lawful possession thereof. Such motion shall be filed in the court of common pleas for the judicial district in which the property was seized.

The Pennsylvania Supreme Court has interpreted Pa.R.Crim.P. Rule 588(A) as follows:

[A] return motion is timely when it is filed by an accused in the trial court while that court retains jurisdiction, which is up to thirty days after disposition. See 42 Pa.C.S. § 5505 (providing that a trial court retains jurisdiction to modify or rescind any order within thirty days of its entry, if no appeal has been taken).

Com. v. Allen, 107 A.3d 709, 717 (2014).

#### 42 Pa.C.S.A. § 5505 states:

Except as otherwise provided or prescribed by law, a court upon notice to the parties may modify or rescind any order within 30 days after its entry, notwithstanding the prior termination of any term of court, if no appeal from such order has been taken or allowed.

Trial courts have the power to alter or modify a criminal sentence within thirty days after entry, if no appeal is taken. Com. v. Walters, 814 A.2d 253, 255-56 (Pa. Super. 2002) quoting Com. v. Quinlan, 639 A.2d 1235, 1238 (1994). Generally, once the thirty - day period is over, the trial court loses the power to alter its orders. Id. The date of receipt is the date of filing. Pa.R.Crim.P. 114, Comment.

#### Discussion

The Defendant's Sentence Order was clocked-in at the Clerk Of Courts Office on February 11th, 2022 at 9:54 am. The Defendant's Sentence Order was dispositive. The Defendant did not file an Appeal. Pursuant to 42 Pa.C.S.A. § 5505, this Court retained jurisdiction for thirty days after the Defendant's Sentence Order was clocked-in. Thirty days after February 11th, 2022 was Sunday, March 13th, 2022. Since March 13th, 2022 fell on a Sunday, the last day this Court retained jurisdiction over this matter was Monday, March 14th, 2022. Monday, March 14th, 2022, therefore, was the last day on which the Defendant could have filed a Motion For Return Of Property pursuant to Com. v. Allen. The Defendant did not file his Motion For Return Of Property until May 26th, 2022: seventy three days late.

#### Conclusion

The Court finds that it lacks jurisdiction over the Defendant's Motion For Return Of Property due to the fact that the Defendant filed his Motion For Return Of Property seventy three days late.

WHEREFORE, the Court issues the following Order:

#### ORDER

AND NOW, this 19th day of July, 2022, the Court finds that the Defendant filed his Motion For Return Of Property seventy three days late. The Court therefore lacks jurisdiction over the Defendant's Motion pursuant to Com. v. Allen, 107 A.3d 709, 717 (2014).
