ANNE D. O'REILLY v. CHRISTOPHER IRVINE and BARBARA MARTIN

- 1. This case arises out of a contract between Plaintiff Anne D. O'Reilly and Defendants for the sale and ownership of two male puppies.
- 2. On July 3, 2023, Plaintiff initiated the current action *pro se*. Due to numerous procedural deficiencies with Plaintiff's initial Complaint, this Court sustained Defendant's Preliminary Objections to that Complaint on October 4, 2023, and granted Plaintiff leave to file an Amended Complaint.
- 3. Defendants contend that Plaintiff's Amended Complaint includes scandalous or impertinent matter and that Plaintiff's Amended Complaint lacks the specificity needed for them to properly respond.
- 4. Here, any reference to Plaintiff's age and health has no bearing on any of Plaintiff's causes of action. Plaintiff's emotional state is equally immaterial to proving any of her claims since none of her claims have an emotional component as an element. Plaintiff's allegation of Defendants holding the dogs for ransom not only is irrelevant to any cause of action, but it is also scandalous and inappropriate because it is inflammatory and derogatory.
- 5. Conversely, Plaintiff's allegations that are material and bear on any cause of action are not scandalous or impertinent. Because "coowned" appears in the contracts attached to Plaintiff's Amended Complaint, Plaintiff's allegations regarding the care of the dogs and the possibility that they could be seized due to alleged violations of local and state law are potentially relevant to her claims for breach of contract and conversion.
- 6. Contrary to Defendants' contention, there is nothing in the Rule that prohibits Plaintiff from using compound sentences. Plaintiff's Amended Complaint provides Defendants with notice of her claims and the facts she alleges to support those claims. Defendants have enough information to be able to properly respond to Plaintiff's allegations.

OPINION

Before this Court are Defendants Christopher Irvine and Barbara Martin's Corrected Preliminary Objections to Plaintiff's Amended Complaint. Defendants contend that Plaintiff's Amended Complaint includes scandalous or impertinent matter and that Plaintiff's Amended Complaint lacks the specificity needed for them to properly respond. For the reasons set forth herein, the attached Order sustaining in part and overruling in part Defendants' first Objection regarding scandalous and impertinent material and overruling Defendants' second Objection regarding specificity is entered. Defendants have twenty (20) days to file an Answer to Plaintiff's Amended Complaint. All parties are directed to proceed with this case in accordance with the Pennsylvania Rules of Civil Procedure and the local rules of this Court.

BACKGROUND

This case arises out of a contract between Plaintiff Anne D. O'Reilly and Defendants for the sale and ownership of two male puppies.

On February 11, 2022, Defendant's dog bred Plaintiff's dog, and four puppies were born from that union on April 11, 2022. On June 25, 2022, Plaintiff and Defendants signed written agreements relating to the ownership of the four puppies, and Defendants

brought two male puppies home. Defendants gave Plaintiff a cashier's check for the agreed upon amount, which Plaintiff did not cash. On June 27, 2022, Defendants emailed Plaintiff to cancel the contracts for all the puppies.

Plaintiff requested that Defendants return the two puppies in their possession. Defendants did not do so. Defendants initiated a civil action in an Adams County Magisterial District Court, requesting sole ownership of all four puppies and \$7,500. On March 28, 2023, the Honorable Mark Beauchat heard oral argument. The court ruled in favor of Plaintiff regarding the monetary damages but determined it had no jurisdiction to decide the ownership or possession of the dogs.²

On July 3, 2023, Plaintiff initiated the current action *pro se*. Due to numerous procedural deficiencies with Plaintiff's initial Complaint, this Court sustained Defendant's Preliminary Objections to that Complaint on October 4, 2023, and granted Plaintiff leave to file an Amended Complaint. Plaintiff retained Counsel and filed an Amended Complaint on October 27, 2023. Plaintiff alleges three causes of action: breach of contract, unjust enrichment, and conversion.

Defendants first filed Preliminary Objections to Plaintiff's Amended Complaint on November 22, 2023, but did not file a supporting mandated by Adams brief as C.Civ.R. 1028(c)(A)(1). On December 20, 2023, Plaintiff filed a Praecipe to Dismiss Defendants Preliminary Objections, as authorized by Adams C.Civ.R. No. 1028(c)(A)(1), and a Memorandum of Law in Response to Defendants' Preliminary Objections. Defendants then filed a Praecipe to Attach the instant Corrected Preliminary Objections on December 28, 2023. Defendants explained that they had originally mistakenly filed a draft of their Preliminary Objections. In the interests of justice, this Court denied Plaintiff's Praecipe to Dismiss Defendants' Preliminary Objections and directed Plaintiff to file a responsive brief to Defendants' Corrected

² Plaintiff in the current case was the defendant in the Magisterial District Court case. The Magisterial District Court found in favor of Plaintiff in the current case, who was the defendant in the case before it.

Preliminary Objections or notify this Court that Plaintiff stood on her December 20, 2023 Memorandum of Law. On January 8, 2023, Plaintiff notified this Court that she stood on her December 20, 2023 Memorandum of Law.

DISCUSSION

Defendants raise two Preliminary Objections: the inclusion of scandalous or impertinent material and insufficient specificity of the Amended Complaint. This Court will address each in turn.

A. Scandalous or Impertinent Material

Defendants first contend that numerous paragraphs in Plaintiff's Amended Complaint contain scandalous or impertinent material. Specifically, Defendants aver that many statements in the Amended Complaint are immaterial and inappropriate to the causes of action Plaintiff alleges.

Pennsylvania Rule of Civil Procedure 1028(a) allows Preliminary Objections for "inclusion of scandalous or impertinent matter[.]" Pa. R. Civ. P. 1028(a)(2). "In order to be scandalous or impertinent, 'the allegation must be immaterial and inappropriate to the proof of the cause of action." **Breslin v. Mountain View Nursing Home, Inc.**, 171 A.3d 818, 829 (Pa. Super. 2017) (quoting **Common Cause/Pennsylvania v. Commonwealth**, 710 A.2d 108, 115 (Pa. Cmwth. 1998)). An allegation may be struck as immaterial and inappropriate to the cause of action if it "has no obvious bearing" on the case. **Biros v. U Lock Inc.**, 255 A.3d 489, 497 (Pa. Super. 2021).

In the instant case, Defendants object to several of Plaintiff's averments. In deciding whether Plaintiff's statements are immaterial, this Court considered whether the statement at issue had any possible bearing on one of Plaintiff's causes of action. "A cause of action for breach of contract must be established by pleading (1) the existence of a contract, including its essential terms, (2) a breach of a duty imposed by the contract and (3) resultant damages."

Pennsy Supply, Inc. v. Am. Ash Recycling Corp. of Pennsylvania, 895 A.2d 595, 600 (Pa. Super. 2006) (quoting Corestates Bank, N.A. v. Cutillo, 723 A.2d 1053, 1058 (Pa. Super.

1999)). To establish unjust enrichment, a plaintiff must show: "(1) benefits [were] conferred on defendant by plaintiff; (2) appreciation of such benefits by defendant; and (3) acceptance and retention of such benefits under such circumstances that it would be inequitable for defendant to retain the benefit without payment of value[.]" Wilson v. Parker, 227 A.3d 343, 353 (Pa. Super. 2020) (quoting Meyer, Darragh, Buckler, Bebenek & Eck, P.L.L.C. v. Law Firm of Malone Middleman, P.C., 179 A.3d 1093, 1102 (Pa. 2018)). Pennsylvania law defines conversion as "the deprivation of another's right of property in, or use or possession of, a chattel, or other interference therewith, without the owner's consent and without lawful justification." McKeeman v. Corestates Bank, N.A., 751 A.2d 655, 659 n.3 (Pa. Super. 2000) (quoting Stevenson v. Economy Bank of Ambridge, 197 A.2d 721, 726 (Pa. 1964)).

Here, any reference to Plaintiff's age or health has no bearing on any of Plaintiff's causes of action. Plaintiff's emotional state is equally immaterial to proving any of her claims since none of her claims have an emotional component as an element. Plaintiff's allegation of Defendants holding the dogs for ransom not only is irrelevant to any cause of action, but it is also scandalous and inappropriate because it is inflammatory and derogatory. Plaintiff can allege that Defendants have refused to return the dogs and have possession of them, but alleging a motive of ransom, even if true, is unnecessary to prove any cause of action in this case. Similarly, no cause of action here requires proof of a third party's involvement. The case presently is against the named Defendants; if Plaintiff wishes to amend her complaint to add other defendants at a later time, this Court will address that issue upon a proper Motion. Plaintiff's Amended Complaint also has two instances where a name is provided that is not the name of any of the Parties and is not mentioned anywhere else in the Complaint. Because these individuals have no bearing on the instant case, their inclusion is impertinent. Likewise, fragments of an averment that do not make grammatical sense are impertinent and immaterial.

Conversely, Plaintiff's allegations that are material and bear on any cause of action are not scandalous or impertinent. Because the word "co-owned" appears in the contracts attached to Plaintiff's

Amended Complaint, Plaintiff's allegations regarding the care of the dogs and the possibility that they could be seized due to alleged violations of local and state laws are potentially relevant to her claims for breach of contract and conversion. Because Plaintiff must allege damages for her breach of contract claim, her averments regarding the dogs' training and potential career as show dogs is material. Defendants can refute Plaintiff's allegations in their Answer, but Plaintiff is allowed to make factual claims supporting her causes of action. Additionally, a fair reading of paragraph 40 of Plaintiff's Amended Complaint is that the inclusion of the number 41 is a typographical error and that the paragraph should continue with the averment made in paragraph 41. It should read "... and not up to the Plaintiff's standards and reputation ..." Defendants may respond in their Answer to Plaintiff's averments in paragraphs 40 and 41 together.

Therefore, Defendants' Objections to the bolded words in paragraphs 21; 22; 23; 34 from "ransom" to "whatsoever."; 35; 49; 60; and 63 of Plaintiff's Amended Complaint are sustained and those averments are stricken from the Amended Complaint. Defendants' Objections to the bolded words in paragraphs 12; 27; 29; 30; 31; 34 from "The" to "rights to,"; 38; 39; 40; and 42 of Plaintiff's Amended Complaint are overruled.

B. Insufficient Specificity

Defendants next contend that Plaintiff's Amended Complaint lacks the specificity needed for them to respond.

Pennsylvania Rule of Civil Procedure 1028(a) allows Preliminary Objections for "insufficient specificity of a pleading[.]" Pa. R. Civ. P. 1028(a)(3). Additionally, Rule 1019(a) requires that "[t]he material facts on which a cause of action or defense is based shall be stated in a concise and summary form." "To be legally sufficient, 'a complaint must not only give the defendant notice of what the plaintiff's claim is and the grounds upon which it rests, but the complaint must also formulate the issues by summarizing those facts essential to support the claim." Catanzaro v. Pennell, 238 A.3d 504, 507 (Pa. Super. 2020) (quoting Feingold v. Hendrzak, 15 A.3d 937, 942 (Pa. Super. 2011)). A pleading is defective if it

only has boilerplate allegations without sufficient facts. **Hortman** v. **Hortman**, 285 A.3d 916 (Pa. Super. 2022).

Here, Plaintiff avers three specific causes of action and provides specific, factual allegations. Plaintiff does not list boilerplate allegations without facts specific to her claims. Plaintiff's Amended Complaint is divided into consecutively numbered paragraphs that contain one material allegation. *See* Pa. R. Civ. P. 1022. Contrary to Defendants' contention, there is nothing in the Rule that prohibits Plaintiff from using compound sentences. Plaintiff's Amended Complaint provides Defendants with notice of her claims and the facts she alleges to support those claims. Defendants have enough information to be able to properly respond to Plaintiff's allegations.

Defendants further argue that they are unable to properly respond because Plaintiff did not state which agreements were written or verbal, in violation of Pa. Rules Civ. P. 1019(h)&(i). However, Plaintiff attached two written and signed agreements to her Amended Complaint. If Defendants disagree that the attached contracts are correct or believe that there are supplemental documents, Defendants can so state in their Answer and provide those documents. Defendants have the alleged contracts upon which Plaintiff is basing her claim and can respond in their Answer based on the documents Plaintiff provided.

Therefore, Defendants' second Preliminary Objection relating to the specificity of Plaintiff's Amended Complaint is overruled.

CONCLUSION

Therefore, for the reasons set forth herein, the attached Order sustaining in part and overruling in part Defendants' first Objection regarding scandalous and impertinent material and overruling Defendants' second Objection regarding specificity is entered. Defendants have twenty (20) days to file an Answer to Plaintiff's Amended Complaint. All parties are directed to proceed with this case in accordance with the Pennsylvania Rules of Civil Procedure and the local rules of this Court.

ORDER OF COURT

AND NOW, this 9th day of January, 2024, for the reasons set forth in the attached Opinion, Defendants' first Preliminary Objection as to the inclusion of scandalous or impertinent matter is **Sustained in part and Overruled in part** as follows:

- 1. Defendants' Objections to the bolded words in paragraphs 21; 22; 23; 34 from "ransom" to "whatsoever."; 35; 49; 60; and 63 of Plaintiff's Amended Complaint are **Sustained**. These averments are stricken from Plaintiff's Amended Complaint.
- 2. Defendants' Objections to the bolded words in paragraphs 12; 27; 29; 30; 31; 34 from "The" to "rights to,"; 38; 39; 40; and 42 of Plaintiff's Amended Complaint are **Overruled**.

Defendants' second Preliminary Objection relating to insufficient specificity is **Overruled**.

Defendants have twenty (20) days to file an Answer to Plaintiff's Amended Complaint. All parties are directed to proceed with this case in accordance with the Pennsylvania Rules of Civil Procedure and the local rules of this Court.
