ADMINISTRATIVE ORDER

AND NOW, this 22nd day of July, 2021, it appears to the Court of Common Pleas of Washington County that:

WHEREAS, Section 323 of the Judicial Code of the Commonwealth of Pennsylvania provides that the Court possesses the authority to "make such rules and orders of court as the interest of justice or *the business of the court* may require." 42 Pa. C.S.A. § 323;

WHEREAS, Section 325 of the Judicial Code of the Commonwealth of Pennsylvania provides that the president judge of a judicial district is vested as the executive and administrative head of the court, including the supervision of judicial business and the promulgation of "all administrative rules and regulations[.]" 42 Pa. C.S.A. § 325;

WHEREAS, the Court may regulate the business of the court-related filing offices (Clerk of Courts, Prothonotary, and Register of Wills/Clerk of the Orphans' Court) when necessary to ensure the proper administration of justice for the judiciary, members of the Bar, and litigants. *See, e.g., In re Ownership of Notes and Reproduction of Transcripts,* 763 A.2d 575 (Pa. Cmwlth. 2000) and *In re: Clerk of Courts Office Functions,* No. 1217 C.D. 2017 (Pa. Cmwlth. November 16, 2017);

WHEREAS, the Court issued an Administrative Order, dated January 15, 2021, setting forth procedures for the filing offices concerning, *inter alia*, hours of operation and regulations for the timely processing of filings and other related functions;

WHEREAS, Section 2906 of the Domestic Relations Code requires the Clerk of the Orphans' Court to enter on the docket an entry for the filing of any decree under the Code (i.e., the docketing of an adoption decree issued by the court). 23 Pa. Con. Stat. Ann. § 2906;

WHEREAS, Section 602 of the Health and Safety Code requires the Clerk of the Orphans' Court to provide a certificate of each adoption (Form H105.091) to the Penn-sylvania Department of Health "on or before the fifteenth day of each calendar month" that was granted in the preceding calendar month. 35 P.S. § 450.602;

WHEREAS, it has been brought to the Court's attention that that certificates of adoption (Form H105.091) in several cases have not been completed and transmitted to the Pennsylvania Department of Health since at least April of 2021;

WHEREAS, it appears that the Register of Wills/Clerk of the Orphans' Court has not transmitted certificates of adoption in at least the following cases: Nos. 63-19-0265, 63-21-0344, 63-21-0374, 63-21-375, 63-21-376, 63-2020-0605, 63-20-0606, 63-21-0615, 63-20-1538, 63-20-1539, and 63-21-0500;

WHEREAS, the failure to carry out this statutory duty is causing harm to adopted children and their families, such harm includes preventing the Department of Health from sealing the adopted child's original birth record and issuing a replacement birth record; WHEREAS, the replacement birth records are required and necessary for parents to obtain social security benefits and cards, medical benefits, school admission, identification cards and other benefits on behalf of adopted children.

WHEREAS, this Court has reviewed docketing information for decrees and/or orders issued by the Orphans' Court in guardianship actions pursuant to 20 Pa. C.S.A. § 5501, *et seq.*;

WHEREAS, it appears to this Court that the Register of Wills/Clerk of the Orphans' Court has failed to docket, scan, and distribute such guardianship decrees and/or orders in the period set forth in the Administrative Order dated January 15, 2021;

WHEREAS, the failure to carry out these duties irreparably harms the ability of the Court to function, and strips parties and other interested persons of their right to due process;

WHEREAS, the Guardianship Tracking System ("GTS"), developed and administered by the Administrative Office of Pennsylvania Courts, is an electronic filing system to be used for filing reports and inventories required for guardianships of the person and/or the estate;

WHEREAS, the Court requires that information contained in GTS be reflected in the docket and files maintained by the Register of Wills/Clerk of the Orphans' Court;

WHEREAS, the Administrative Order dated January 15, 2021, provides that the Register of Wills/Clerk of the Orphans' Court shall print, file, docket, and scan all electronic reports filed in the GTS;

WHEREAS, it appears that the Register of Wills/Clerk of the Orphans' Court is failing to comply with the procedure set forth in the preceding paragraph as provided by the Administrative Order;

WHEREAS, Pennsylvania Rule of Judicial Administration 510 provides that the Clerk of the Orphans' Court is responsible for ensuring that any guardianship report or inventory submitted in a physical paper format be manually entered into the GTS;

WHEREAS, a member of the staff of the Register of Wills/Clerk of the Orphans' Court informed this Court that the Register is not accepting reports or inventories in paper format in contravention of Rule 510;

WHEREAS, the Administrative Order dated January 15, 2021, requires the Register of Wills/Clerk of the Orphans' Court to review "Upcoming and Overdue Reports" in the GTS, and send failure to comply notifications to guardians on at least a quarterly basis;

WHEREAS, it appears that the Register of Wills/Clerk of the Orphans' Court has not sent a single late notification since approximately October 2020; and

WHEREAS, this Court has received numerous complaints among judicial officers, staff, and members of the Bar that the Register of Wills/Clerk of the Orphans' Court has failed to maintain an accurate and up-to-date docket and scanned images of filings, orderly physical files, and timely (or actual) service of decrees and/or orders, including *for example:*

In case No. 63-20-395 (a guardianship), the Register of Wills/Clerk of the Orphans' Court failed to file, scan and serve this Court's Order of October 30, 2020, directing the filing of a concise statement of matters on appeal until No-

vember 6, 2020. The Register of Wills failed to mail the order to counsel of record until January 8, 2021.

- In case No. 63-21-500 (an adoption), the Register of Wills/Clerk of the Orphans' Court failed to docket a final decree of adoption for 39 days (June 3 to July 12).
- Three final decrees of adoption issued on June 11, 2021, have still not yet been docketed to date (Nos. 63-21-359, 63-21-374, and 63-21-375).
- On July 7, 2021, the Superior Court of Pennsylvania contacted this Court to inquire about the status of a record on appeal. A member of judicial staff contacted the Register of Wills/Clerk of the Orphans' Court, James Roman, who thereafter informed the court that files, orders, and other items are missing within the Register's office.

In light of the foregoing, the Court having determined that immediate action is necessary to ensure due process, safeguard the filing of legal papers, and other critical functions related to the administration of justice and due process, it is hereby OR-DERED, ADJUDGED, and DECREED that the Register of Wills/Clerk of the Orphans' Court shall:

- 1. Bring all adoption filings up-to-date and transmit all certificates of adoption required to have been provided to the Department of Health prior to and on the fifteenth of this month, by the close of business on Friday, July 30, 2021;
- 2. Bring all guardianship filings up-to-date by Friday, July 30, 2021;
- 3. Accept reports and inventories filed by guardians in physical paper format, and ensure that said reports and inventories are manually entered into the GTS; and
- 4. Otherwise comply forthwith with the Administrative Order dated January 15, 2021.

It is further ORDERED that the Register of Wills/Clerk of the Orphans' Court shall provide a written report on his compliance with this Order at the close of business each day until July 30, 2021, or whenever the adoptions and guardianship case fillings are up-to-date, whichever is sooner. The written report shall be delivered to the President Judge and District Court Administrator.

The Court will initiate contempt proceedings in the event of a failure to adhere to this Administrative Order, or a continued inability to adhere to the Administrative Order dated January 15, 2021.

The District Court Administrator, or his designee, is directed to serve a copy of this Administrative Order on the Register of Wills/Clerk of the Orphans' Court, and cause a copy to be published in the *Washington County Reports*, the official legal publication of Washington County, at the expense of Washington County, and in the *Pennsylvania Bulletin*.
