OPINION AND ORDER

LESKINEN, J.

AND NOW, this 14th day of November 2018, upon review the Motion to Suppress Evidence, Motion to Suppress Statements, and Motion to Dismiss the charge of Drug Delivery Resulting in Death, prepared on behalf of Matthew Joseph Brumley (hereinafter Defendant), the Court HEREBY DENIES the Motion in its entirety.

BACKGROUND

On August 4, 2017 EMS and State Police were dispatched to 204 South Main Street, Room #5, Point Marion Borough, Fayette County for the report of a drug overdose. When they arrived, they found Jennifer Kaye Ward (hereinafter Victim) on the floor, deceased.

William Ward, the Victim's husband, was interviewed multiple times by Troopers. Ward provided that he contacted a man he only knew as Chaz, later identified as Chaz Franklin Rankin, for the purpose of picking up heroin. Ward and Rankin drove to the residence of the Defendant. Ward described the structure as a two (2) story residence with a covered porch with blue siding. Ward stated that he gave Rankin eighty dollars (\$80) for a "bun" (bundle - ten (10) stamp bags of heroin).

Rankin exited the vehicle and went to the door of the residence. The Defendant answered the door. Rankin entered the residence with the Defendant and exited approximately four minutes later. Once Rankin returned to the vehicle he handed Ward ten (10) plain blue stamp bags of heroin.

Ward returned to the address listed supra. Ward had been living with the Victim for approximately two (2) weeks at this address. Ward then gave the Victim the stamp bags of heroin. Ward stated that he told the Victim what he purchased was strong and could've been pure Fentanyl. Ward relayed that the Victim proceeded to snort the contents of one whole stamp bag. Later, Ward and the Victim split one stamp bag and went to sleep for the night. Ward woke up to use the bathroom and noticed that the Victim had not moved. Ward yelled at the Victim to wake up, but she did not. Ward then rolled over the Victim and noticed her lips were blue. 911 was contacted and CPR was preformed until EMS personnel arrived on scene.

On December 6, 2017 the Autopsy Report, Toxicology Report, and Final Pathological Diagnosis was received for the Victim. The Victim's cause of death was combined drug toxicity of Synthetic Morphine (Fentanyl), Morphine, Buprenorphine, and Benadryl.

On March 13, 2018 Ward was provided a photo lineup of eight individuals and he identified Chaz Franklin Rankin as the man he knew to be Chaz. On March 22, 2018, Rankin was interviewed. Rankin stated that in early August of 2017 he took Ward to the Defendant's residence

in Brownsville, Pennsylvania to purchase heroin. Rankin was shown a photograph of 415 Hummel Street, Brownsville, Pennsylvania, Fayette County, and positively identified that as the Defendant's residence. 415 Hummel Street is a two (2) story residence with a covered porch and blue siding.

Rankin stated that on the day in question he was provided money from Ward. Rankin gave that money to the Defendant and the Defendant gave Rankin stamp bags of heroin. Rankin then gave those stamp bags of heroin to Ward.

The Redstone Township Police searched the Defendant incident to his arrest. The police did not find any inculpatory evidence against the Defendant.

The Defendant was interviewed after his arrest at the Uniontown State Police Barracks. The Defendant signed a Miranda right waiver on April 3, 2018 at 1633 hours. The Defendant relayed that Rankin was his cousin, he did not know the last time he saw Rankin and that he does not sell heroin.

DISCUSSION

18 Pa.C.S. § 2506 provides Pennsylvania's general principles of justification for the use of deadly force. The statute provides in relevant part:

(a) Offense defined.--A person commits a felony of the first degree if the person intentionally administers, dispenses, delivers, gives, prescribes, sells or distributes any controlled substance or counterfeit controlled substance in violation of section 13(a)(14) or (30) of the act of April 14, 1972 (P.L. 233, No. 64),1 known as The Controlled Substance, Drug, Device and Cosmetic Act, and another person dies as a result of using the substance.

18 Pa.C.S. § 2506.

In this case, there are two (2) witness statements that the Defendant sold heroin to Rankin and said heroin was delivered to the Victim. The Victim died. The Victim's cause of death was due to combined drug toxicity. The Commonwealth has presented sufficient evidence to support a prima facie case for the charge of drug delivery resulting in death.

There was no physical evidence recovered when the Defendant was lawfully searched incident to his arrest. The Defendant's Motion to suppress evidence is denied.

The Defendant signed a valid Miranda waiver. He did not make any inculpatory statements while in custody. Any statements that the Defendant made will not be suppressed.

Therefore, the Court enters the following:

AND NOW, this 14th day of November 2018, upon review the Motion to Suppress Evidence, Motion to Suppress Statements, and Motion to Dismiss the charge of Drug Delivery Resulting in Death, prepared on behalf of Matthew Joseph Brumley, the Court HEREBY DENIES the Motion in its entirety.
