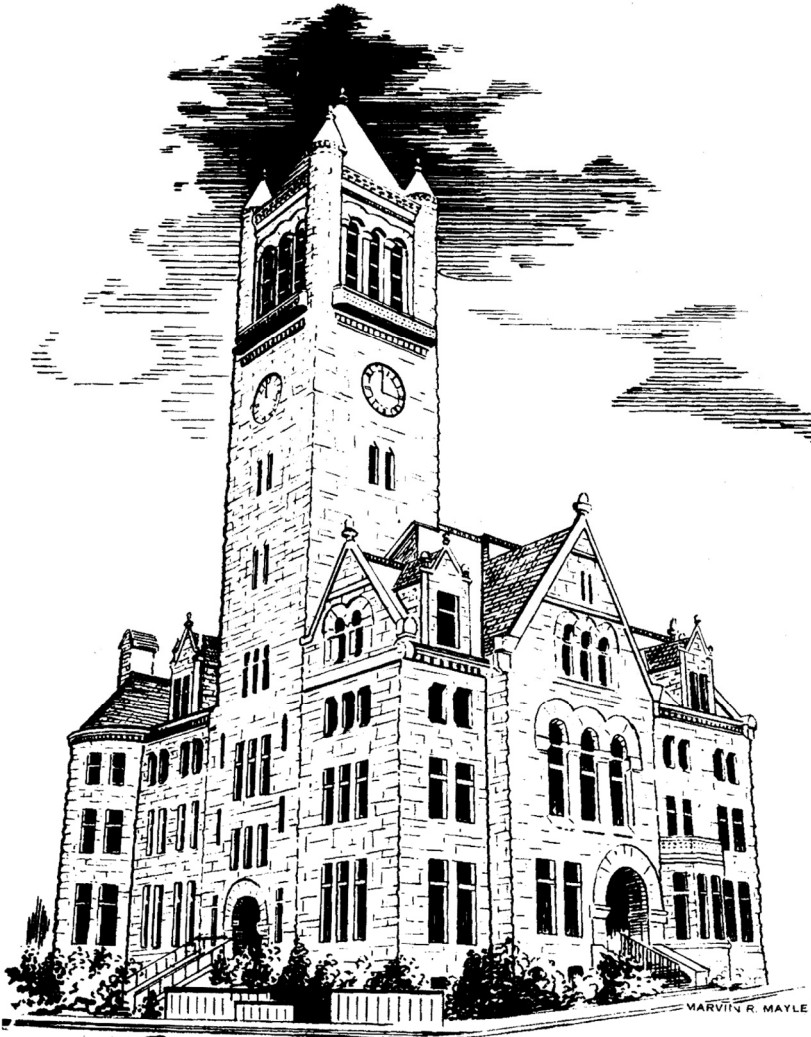

OPINION AND ORDER

LESKINEN, J.

April 21, 2022

AND NOW, this 21st day of April, 2022, upon review of the appropriateness of the denial of bail by the Magisterial District Judge on November 21, 2021, this Court hereby finds that there is a "presumption great" and "proof evident" that "no condition or combination of conditions other than imprisonment will reasonably assure the safety of any person in the community." Accordingly, the Court will set no Bond amount.

The general rule is that the Commonwealth has the burden of proving that a Defendant should be denied pre-trial bail. Commonwealth v. Heiser, 330 Pa. Super. 70 (Pa. Super. Ct., 1984); Commonwealth v. Truesdale, 449 Pa. 325, 296 A. 2d 829 (1972).

Article 1, Section 14 of the Pennsylvania Constitution is entitled "Prisoners to be bailable; habeas corpus." This section provides that:

All prisoners shall be bailable by sufficient sureties, unless for capital offenses or for offenses for which the maximum sentence is life imprisonment or unless no condition or combination of conditions other than imprisonment will reasonably assure the safety of any person in the community when the proof is evident or presumption great...

Pa. Const. Art. 1, §§14. (emphasis added)

Defendant is alleged to have used a loaded pistol to strike his former girlfriend, Autumn Kline, multiple times through the night, at least once while sitting on her chest, and making multiple threats to kill her. He is not charged with strangulation, but he held her tightly with one hand around her neck while striking her with the other hand. According to the Preliminary Hearing transcript, he said he had "gone too far," and he was going to kill her and then kill himself. He is not charged with kidnapping or unlawful restraint, but according to the Transcript, he attempted to confine her overnight in their bed. However, when the seven-month- old baby cried, he allowed her to attend to that child, and she was able to gather all four children and slip away while he went back to sleep. She was so scared that she fled and hid out in a motel for more than five days before she could be interviewed by the Trooper and charges could be filed. She still had

multiple bruises and a large scabbed laceration by her eye. The victim is still so scared of the defendant's threats that she believes that she and her children would not be safe if he was released, according to the victim impact statement submitted to the Court on March 24, 2022. There has been no suggestion as to how the victim and the four children can be kept safely away from the defendant if he was to be released on bond. Under these circumstances, this Court finds that the "proof is evident or presumption great" that there is currently "no condition or combination of conditions other than imprisonment" that "will reasonably assure the safety of any person in the community."

Therefore, this Court enters the following:

ORDER

AND NOW, this 21st day of April, 2022, it is hereby ORDERED and DIRECTED that Bond is hereby DENIED.
