PIKE COUNTY DISTRICT ATTORNEY PRESS RELEASE PIKE COUNTY SENTENCING INFORMATION

October 22, 2020 — Pike County District Attorney Raymond J. Tonkin announced the following criminal sentences were issued by Pike County Court of Common Pleas President Judge Gregory Chelak:

Alex Manuel Ayala, age 19, of Scranton, PA, was sentenced to a fine of \$400.00 for the crime of Possession of a Small Amount of Marihuana. The state police pulled over a vehicle along I-84 in Blooming Grove Township on February 9, 2020, which was traveling in the passing lane for an extended time when there was no traffic in the right lane. When speaking with the occupants of the vehicle, the trooper detected the smell of Marihuana. Ayala admitted to smoking Marihuana prior to the stop and a consent to search the vehicle revealed Marihuana.

Damian E. Muniz, age 33, of Greeley, PA, was sentenced to 9 months to 23 months in the Pike County Jail, followed by 3 years of probation, fined \$1,500.00 and had his driver's license suspended for a duration to be determined by PennDOT, for the crimes of Accident Resulting in Death or Injury and Driving Under the Influence. The state police were dispatched to Well Road in Blooming Grove Township on January 1, 2020, where Muniz had driven into a tree, injuring his passenger. Muniz then fled the scene of the accident on foot, leaving his passenger behind. When Muniz was located, he admitted to drinking an alcoholic beverage prior to the crash.

Kevin Joseph Leisenheimer, age 26, of Milford, PA, was sentenced to 12 months of probation and fined \$300.00 for the crime of Possession of a Controlled Substance. Leisenheimer was a passenger in a vehicle on September 15, 2019, which was stopped by the state police for a loud muffler and speeding along Milford Road in Delaware Township. A consent to search the vehicle revealed empty glassine packets and bags of Heroin which Leisenheimer reported were his.

Robin A. Woods, age 61, of Montague, NJ, was sentenced to 90 days to 5 years in the Pike County Jail, fined \$1,500.00 and had her driver's license suspended for 18 months for the crime of Driving Under the Influence. Woods was observed driving over a curb and into a stop sign at 6th Street and Harford Street in Milford Borough on September 3, 2019. While speaking with Woods, the officer detected the smell of an alcoholic beverage and observed her to have red, glassy eyes and slurred speech. Woods admitted to consuming alcohol. Field Sobriety Tests showed impairment and a blood test confirmed a blood alcohol content of .294%.

Eric Lee Leger, age 22, of Greeley, PA, was sentenced to 6 months of the IP Program which will include 30 days of house arrest, a fine of \$1,000.00 and a driver's license suspension of 12 months for the crime of Driving Under the Influence of a Controlled or Counterfeit Substance. The state police stopped Leger while traveling along SR 434 with an expired registration on July 5, 2019. Leger was observed to have bloodshot, glassy, watery eyes and was sweating profusely. Leger admitted to ingesting prescribed Methadone and smoking Marihuana. Leger refused a blood test.

Jacob Edward Becker, age 31, of Bushkill, PA, was sentenced to 72 hours to 6 months in the Pike County Jail, fined \$1,000.00 and had his driver's license suspended for 12 months for the crime of Driving Under the Influence. The state police were alerted to Becker

driving a dump truck erratically along SR 402 in Blooming Grove Township on June 11, 2019. When contact was made with Becker, the trooper detected the smell of an alcoholic beverage. Field Sobriety Tests showed impairment and a breath test confirmed a blood alcohol content of .213%.

Nolan Terry Swanson, age 20, of Shohola, PA, was sentenced to 12 months of probation and a fine of \$300.00 for the crime of Theft. The state police were dispatched to I-84 in Dingman Township on January 7, 2019, where an individual was broke down. The individual reported that Swanson was one of two men who had stopped to offer her assistance, but instead took her car keys and personal items with a total value in excess of \$200.00.

Melissa Jean Devito, age 34, of Milford, PA, was sentenced to 12 months of probation and fined \$500.00 for the crime of Access Device Fraud. On November 3, 2019, while an employee at a business in Westfall Township, Devito used an individual's name and identification to obtain a gift card in the amount of \$150.00, without the individual's permission, then used the gift card to make purchases at the business.

Christopher J. Olmeda, age 48, of Hawley, PA, was sentenced to 12 months of probation and fined \$200.00 for the crime of Theft. While working at a business in Palmyra Township between August 16, 2019 and August 22, 2019, Olmeda took \$200.00 from the register without permission of his employer.

Kelly Lynn Hanway, age 43, of Bushkill, PA, was sentenced to 12 months of probation and fined \$300.00 for the crime of Recklessly Endangering Another Person. Hanway was engaged in a physical altercation on October 23, 2019, at a residence in Lehman Township, during which she forced a child to the ground causing the child to have difficulty breathing.

Matthew Targonski, age 52, of Port Jervis, NY, was sentenced to 6 months of probation and fined \$150.00 for the crime of Defiant Trespass. Targonski and an individual were found trespassing on May 8, 2020, at a residence in Westfall Township. Targonski was advised by the Eastern Pike Regional Police two times prior to remove themselves from the residence.

Jenalic Eileen Hernandez, age 19, of Glen Spey, NY, was sentenced to 3 months of probation and fined \$100.00 for the crime of Disorderly Conduct. On November 18, 2019, Hernandez took part in a public disturbance by using her cell phone to record an assault occurring at a hotel in Westfall Township.

Bryan Padilla, age 30, of Drums, PA, was sentenced to a fine of \$400.00 for the crime of Possession of a Small Amount of Marihuana. The state police observed Padilla travel in the left lane of I-84 in Blooming Grove Township on March 2, 2020, for over a mile when there was no traffic in the right lane, and traveled at a slower than posted speed. When contact was made with Padilla, the trooper detected the smell of Marihuana. A probable cause search revealed Marihuana which Padilla said was his.

Sharief Omar Ford, age 26, of Bushkill, PA, was sentenced to a fine of \$300.00 for the crime of Possession of Drug Paraphernalia. The state police stopped Ford on October 12, 2019, for speeding along Myck Road in Delaware Township. Upon speaking with Ford, Ford admitted to the trooper that he was in possession of a Marihuana grinder and provided same to the trooper.


