NOTICE HEREBY IS GIVEN that the Board of Directors of the East Lampeter Sewer Authority (the "Authority"), a Pennsylvania municipality authority having its registered office at 2250 Old Philadelphia Pike, Lancaster, Lancaster County, Pennsylvania, has adopted a resolution proposing a certain amendment to its Articles of Incorporation; the Authority has submitted the proposed amendment to the Board of Supervisors of East Lampeter Township, Lancaster County, Pennsylvania (the "Municipality"), the governing authority of the Municipality composing the Authority; the governing authority of the Municipality, by Resolution duly enacted, has adopted and approved the amendment to the Articles of Incorporation of the Authority; the Authority intends to file Articles of Amendment to its Articles of Incorporation with the Secretary of the Commonwealth of Pennsylvania on December 12, 2019; such Articles of Amendment are to be filed under provisions of the Pennsylvania Municipality Authorities Act, Act 22 of 2001, P.L. 287, 53 Pa. In addition to the powers and project authorizations of the Authority provided for in Ordinance No. 18 of 1970 of the Board of Supervisors of the Township, to wit, ‘exercising and enjoying all powers capable of being exercised by the municipal authority’ and undertaking project(s) [t]o acquire, hold, construct, improve, maintain, operate, own and lease, either in the capacity of lessor or lessee, sewers, sewer systems, interceptor lines, sewage treatment works and works for the treatment and disposal of industrial waste,’ the Authority is authorized to acquire, hold, construct, improve, maintain, operate, and own storm water systems or parts thereof including the planning, management and implementation of storm water systems.”
