#### Rosado vs. Penndot

Petition for leave to appeal *nunc pro tunc* – Suspension of operating privilege – Credibility – Concise matters complained of on appeal - Waiver

- 1. In order to be granted leave to appeal *nunc pro tunc*, a licensee has the burden to prove that his delay in filing his appeal was caused by fraud or a breakdown in the administrative process. Proof of extraordinary circumstances has been considered to be an adequate basis for meeting this requirement, including relevant non-negligent circumstances.
- 2. If a petitioner's testimony lacks credibility, it cannot be the basis of proving anything and is a fatal defect when petitioner has the burden of proof.
- Issues not included in a concise statement of matters complained of on appeal are waived.
- 4. A concise statement which is too vague to allow the court to identify the issues raised on appeal is the functional equivalent of no concise statement at all.
- 5. Before the Commonwealth Court considers the merits of a petitioner's case, it first must determine whether the petitioner preserved any issues for appellate review.
- 6. Even if the trial court correctly guesses the issues Appellant raises on appeal and writes an opinion pursuant to that supposition, the issues are still waived.
- 7. Petitioner filed a petition for leave to appeal *nunc pro tunc* from the suspension of his operating privileges. He contended the court erred by not permitting him to establish mail addressed to a police station was delivered to his address. Petitioner did not attempt to prove mail addressed to him was delivered to the police station. This Court views Petitioner's Statement of Errors Complained of on Appeal as a textbook example of a statement that preserves no issues for appellate review and suggests the appellate court find petitioner preserved no issues or, if any issues were preserved, they are deemed without merit and Petitioner's appeal should be denied.

#### OPINION

Petitioner has filed an appeal from our order of November 19, 2020, wherein we denied petitioner's petition for leave to appeal *nunc pro tunc* from the suspension of his operating privileges by the Pennsylvania Department of Transportation. Pursuant to Pa.R.A.P. No. 1925(a), we herewith file this opinion stating the reasons why we believe petitioner has preserved no issue for appeal and also setting forth the reasons for our order.

Following the filing of the appeal, petitioner/appellant was directed to file a concise statement of the errors complained of on appeal and has done so although, for the reasons set forth below, we believe that the statement does not preserve any issues for appeal.

On or about September 11, 2020, petitioner appears to have filed a petition for leave to appeal *nunc pro tunc* from the action of the Pennsylvania Department of Transportation suspending his operating privileges. A hearing on the petition was held on November 19, 2020, following which we entered an order denying the petition. On December 8, 2020, petitioner filed an appeal to the Superior Court which appeal was transferred to the Commonwealth Court. The appeal appears to have been docketed on the Commonwealth Court docket on or about April 15, 2021, and notice of that docketing appears to have been sent by the Commonwealth Court on June 14, 2021. On February 3, 2021, petitioner was ordered to file a concise statement of matters complained of on appeal. On February 12, 2021, petitioner moved for additional time to file the statement which motion was denied without prejudice to the right of petitioner to later request leave to supplement his concise statement when he was able to identify such additional issues as he might wish to pursue. No further request was made and on February 22, 2021, petitioner filed a document entitled "Sui-Juris Statement of Errors

Complained of on Appeal Pursuant Pa.R.A.P. No. 1925 (b).(1)."

Traditionally, "in order to be granted leave to appeal nunc pro tunc, Licensee has the burden to prove that his delay in filing his appeal was caused by fraud or a breakdown in the administrative process." Anderson v. Commonwealth of Pennsylvania., Department of Transportation, Bureau of Driver Licensing, 744 A.2d 825, 827 (Pa. Commw. Ct. 2000). More recently, proof of extraordinary circumstances has been considered to be an adequate basis for meeting this requirement, including relevant non-negligent circumstances. Simply put, petitioner did not prove any of the matters which it was his burden to prove if he were going to be permitted to file a license suspension appeal nunc pro tunc. Keeping in mind the issues before the trial court, only one of the errors complained of even comes close to being relevant to this appeal, namely number 5, in which petitioner contends that we erred by not permitting him to establish that mail addressed to a police station is delivered to his address. Petitioner did not prove -- and did not even attempt or offer to prove - that mail addressed to him was delivered to the police station. In any event, petitioner's testimony was so lacking in credibility that it could not be the basis of proving anything, a fatal defect when petitioner has the burden of proof.

Even the most cursory review of the other issues raised by petitioner demonstrates that none of them preserves for appeal any issue relevant to **this** case. (For the most part, petitioner's issues appear to be related to some other entirely different case.) Petitioner claims that he was denied the right to be heard on various issues and that he was denied "procedural due process." The transcript of the hearing adequately debunks these claims. Petitioner claims, *inter alia*, that he was denied the right to introduce evidence regarding "the alleged Chemical Test Refusal," and various other barely coherent claims that do not appear to have anything at all to do with the issues that were before the court.

"Pennsylvania Rule of Appellate Procedure 1925 provides, in relevant part, that, 'Issues not included in [a concise statement] ... are waived.' Pa.R.A.P.1925(b)(4) (vii). As this Court recently explained:

Rule 1925 is intended to aid trial judges in identifying and focusing upon those issues which the parties plan to raise on appeal. Rule 1925 is thus a crucial component of the appellate process. When a court has to guess what issues an appellant is appealing, that is not enough for meaningful review. When an appellant fails [to] adequately [] identify in a concise manner the issues sought to be pursued on appeal, the trial court is impeded in its preparation of a legal analysis which is pertinent to those issues. In other words, a [c]oncise [s]tatement which is too vague to allow the court to identify the issues raised on appeal is the functional equivalent of no [c]oncise [s]tatement at all.

Commonwealth v. Ray, 134 A.3d 1109, 1114 (Pa.Super.2016) (citation omitted)." Barnes v. Alcoa, Inc., 2016 PA Super 178, 145 A.3d 730, 734 (2016).

Before the Commonwealth Court considers the merits of petitioner's case, it first must determine whether petitioner has preserved any issues for appellate review.

An appellant's concise statement must identify the errors with sufficient specificity for the trial court to identify and address the issues the appellant wishes to raise on appeal. See Pa.R.A.P. 1925(b)(4)(ii) (requiring a Rule 1925(b) statement to 'concisely identify each ruling or error that the appellant intends to challenge with sufficient detail to identify all pertinent issues for the judge'). This Court explained in Riley v. Foley, 783 A.2d 807, 813 (Pa.Super. 2001), that Pa.R.A.P. 1925 is a crucial component of the appellate process because it allows the trial court to identify and focus on those issues the parties plan to raise on appeal. We further determined that 'a Concise Statement which is too vague to allow the court to identify the issues raised on appeal is the functional equivalent to no Concise Statement at all.' Commonwealth v. Dowling, 778 A.2d 683, 686-87 (Pa.Super. 2001). 'Even if the trial court correctly guesses the issues Appellant[] raise[s] on appeal and writes an opinion pursuant to that supposition the issues are still waived.' Kanter v. Epstein, 866 A.2d 394, 400 (Pa.Super. 2004) (citation omitted, appeal denied, 584 Pa. 678, 880 A.2d 1239 (2005), cert. denied, Spector, Gadon & Rosen, P.C. v. Kanter, 546 U.S. 1092, 126 S.Ct. 1048, 163 L.Ed.2d 858 (2006)).

Satiro v. Maninno, 2020 PA Super 185, 237 A.3d 1145, 1150 (2020)

In our view, petitioner's Statement of Errors Complained of on appeal is a textbook example of a statement that preserves no issues for appellate review.

For the foregoing reasons, we respectfully suggest that it be found that petitioner has preserved no issues for appellate review or, if any issues are found to have been preserved, that they are without merit and that petitioner's appeal should be denied.
