OPINION BY: ASHWORTH, P.J., APRIL 19, 2022. Before the Court is the *pro se* petition of Tracy Lee Hodges, filed pursuant to the Post Conviction Collateral Relief Act, 42 Pa.C.S.A. §§ 9541-9546 (PCRA). For the reasons set forth below, this petition will be dismissed and denied without a hearing.<sup>1</sup>

#### I. BACKGROUND

The background relevant to this matter can be succinctly summarized as follows:<sup>2</sup>

In May of 2018, Hodges timely filed his first pro se PCRA petition (2018 PCRA). The Court appointed counsel and allowed an amended petition with supplemental briefing by Hodges and the Commonwealth. After an evidentiary hearing, the Court denied the 2018 PCRA on its merits by Opinion and Order of January 16, 2019. Hodges did not appeal. Subsequently, Hodges filed a pro se PCRA petition (2020 PCRA) alleging ineffective assistance counsel for his 2018 PCRA counsel's failure to notify him of the Court's denial of the 2018 PCRA and his right to appeal said denial. With the agreement of the Commonwealth, the Court reinstated Hodges' right to appeal the denial of the 2018 PCRA, nunc pro tunc, and pursuant to Rule 904(A) of the Pennsylvania Rules of Criminal Procedure, appointed new counsel, Stephen W. Grosh, Esquire (appellate counsel). Appellate counsel properly filed a timely notice of appeal on March 26, 2020. After close review of the matters of record, however, appellate counsel concluded there were no issues of merit to be raised on appeal. Accordingly, he filed an Anders/McClendon<sup>3</sup> statement in lieu of a statement of errors pursuant to Pa. R.C.P. 1925(b), along with a motion to withdraw as counsel. After conducting its own review of the matters of record, the Superior Court agreed that Hodges had no issues of merit to raise regarding the denial of the 2018 PCRA and granted appellate counsel leave to withdraw. By Memorandum Opinion of June 7, 2021, the Superior Court affirmed the 2018 PCRA

denial. See Commonwealth v. Hodges, 258 A.3d 498 (Table), (Pa. Super. 2021); see also Commonwealth v. Hodges, No. 604 MDA 2020, 2021 WL 2312762 (Memo. Op.) (Pa. Super. 2021).

On July 26, 2021, Hodges sent a letter to the undersigned, complaining of several alleged trial court errors associated with his negotiated guilty plea of September 29, 2017. The Court deemed this a new PCRA petition (original 2021 PCRA) that was untimely filed and failed to meet the requirements for an exception to the timeliness bar. Therefore, on August 19, 2021, the Court notified Hodges pursuant to Pa. R.Crim.P 907 of its intent to dismiss the original 2021 PCRA without appointment of counsel and without a hearing. On December 7, 2021, Hodges filed another *pro se* pleading that the Court treats as an amended petition to the 2021 PCRA (amended 2021 PCRA), which was filed in response to the Court's 907 Notice.

## II. DISCUSSION A. Original 2021 PCRA

Before the Court may address the merits of Hodges' arguments in the original 2021 PCRA, we must first consider the timeliness of that petition because it implicates the jurisdiction of the Court. Commonwealth v. Davis, 86 A.3d 883, 887 (Pa. Super. 2014). Hodges' PCRA petitions are governed by 42 Pa.C.S.A. § 9545(b)(1), which provides that any PCRA petition, including a second or subsequent one, normally must be filed within one year of the date on which the judgment of sentence becomes final. This time restriction is "jurisdictional in nature." Commonwealth v. Albrecht, 606 Pa. 64, 67, 994 A.2d 1091, 1093 (2010) (citation omitted). Pennsylvania law makes clear that when "a PCRA petition is untimely, neither [the Superior] Court nor the trial court has jurisdiction over the petition." Commonwealth v. Seskey, 86 A.3d 237, 241 (Pa. Super. 2014) (citation omitted). "[Jurisdictional time] limitations are mandatory and interpreted literally; thus, a court has no authority to extend filing periods except as the statute permits." Commonwealth v. Jackson, 30 A.3d 516, 519 (Pa. Super. 2011) (quoting Commonwealth v. Fahy, 558 Pa. Super. 313, 329, 737 A.2d 214, 222 (1999)). "Without jurisdiction, [the courts] simply do not have the legal authority to address the substantive claims." Seskey, supra.

For purposes of the PCRA, a judgment of sentence becomes final at the conclusion of direct review, including discretionary review in the Supreme Court of Pennsylvania and the Supreme Court of the United States, or at the expiration of the time for seeking such review if none is sought. 42 Pa.C.S.A. § 9545(b)(3). See also Commonwealth v. Jones, 54 A.3d 14, 17 (Pa. Super. 2012). A petitioner who seeks review in the Superior Court has 30 days to do so after the sentence is entered. See Pa.R.A.P. 903(a). Hodges was sentenced on the underlying charges on September 29, 2017, and he filed neither a post-sentence motion nor an appeal. Therefore, his judgment of sentence became final for PCRA purposes 30 days after the date of sentence, when his time for seeking review with the Superior Court expired – on or about October 29, 2017. 42 Pa.C.S.A. § 9545(b)(3). Accordingly, Hodges had one year

from that date within which to file any PCRA petition, both his first and any subsequent petition. The original 2021 Petition was filed on July 26, 2021, well after the October 29, 2017 deadline, rendering it untimely unless Hodges is able to plead and prove the applicability of one of the three statutory exceptions enumerated at Section 9545(b)(1)(i-iii) of the PCRA.<sup>4</sup> Commonwealth v. Lawson, 90 A.3d 1, 5 (Pa. Super. 2014); Commonwealth v. Ketchmar, 971 A.2d 1249, 1251 (Pa. Super. 2009). PCRA section 545(b)(1) permits consideration of the merits of a facially untimely PCRA petition only where:

- (i) the failure to raise the claim previously was the result of interference by government officials with the presentation of the claim in violation of the Constitution or laws of this Commonwealth or the Constitution or laws of the United States;
- (ii) the facts upon which the claim is predicated were unknown to the petitioner and could not have been ascertained by the exercise of due diligence; or
- (iii) the right asserted is a constitutional right that was recognized by the Supreme Court of the United States or the Supreme Court of Pennsylvania after the time period provided in this section and has been held by that court to apply retroactively.

42 Pa.C.S.A. § 9545(b)(1)(i-iii). Moreover, any petition invoking one or more of these timeliness exceptions must be filed within one year from the date the claim *could have* been presented. *Id.* at § 9545(b)(2)

Hodges simply fails to plead and prove any of these exceptions *vis-à-vis* the original 2021 PCRA. He does not provide a single fact or item of evidence to show either: (1) that governmental obstruction prevented him from bringing these claims earlier; (2) that new evidence has been discovered that was unknown to the petitioner and could not have been ascertained by the exercise of due diligence; or (3) that since the expiration of his time for filing a timely PCRA, the Supreme Court of the United States has recognized a specific, new constitutional right that applies to has been held to apply retroactively.

Moreover, the first four issues Hodges raises in the original 2021 PCRA concern additional allegations that guilty plea counsel was ineffective. Hodges could and should have raised such issues within the 2018 PCRA, but he did not and those issues are now waived. See 42 Pa.C.S.A. § 9544(a)(3) (petitioner must plead and prove that his claim

has not been previously litigated or waived); 42 Pa.C.S.A. § 9544(b) ("... an issue is waived if the petitioner could have raised it but failed to do so before trial, at trial, during unitary review, on appeal or in a prior state postconviction proceeding"). Issues five through nine in the original 2021 PCRA all contain allegations of trial court error during the guilty plea process. Again, not only are these issues untimely, they are also waived as Hodges could and should have raised them through a direct appeal from his judgment of sentence; he did not. Issue ten of the original 2021 PCRA is moot as it was raised within the 2020 PCRA and remedied by this Court. See Opinion and Order of March 12, 2020 (reinstating Hodges' right to appeal nunc pro tunc).

#### B. Amended 2021 PCRA

With regard to the amended 2021 PCRA, Hodges largely repeats allegations from his original 2021 PCRA, which are untimely and/or waived. However, the amended 2021 PCRA does contain a new allegation that Hodges' court-appointed PCRA appellate counsel provided ineffective assistance during the appeal of the 2018 PCRA. Specifically, Hodges alleges that PCRA appellate counsel rendered ineffective assistance by filing an <code>Anders/McClendon/Santiago</code> brief in lieu of an advocate's brief or statement of matters complained of an appeal, pursuant to Rule 1925(b) of the Pennsylvania Rules of Appellate Procedure.

A petitioner seeking post-conviction collateral relief under the PCRA is not only entitled to counsel but to effective counsel in pursuing such claims. See Commonwealth v. Albert, 522 Pa. 331, 561 A.2d 736, 738 (1989) (rule-based right to counsel in a PCRA includes "concomitant right to effective assistance of counsel" in the PCRA court); see also Commonwealth v. Albrecht, 554 Pa. 31, 720 A.2d 693, 699-700 (1998) (appointment of counsel pursuant for first PCRA also provides an enforceable right to effective PCRA counsel). Notably, our Supreme Court has recently affirmed that "[t]he guidance and representation of an attorney during collateral review ensures that meritorious legal issues are recognized and addressed, and that meritless claims are abandoned." Commonwealth v. Bradley, 261 A.3d 381, 391-92 (2021). In Bradley, our Supreme Court addressed the procedural difficulties defendants encounter when attempting to raise claims for ineffective assistance of PCRA counsel. The Supreme Court concluded that a PCRA petitioner may, after a PCRA court denies relief, and after obtaining new counsel or acting pro se, raise claims of PCRA counsel's ineffectiveness at the first opportunity to do so, even if on appeal. Id.

The instant case stands in an unusual procedural posture since Hodges' complaint is specifically with PCRA *appellate* counsel, who happens to be the second counsel court-appointed to represent him in connection with the 2018 PCRA.<sup>5</sup> Hodges claims that his appellate counsel rendered ineffective assistance in pursuing Hodges' appeal of the 2018 PCRA denial. Technically, Hodges' very first opportunity to raise such a claim would have been in a petition for appeal to the Supreme Court of Pennsylvania from the Superior Court's decision of June 7, 2021,

which granted PCRA appellate counsel's motion to withdraw and affirmed this Court's denial of the 2018 PCRA. Nonetheless, since the *Bradley* Court utilizes permissive language to describe the procedure for raising ineffective assistance of PCRA counsel claims, Hodges' failure to file a petition for appeal on this issue is not fatal, and the Court finds the issue was properly raised in response to the Court's 907 Notice of August 19, 2021. Therefore, we will address the merits of Hodges' claim that his court-appointed PCRA appellate counsel rendered ineffective assistance.

In order to prevail on a claim of ineffective assistance of counsel made in the post conviction context, a petitioner must overcome the presumption that counsel is effective, establishing by a preponderance of the evidence that: the underlying claim has arguable merit; trial counsel had no reasonable basis for proceeding as he did; and the defendant suffered prejudice. See 42 Pa. C.S.A. § 9543(a)(2)(ii); Spotz, 616 Pa. at 187, 47 A.3d at 76 (citing Commonwealth v. Pierce, 515 Pa. 153, 158-59, 527 A.2d 973, 975-76 (1987)). The petitioner has the burden of establishing counsel's ineffectiveness because counsel is presumptively effective. *Id.* 

With respect to whether counsel's acts or omission were reasonable, counsel is accorded broad discretion to determine tactics and strategy. Commonwealth v. Fowler, 447 Pa. Super. 534, 670 A.2d 1153 (1996), aff'd 550 Pa. 152, 703 A.2d 1027 (1997). The applicable test is not whether alternative strategies were more reasonable, employing a "hind-sight" evaluation of the record, but whether counsel's decision had any reasonable basis to advance the interests of the defendant. Commonwealth v. Chmiel, 612 Pa. 333, 361, 30 A.3d 1111, 1127 (2011). The appellate courts will conclude that counsel's chosen strategy lacked a reasonable basis only if the petitioner proves that "an alternative not chosen offered a potential for success substantially greater than the course actually pursued." Commonwealth v. Williams, 587 Pa. 304, 312, 899 A.2d 1060, 1064 (2006) (citation omitted).

To establish the prejudice prong, the petitioner must show that there is a reasonable probability that the outcome of the proceedings would have been different but for counsel's ineffectiveness. *Commonwealth v. Chmiel*, 30 A.3d 1111, 1127-28 (2011). "We stress that boilerplate allegations and bald assertions of no reasonable basis and/or ensuing prejudice cannot satisfy a defendant's burden to prove that counsel was ineffective." *Id.* (quoting Commonwealth v. Paddy, 609 Pa. 272, 292, 15 A.3d 431, 443 (2011)). Hodges alleges here that PCRA appellate counsel was ineffective for filing a statement of intent to file an *Anders/McClendon/Santiago* brief in lieu of a Rule 1925(b) concise statement pursuant to Pa. R.A.P. 1925(c)(4). He argues that counsel was ineffective for failing to find and raise non-frivolous matters on appeal of the 2018 PCRA petition's denial. After careful review, this Court finds Hodges' claim to be meritless.

Rule 1925 states, in pertinent part: "In a criminal case, counsel may file of record and serve on the judge a statement of intent to file an *Anders/McClendon* brief in lieu of filing a Statement. . . ." Pa. R.A.P.

1925(c)(4). The official note to subsection (c)(4) provides the following:

This paragraph clarifies the special expectations and duties of a criminal lawyer. Even lawyers seeking to withdraw pursuant to the procedures set forth in Anders v. California, 386 U.S. 738, 87 S.Ct. 1396, 18 L.Ed.2d 493 (1967) and Commonwealth v. McClendon, 495 Pa. 467, 434 A.2d 1185 (1981) are obligated to comply with all rules, including the filing of a Statement. . . . However, because a lawyer will not file an Anders/McClendon brief without concluding that there are no non-frivolous issues to raise on appeal, this amendment allows a lawver to file, in lieu of a Statement, a representation that no errors have been raised because the lawyer is (or intends to be) seeking to withdraw under Anders/Mc-Clendon. At that point, the appellate court will reverse or remand for a supplemental Statement and/or opinion if it finds potentially non-frivolous issues during its constitutionally required review of the record.

Official Note to Subsection (c)(4) of Pa. R.A.P. 1925.

In this case, prior to conducting its independent review of the record, the Superior Court first addressed PCRA appellate counsel's motion to withdraw. The Superior Court noted that PCRA appellate counsel applied for withdrawal under <code>Anderson/McClendon</code>, but that "Anders applies to counsel who seeks to withdraw from representation on direct appeal. Anders imposes stricter requirements than those imposed when counsel seeks to withdraw during the post-conviction process pursuant to the dictates of <code>Commonwealth v. Turner</code>, 544 A.2d 927 (Pa. 1988), and <code>Commonwealth v. Finley</code>, 550 A.2d 213 (Pa. Super. 1988) (en banc). See <code>Commonwealth v. Fusselman</code>, 866 A.2d 1109, 1111 n.3 (Pa. Super. 2004)." <code>Hodges</code>, 258 A.3d at n.1. Therefore, the Superior Court reviewed whether counsel had complied with the mandates of <code>Finley/Turner</code> such that withdrawal was appropriate. The Superior Court found that PCRA appellate counsel and this trial court did substantially comply with the following requirements:

- 1. A 'no merit' letter by PCRA counsel detailing the nature and extent of his review;
- 2. The 'no merit letter' by PCRA counsel listing each issue the petitioner wished to have reviewed;
- 3. The PCRA counsel's explanation in the 'no merit letter', of why the petitioner's issues were meritless:
- 4. The PCRA court conducting its own independent review of the record; and
- 5. The PCRA court agreeing with counsel that the petition was meritless.

Hodges, 258 A.3d at \*2 (citations, brackets, and quotations omitted).

Additionally, the Superior Court found that appellate counsel substantially complied with the requirement that any PCRA counsel moving to withdraw at the appellate level must forward the petitioner notification that "petitioner has the immediate right to proceed *pro se*, or with the assistance of privately retained counsel." *Id.* (citing *Commonwealth v. Muzzy*, 141 A.2d 509, 511-512 (Pa. Super. 2016). The record supports the Superior Court's finding. Indeed, even Hodges himself acknowledges receipt of appellate counsel's letter notifying him of this information; Hodges attached a copy of the same to his letter to the undersigned dated January 7, 2021 (stamped and docketed by the Clerk of Courts on January 12, 2021). Hodges' failure to act upon this notification of rights is entirely his own.<sup>6</sup>

Moreover, in light of appellate counsel's assertion that there were no meritorious issues to be raised from the denial of the 2018 PCRA, the Superior Court executed its mandatory duties under *Turner/Finley* and undertook to "independently review [Hodges'] ineffectiveness [of trial counsel] claims to ascertain whether it entitles him to relief." *Id.* In so doing, the Superior Court concluded that "because Hodges' claim of ineffectiveness regarding the entry of his guilty plea is refuted by the record and otherwise meritless, we affirm the PCRA court's order denying him post-conviction relief." *Id.* at \*4. Having reviewed Hodges' entire record yet again, the undersigned stands in full agreement with the opinion of the Superior Court for the reasons detailed in this Court's Opinion of January 16, 2019.

#### III. CONCLUSION

For the foregoing reasons, Tracy Lee Hodges' *pro se* original 2021 PCRA petition is untimely, with no applicable exceptions, and must be dismissed without further proceedings. The amended 2021 PCRA petition lacks merit and should be denied.

Accordingly, I enter the following:

The Court notes that Petitioner's letter of January 7, 2021, seeking copies of transcripts and records, was sent some eight weeks after PCRA appellate counsel's notification of rights letter dated November 20, 2020. In the Court's responsive Order of January 21, 2021, the Court denied Hodges' request and directed him to seek any information he required from his court-appointed counsel. At the time of Hodges' request for transcripts, the Superior Court had not yet granted PCRA appellate counsel's motion for withdrawal. Copying PCRA appellate counsel on its Order, the Court cautioned counsel that he should "continue to zealously execute his duties to [Hodges] as court-appointed counsel." Nothing in the record indicates that Hodges followed the Court's advice and contacted his attorney.

#### ORDER

AND NOW, this 19th day of April, 2022, upon consideration of petitioner Tracy Lee Hodges' original *pro se* petition for post-conviction collateral relief, filed July 26, 2021, and amended *pro se* petition for post-conviction collateral relief, filed December 7, 2021, it is hereby ORDERED that said original petition is DISMISSED and said amended petition is DENIED without a hearing. The original petition is untimely filed under the Post Conviction Collateral Relief Act (PCRA), 42 Pa.C.S.A. §§ 9541-9546, and Petitioner fails to plead and prove any of the applicable exceptions under the PCRA. Therefore, the Court lacks jurisdiction to rule on the merits, and no purpose would be served by further proceedings.

Further, the Superior Court of Pennsylvania states that PCRA appellate counsel, Stephen W. Grosh, Esquire, substantially complied with his duties to Petitioner and that Petitioner's appeal of his 2018 PCRA was lacking in merit as a matter of law, a conclusion with which the Court agrees after its independent review of the record.

Pursuant to Pa. R.Crim.P. 907(4), this Court advises Petitioner that he has the right to appeal from this Order. Petitioner shall have **30 days** from the date of this final Order to appeal to the Superior Court of Pennsylvania. Failure to appeal within 30 days will result in the loss of appellate rights.

It is further ORDERED that Petitioner shall have the right, if indigent, to appeal *in forma pauperis*.
