

The Administrative Office of York County Courts is currently accepting applicants interested in taking PCRA appointments on a per-case, billable-hour basis.

Currently the hourly rates are \$85 for non-homicide, \$115 for noncapital homicide, and \$125 for capital homicide. Effective January 1, 2021 the non-homicide hourly rate will increase to \$115, matching the non-capital homicide rate. This is only for PCRA appointments, not for trial representation.
