MISCELLANEOUS LEGAL NOTICE

NOTICE IS HEREBY GIVEN that pursuant to the authority of the Local Tax Enabling Act (Act of December 31, 1965 P.L. 1257, 53 P.S. 6901 et seq. as amended by P.L. 197, No. 32, July 2, 2008) the Board of Supervisors of West Burlington Township intends to consider adopting an ordinance levying an earned income tax of 1/2%. In the judgment of the West Burlington Township Supervisors, such a tax is necessary to produce additional revenue to fund the general operating expenses of West Burlington Township. The amount of revenue estimated to be derived from the tax is \$12,000 per year.

The Earned Income Tax will impose a one-half percent (1/2%) tax on salaries, wages, commissions, bonuses, incentive payments, fees, tips, and other compensation earned by residents and of those who work in the Township of West Burlington on or after January 1, 2013 and on the net profits earned on the operation of a business, profession, or other activity by those who conduct the business, profession or activity in West Burlington Township on or after that date. The ordinance will require the filing of returns, providing information by employers and those subject to the tax.

The ordinance will be considered for adoption at a meeting of the West Burlington Township Supervisors scheduled for January 28, 2013 at 7:00 P.M. at the Township Building. Any person with a disability requiring special accommodation to attend the meeting of the Board of Supervisors should notify the Township Secretary at (570) 297-0773 as soon as possible but no later than three (3) business days prior to the meeting. West Burlington Township will make every effort to provide reasonable accommodations.
