

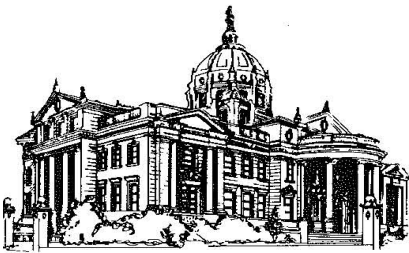

1. Distribute copies of the adopted local rules to the Legislative Reference Bureau for publication in the *Pennsylvania Bulletin*;
2. File one (1) copy with the Administrative Office of Pennsylvania Courts;
3. Publish the local rules on the Court's website within thirty (30) days of the effective date; and
4. Cause a copy hereof to be published in the Washington County' Reports once a week for two successive weeks at the expense of the County of Washington.

Rule L-120. DEFINITIONS. CLERK OF COURTS

The Juvenile Probation Office is designated as the Clerk of Courts for juvenile delinquency matters. The Juvenile Probation Office shall have the responsibility and function to maintain the official court record and docket set forth in Pennsylvania Rule of Juvenile Procedure 166. The Chief Juvenile Probation Officer shall have the authority to certify records of, and affix the seal of, the Court of Common Pleas of Washington County where the same may be required.
