OPINION AND ORDER

Wagner, P.J. July 20, 2021

Before the Court are the Preliminary Objections to the Plaintiffs' complaint filed by Defendant, Joshua N. Blystone, who objects to the complaint as being legally insufficient to support the allegation that the motor vehicle accident was a result of Defendant's "recklessness."

BACKGROUND

On December 18, 2018, the Plaintiff was traveling eastbound on New Geneva Road and was approaching the intersection of New Geneva Road and Greater Point Marion Road in Fayette County, Pennsylvania. The Defendant was stopped at the intersection in the westbound lane of New Geneva Road. The intersection does not have a turning lane or traffic signal device but there are two solid yellow lines separating the lanes of traffic. The Defendant made a U-turn into the eastbound lane into the pathway of the Plaintiffs vehicle resulting in a collision. The Plaintiff suffered serious injuries to her back and left leg as a result of the collision.

On October 23, 2020, the Plaintiffs commenced this action by filing a Writ of Summons and later filing a Complaint in Civil Action on December 9, 2020. On January 29, 2021,' the Defendant filed Preliminary Objection to Plaintiffs' Complaint.

Pennsylvania Rules of Civil Procedure provide that preliminary objections may be filed by any party to any pleading and may be filed on the following grounds: (2) failure of a pleading to conform to law or rule of court or inclusion of scandalous or impertinent matter; (3) insufficient specificity; (4) legal insufficiency of a pleading. Pa.R.C. P. 1028(a)(2), (3), (4).

In his preliminary objections, the Defendant has filed a motion to strike off the word "reckless" contained in the complaint. The Court must accept as true all well-pleaded material and relevant facts. Mellon Bank N.A. v Fabinyi, 650 A.2d 895 (Pa. Super. 1994). Conclusions of law, unwarranted inferences from the facts, argumentative allegations or expressions of opinion need not be accepted as true. Myers v. Ridge, 712

A.2d 791 (Pa. Cmwlth 1998).

Punitive damages may be awarded for conduct that is outrageous, because of the defendant's reckless indifference to the rights of others. Restatement (Second) of Torts Section 908(a). A defendant acts recklessly when his conduct creates an unreasonable risk of physical harm to another and such risk is substantially greater than that which is necessary to make his conduct negligent. Hutchinson ex rel Hutchinson v. Luddy, 870 A.2d 766 (Pa. 2005). Punitive damages are based on conduct, which is malic io us, wanton, reckless, willful or oppressive.

An essential fact needed to support a claim for punitive damages is that the defendant's conduct be outrageous. Outrageous conduct is defined as an act done with reckless indifference to the interest of others. Baker v. Rangos, 324 A.2d 498 (1974). Reckless indifference to the interest of others is defined as wanton misconduct meaning an intentional act done in disregard of a risk known to him or so obvious that he must be taken to have been aware of this. Focht v. Rabada, 268 A.2d 157 (Pa. Super. 1970). In Focht, it was determined that the act itself and all the circumstances surrounding the act can establish by circumstantial evidence of the Defendant's conscious disregard of the risk of harm that under the circumstances of the case that the defendant's conduct was not only negligent but could also be considered outrageous and was done in conscious disregard of the risk imposed by his actions.

When the Defendant deliberately turned into on-coming traffic who had the right of way at an intersection with no traffic control device or turning lane, his actions could be considered to have been done in disregard of a known risk and therefore reckless. Therefore, the Court will overrule Defendant's Preliminary Objection at this time and enters the following Order

ORDER

AND NOW, this 20th day of July 2021, upon consideration of the Defendant's Preliminary Objection to Plaintiff's Complaint, it is hereby ORDERED and DECREED that the Preliminary Objection is her by OVERRULED.
