REBECCA STRAUSBAUGH VS. MICHAEL STRAUSBAUGH

1. A Decree of Divorce under section 3301 (d) was granted on January 7, 2014, by the Honorable Robert G. Bigham. On December 26, 2018, just short of five years after the entry of the Decree, Husband filed a "Motion to Open Divorce Decree" on the basis that this Court erroneously entered a Decree of Divorce without ruling on Husband's request for economic relief. In support of his contention, Husband noted that the Federal Bureau of Prisons had recently approved correspondence between the parties "to take care of any pending legal matters." On December 28, 2018, the undersigned denied Husband's Motion to Open Divorce Decree.

2. On January 18, 2019, Husband filed a Motion to Reconsider the Denial of Motion to Open Divorce Decree and a Motion to Vacate or Strike Divorce Decree. On January 22, 2019, the undersigned entered an Order denying Husband's Motion to Vacate or Strike Divorce Decree. Husband's Motion to Reconsider the Denial of Motion to Open Divorce Decree was not granted.

3. Husband's Concise Statement of Matters Complained of On Appeal simply states that this Court committed error in denying Husband's Motions, but fails to state any specific rationale therefor.

4. Husband's December 26, 2018 Motion was filed within five years of the issuance of the date of the Decree. However, Husband has failed to asset grounds, which would warrant the opening of the Divorce Decree pursuant to 23 Pa. C.S.A. §3332.

5. In light of these facts, along with Husband's failure to assert fraud or some other extraordinary cause justifying intervention by this Court, the undersigned denied Husband's December 26, 2018 Motion and did not grant reconsideration of that ruling. As Husband's January 18, 2019 Motion was filed outside of the aforementioned five-year time frame required by §3332, it was also denied.

OPINION PURSUANT TO Pa. R.A.P. 1925(a)

Michael Strausbaugh ("Husband") appeals from this Court's Orders dated December 28, 2018 (denying Husband's Motion to Open Divorce Decree) and January 22, 2019 (denying Husband's Motion to Vacate or Strike Divorce Decree). The parties were married on July 5, 2003. Rebecca Strausbaugh ("Wife") filed a Complaint in Divorce under Sections 3301 (c) and (d) of the Pennsylvania Divorce Code on February 7, 2012. 23 Pa. C.S.A. §3301. Husband was personally served with the Complaint on February 14, 2012. Wife filed a Notice of Intention to Request Entry

of Section 3301 (d) Divorce Decree and a blank Counter-Affidavit on November 5, 2013.

On November 22, 2013, Husband filed a Counter-Affidavit, indicating that he opposed the entry of a divorce decree because the parties had not lived separate and apart for a period of at least two years and that the marriage was not irretrievably broken. He also raised claims for economic relief. Attached to Husband's Counter-Affidavit was a narrative-style pleading, in which he referenced, inter alia, the parties' inability to communicate due to their respective incarcerations¹, custody of their minor child, and economic claims regarding the former marital residence and the parties' bank accounts. Specifically, Husband requested 50% of all funds that were withdrawn from the parties' personal and business accounts at Members First Federal Credit Union. Husband further indicated that these accounts were closed sometime after the parties were both incarcerated on March 18, 2011. Husband also requested "100% of all right to 1946 East Berlin Road, New Oxford, Pennsylvania". This property went into foreclosure and was sold at Sheriff's sale in 2013². In addition, Husband cited the parties' date of separation as March 18, 2011, by virtue of their respective incarcerations.

By Order dated November 25, 2013³, this Court addressed the claims raised in Husband's Counter-Affidavit and the attachment thereto. In the same Order, this Court denied Husband's Motion to Dismiss 3301 (d) Divorce Action, Motion for Appointment of Counsel or Paralegal and Motion for Extension of Time to File Brief in Support of Defendant's Counter-Affidavit. This Order directed the parties to follow the applicable Rules of Civil Procedure regarding service of documents and urged them to consult with legal counsel. Wife filed an Amended Praecipe to Transmit Record on November 26, 2013 requesting a 3301 (d) divorce. A Decree of Divorce under

section 3301 (d) was granted on January 7, 2014 by the Honorable Robert G. Bigham.

On December 26, 2018, just short of five years after the entry of the Decree, Husband filed a "Motion to Open Divorce Decree" on the basis that this Court erroneously entered a Decree of Divorce without ruling on Husband's request for economic relief. In support of his contention, Husband noted that the Federal Bureau of Prisons had recently approved correspondence between the parties "to take care of any pending legal matters". On December 28, 2018, the undersigned denied Husband's Motion to Open Divorce Decree.

On January 18, 2019, Husband filed a Motion to Reconsider the Denial of Motion to Open Divorce Decree and a Motion to Vacate or Strike Divorce Decree. On January 22, 2019, the undersigned entered an Order denying Husband's Motion to Vacate or Strike Divorce Decree. Husband's Motion to Reconsider the Denial of Motion to Open Divorce Decree was not granted. On February 5, 2019, Husband filed a Notice of Appeal to the December 28, 2018 Order and the January 22, 2019 Order. This Notice of Appeal was filed 39 days after the December 28, 2018 Order and 14 days after the January 22, 2019 Order. A notice of appeal "shall be filed within 30 days after the entry of the order from which the appeal is taken." *Pa. R.A.P., Rule 903.* Therefore, the undersigned submits that Husband's appeal to the December 28, 2018 Order is not timely.

Husband's Concise Statement of Matters Complained of On Appeal simply states that this Court committed error in denying Husband's Motions, but fails to state any specific rationale therefor. When an appellant fails adequately to identify in a concise manner the issues sought to be pursued on appeal, the trial court is impeded in its preparation of a legal analysis, which is pertinent to those issues. *Com. v. Dowling*, 778 A.2d 683 (Pa. Super. 2001). "Issues not included in the [Concise] Statement and/or not raised in accordance with the provisions of this paragraph (b)(4) are waived." *Pa. R.A.P. Rule 1925 (b)*. It is respectfully submitted that Husband has waived the issues on appeal.

In the alternative, the undersigned respectfully submits that this Court's Orders should be affirmed for the reasons that follow. Generally, petitions to open a divorce decree must be filed within 30 days. *42 Pa. C.S.A. § 5505*. "After this 30-day period, an order can

only be opened or vacated if there is fraud or some other circumstance so grave or compelling as to constitute extraordinary cause justifying intervention by the court." *Justice v. Justice*, 612 A.2d 1354, 1357 (Pa. Super. 1992).

The motion may lie where it is alleged that the decree was procured by intrinsic fraud or that there is new evidence relating to the cause of action, which will sustain the attack upon its validity. A motion to vacate a decree or strike a judgment alleged to be void because of extrinsic fraud, lack of jurisdiction over the subject matter or a fatal defect apparent upon the face of the record must be made within five years after entry of the final decree. Intrinsic fraud relates to a matter adjudicated by the judgment, including perjury and false testimony, whereas extrinsic fraud relates to matters collateral to the judgment which have the consequence of precluding a fair hearing or presentation of one side of the case.

23 Pa. C.S.A. § 3332. Husband's December 26, 2018 Motion was filed within five years of the issuance of the date of the Decree. However, Husband has failed to assert grounds, which would warrant the opening of the Divorce Decree pursuant to 23 Pa. C.S.A. §3332. It should be noted that the only economic issues alluded to by Husband in the attachment to his counter-affidavit concerned the former marital residence, which was lost to foreclosure, and bank accounts that, by his admission, were no longer in existence. The 3301 (d) Counter-Affidavit signed by Husband clearly states that "I understand that in addition to checking (b) above, I must also file all of my economic claims in writing and serve them on the other party. If I fail to do so before the date set forth on the Notice of Intention to Request Divorce Decree, the divorce decree may be entered without further delay." In addition, the two-year date of separation requirement had been met, thus the entry of a Decree was appropriate. In light of these facts, along with Husband's failure to assert fraud or some other extraordinary cause justifying intervention by this Court, the undersigned denied Husband's December 26, 2018 Motion and did not grant reconsideration of that ruling. As Husband's January 18, 2019 Motion was filed outside of the aforementioned five-year time frame required by §3332, it was also denied.

In conclusion, it is respectfully submitted that Husband has waived the issues cited in his concise statement of appeal because it is a vague statement, which impedes this Court's ability to prepare a response to it. It is also submitted that the appeal to the December 28, 2018 Order is not timely, as the Notice of Appeal was not filed within thirty days of that date. Alternatively, it is respectfully requested that this Court's December 28, 2018 Order and January 22, 2019 Order be affirmed for the reasons outlined above.
