OPINION

BY: ASHWORTH, P.J. March 11, 2021

This matter is before the Court on Defendant Cory Cressman’s counseled Post-Sentence Motion to Withdraw Guilty Plea. For the reasons set forth below, said motion will be denied.

I. Background

The Defendant was charged with one count of rape of a child, two counts of indecent assault of a minor less than thirteen years old, two counts of corruption of minors by a defendant greater than eighteen years old, and one count of terroristic threats,<sup>1</sup> all stemming from an incident in January, 2019.

On November 6, 2019, Defendant, represented by counsel, appeared for his preliminary hearing before Magisterial District Judge Edward A. Tobin; however, prior to the start of the hearing, Defendant agreed to waive his preliminary hearing in exchange for the Commonwealth’s agreement to remove the mandatory minimum sentence for the rape of a child charge. Def. Mot. at ¶ 2; Cm.w. Answ. at ¶2. The parties concur that the two child victims were also present at the MDJ’s office, ready and waiting to testify at the preliminary hearing. Def. Mot. at ¶8; Cm.w. Answ. at ¶8.

After discovery was exchanged, the parties engaged in further plea negotiations. Ultimately, defense counsel met with the Defendant via videoconference<sup>2</sup> on December 4, 2020, to discuss the Commonwealth’s “global offer” of a sentence of seven to fifteen years incarceration in exchange for his plea, which the Defendant accepted after consultation. Def. Mot. at ¶5. A guilty plea hearing was scheduled for January 27, 2021. Prior to the hearing, Defendant met with his attorney two

additional times, via telephone on January 6, 2021, and via videoconference on January 21, 2021. *Id.*

During the videoconference of January 21, the Defendant “spoke of pulling his Guilty Plea and remanding the charges to the Preliminary Hearing. He was under the incorrect assumption that the statements of the girls to police were heresay [sic] and not admissible — and therefore could be thrown out at the Preliminary hearing.” Def. Mot. at ¶8. Counsel corrected Defendant’s misunderstanding and reminded Defendant that he had waived his right to a preliminary hearing in exchange for a reduction in sentence. *Id.* at ¶8. After this explanation, Defendant agreed to proceed with the guilty plea. Defendant and counsel discussed the details of the plea, and counsel read aloud and reviewed the plea documents, including the guilty plea colloquy. *Id.* at ¶9.<sup>3</sup> Defendant was able to read and review the documents for himself through a screenshare with his attorney. *Id.*

The Court held the Guilty Plea hearing on January 27, 2021, at which time the Defendant entered a waiver under 42 Pa.C.S.A. §9799.24 in order to proceed to sentencing on that date. After thoroughly explaining the nature of the charges against the Defendant, the rights he was foregoing with the guilty plea, the presumption of innocence, and the possible penalties, the Court accepted Defendant’s guilty plea and sentenced him in accordance with its negotiated terms. Cressman timely filed the instant post-sentence motion on February 5, 2021, and in response to this Court’s order, the Commonwealth responded thereto on February 10, 2021. Of particular note, defense counsel, Cory J. Miller, Esquire, avers that he filed this post-sentence motion to preserve the Defendant’s rights, but against his own legal advice to the Defendant. Def. Mot. at ¶18. Mr. Miller asks in the “wherefore” clause of the motion that he be allowed to withdraw as Defendant’s counsel.

This matter is now ripe for disposition.

## II. Discussion

It has long been required that before a trial court may accept a guilty plea, it must carefully examine the defendant on the record to ensure the plea is entered into knowingly, voluntarily, and intelligently. Pa. R.Crim.P 509(B)(2). As our Superior Court dictates, it is incumbent upon a trial court to ensure the defendant is aware of

(1) the nature of the charges to which he

is pleading guilty; (2) the factual basis for the plea; (3) he is giving up his right to trial by jury; (4) and the presumption of innocence; (5) he is aware of the permissible ranges of sentences and fines possible; and (6) the court is not bound by the terms of the agreement unless the court accepts the plea.

*Commonwealth v. Kpou*, 153 A.2d 1020, 1023 (Pa.Super. 2016) (quoting *Commonwealth v. Prendes*, 97 A.3d 337, 351–54 (Pa.Super. 2014)(internal quotations and citations omitted)). Further, “[a] person who elects to plead guilty is bound by the statement he makes in open court while under oath and he may not later assert grounds for withdrawing the plea which contradict the statements he made at his plea colloquy.” *Commonwealth v. Pollard*, 832 A.2d 517, 523 (Pa.Super. 2003).

When a defendant wishes to withdraw a guilty plea, “a request made [b]efore sentencing ... should be liberally allowed.” *Commonwealth v. Kpou*, 153 A.2d 1020, 1022 (Pa.Super. 2016)(citing *Commonwealth v. Forbes*, 450 Pa. 185, 299 A.2d 268, 271 (1973))(emphasis added). However, when the request to withdraw the guilty plea is made after imposition of sentence, a stricter standard applies. *Id.* at 1023. Once sentence has been imposed, “post-sentence motions for withdrawal are subject to higher scrutiny since courts strive to discourage the entry of guilty pleas as sentencing-testing devices.” *Commonwealth v. Kelly*, 5 A.3d 370, 377 (Pa.Super. 2010), appeal denied, 613 Pa. 643, 32 A.3d 1276 (2011). The Court may grant a post-sentence request “only where necessary to correct a manifest injustice.” *Kpou*, 153 A.2d at 1023 (citing *Commonwealth v. Starr*, 450 Pa. 485, 301 A.2d 592, 595 (1973)). A manifest injustice occurs “when a plea is not tendered knowingly, intelligently, voluntarily, and understandingly.” *Id.* (quoting *Commonwealth v. Gunter*, 565 Pa. 79, 771 A.2d 767, 771 (2001)). The bar for proving a manifest injustice is high. Pennsylvania appellate courts have found even a post-sentence claim of actual innocence to be insufficient to show a manifest injustice that would allow the defendant to withdraw his guilty plea post sentence. See, e.g., *Kpour*, 153 A.2d at 1023 (citing *Commonwealth v. Myers*, 642 A.2d 1103, 1108 (1994)(“[a] defendant’s post-sentence recantation of guilt does not rise to the level of prejudice on the order of manifest injustice sufficient to require that he be permitted to withdraw his plea of guilty.”)).

In the instant case, the Defendant cannot show a “manifest injustice” upon which this Court could permissibly grant his post-sentence request to withdraw the guilty plea. Defendant alleges that he entered the guilty plea upon the belief and upon advice of counsel that he would be allowed to change his mind and withdraw the plea at any time, even after imposition of sentence. Defendant’s counsel, Mr. Miller, avers he made no such statements. Def. Mot. at ¶13-15. Whether Mr. Miller rendered this advice to Defendant or not, however, is immaterial to the question before us because the record as a whole clearly shows that Defendant tendered his plea knowingly, intelligently, voluntarily, and understandingly, and that no manifest injustice will result from denial of his request.

First, during the negotiation and execution of the plea agreement, the Defendant met with his attorney via videoconference or telephone on at least three occasions: December 4, 2020, January 6, 2021, and January 21, 2021. During the phone conference of January 6, 2021, Defendant and his attorney reviewed all documents relevant to the plea agreement and guilty plea, including the Guilty Plea Colloquy, which consists of some 74 paragraphs designed to inform the Defendant of his rights and particularly those rights he would forego upon entering the guilty plea. Counsel read aloud each document in its entirety over the phone. At the conclusion of the phone conference, the Defendant agreed that counsel should sign the necessary plea documents on Defendant’s behalf. Def. Mot. at ¶7. After the phone conference, counsel was contacted by Defendant’s mother, who informed him the Defendant had additional questions regarding his plea. Counsel therefore scheduled the videoconference with Defendant for January 21, 2021. During the videoconference, counsel reviewed for a second time the guilty plea documents, including the Guilty Plea Colloquy. The Defendant also independently reviewed the documents for himself through a “screenshare” whereby his attorney broadcast electronic copies of the plea agreement and Guilty Plea Colloquy onto Defendant’s computer screen for him to read. The Defendant had ample opportunity to review the documents and to ask questions of counsel, which he did. Def. Mot. at ¶9. Counsel answered Defendant’s questions regarding the plea and Defendant agreed to move forward with it.

Prior to the Guilty Plea hearing on January 27, 2021, this Court examined all of the plea documents, including Defendant’s answers to the Guilty Plea Colloquy. The Court was satisfied then and is satisfied now that the Defendant was thor-

oughly informed regarding all aspects of the guilty plea process. Reviewing those answers again now, the Court reaches the same conclusion — Defendant entered his guilty plea pursuant to the negotiated terms of the plea agreement knowingly, intelligently, voluntarily, and understandingly; there is simply no basis for the Court to grant Defendant’s request to withdraw that plea now, after imposition of sentence.

Further, even if the Defendant harbored lingering doubts or confusion regarding his plea, or defense counsel rendered questionable advice, as Defendant suggests, any doubts or deficiencies were dispelled during the Guilty Plea hearing itself on January 27, 2021. At the hearing, the Court directly engaged with the Defendant, under oath, regarding the plea and Defendant’s rights. The Court thoroughly explained to the Defendant his right to a trial by jury, his presumption of innocence, the elements of all the charges against him, and the possible penalties for each, should the Court reject the plea agreement. N.T. at 7-8. At the conclusion of each explanation, the Court stopped to ask the Defendant explicitly if he understood what the Court had just explained and if the Defendant had any questions. Each time, the Defendant answered he understood and had no questions. N.T. at 7-11. Next, the Court addressed the Guilty Plea Colloquy. The Defendant affirmed that he had reviewed the Colloquy with his attorney and had authorized the signature on his behalf. N.T. at 11. In response to the Court’s inquiry, the Defendant responded he had no questions about the contents of the Guilty Plea Colloquy. *Id.* At that time, the Commonwealth read its recitation of facts, which the Defendant subsequently affirmed. N.T. at 14. Defendant’s counsel recited for the record the nature and extent of his consultations with the Defendant prior to the plea, detailing the long negotiation process with the Commonwealth, which began the day of the preliminary hearing. N.T. at 15. Finally, the Court provided the Defendant with one final opportunity to make a statement or to ask questions. After the Defendant asked and the Court answered a question regarding prison housing, the Court accepted the guilty plea and negotiated plea agreement and sentenced the Defendant to the agreed upon sentence of an aggregate of 7-15 years incarceration with conditions, some mandatory and some recommended. N.T. 17-18.

Reviewing the record as a whole, including the Guilty Plea Colloquy, the transcript from the hearing of January 27, 2021, and the pleadings of the parties, the Court finds no reason to change its ultimate conclusion that the Defendant entered into

the guilty plea fully understanding the guilty plea process, the nature and substance of his guilty plea, and the rights he was exchanging for the Commonwealth's agreement to what could have been a much more severe penalty. The Defendant offers no evidence to the contrary. Although he alleges his attorney informed him that withdrawal of the plea after sentencing was an option, the Defendant never raised this with the Court even as the Court provided him the opportunity to ask questions throughout the hearing. As evidenced by the record, the Defendant was capable of asking and did in fact ask cogent questions of both his attorney and the Court. The Court simply finds it implausible that the Defendant could have maintained the claimed mistaken belief even after the Guilty Plea hearing.

The Court does note that on February 8, 2021, it received a handwritten letter from the Defendant directly addressed to President Judge Ashworth as well as another identical letter addressed to the Honorable Howard F. Knisely of this Court.<sup>4</sup> In the letter, the Defendant states that

[wh]en I took the plea deal for 7 to 15 years I was under the influence of my medication and was drowsy when I took the plea but it is my understanding that I have 10 to 15 days following my decision to appeal my decision. I wish to appeal and take back the deal and I wish to follow through and take this to trial and that is my final decision.

Ltr. of Def., January 29, 2021. The Court also received

As Defendant is and was represented by counsel at that time, the Court cannot consider Defendant's ex parte letter, which appears to be Defendant's pro se attempt to file a post-sentence motion to withdraw his guilty plea. Such hybrid representation has been expressly precluded by our Supreme Court, whether at trial, on appeal, or during PCRA proceedings. See *Commonwealth v. Jette*, 611 Pa. 166, 23 A.3d 1032, 1038-40 (2011); *Commonwealth v. Pursell*, 555 Pa. 233, 724 A.2d 293, 302 (1999); *Commonwealth v. Ellis*, 534 Pa. 176, 626 A.2d 1137, 1139 (1993). See also *Commonwealth v. Willis*, 29 A.3d 393,

400 (Pa. Super. 2011). Pennsylvania Rule of Criminal Procedure 576(A)(4) addresses hybrid representation before the courts of common pleas, mandating that the pro se filing be received and docketed, but then forwarded to counsel: “In any case in which a defendant is represented by an attorney, if the defendant submits for filing a written motion, notice, or document that has not been signed by the defendant’s attorney, the clerk of courts shall accept it for filing” and send a copy to the attorney of record in the case within ten days of receipt. *Id.*

Even if the Court were able to consider the pro se filing, it would not change the Court’s opinion that there is no basis for allowing Defendant to withdraw his plea at this post-sentence stage of the proceedings. Defendant knowingly, voluntarily, and intelligently answered and signed the Guilty Plea Colloquy. In that document, he affirmed he was not under the influence of alcohol, drugs, or medication. Guilty Plea Colloquy at ¶3. When asked the follow-up question regarding whether medication affects his ability to understand the questions or the purpose of the document, he answered “N/A.” *Id.* at ¶5. In response to the question of whether he was or had ever been treated for a mental illness, he stated “yes” and wrote in “Bipolar/anxiety,” however he answered in the negative as to whether “the illness or its treatment affect[s] your ability to understand these questions or why you are here today.” *Id.* at ¶¶ 5-6. During the Guilty Plea hearing, the Defendant affirmed under oath the answers he gave in the Guilty Plea Colloquy and told the Court he did not have any questions relating to that document. N.T. at 11. The Defendant cannot now disavow the answers he gave under oath in order to serve his purposes in this post-sentence motion. *Commonwealth v. Pollard*, 832 A.2d 517, 523 (Pa.Super. 2003).

### III. CONCLUSION

For the reasons set forth above, the Court finds the Defendant entered a knowing, willing, and intelligent plea of guilt, pursuant to a negotiated plea agreement. He has failed to show any manifest injustice that would require this Court to allow the withdrawal of that plea now that sentence has been imposed. Accordingly, I enter the following:

**ORDER**

---

AND NOW, this 11th day of March, 2021, upon consideration of Defendant Cory Cressman's post sentence motion, it is hereby ORDERED that said motion is DENIED.

Pursuant to Pa.R.Crim.P. 720(B)(4), this Court advises Defendant that he has the right to appeal from this Order denying his post sentence motion. Defendant shall have 30 days from the date of this final Order to appeal to the Superior Court of Pennsylvania. Failure to appeal within 30 days will result in the loss of appellate rights.

Defendant is further advised that he has the right to assistance of counsel in the preparation of the appeal. If Defendant is indigent, he has the right to appeal *in forma pauperis* and to proceed with assigned counsel as provided in Pa.R.Crim.P. 122.
