Intention of rule - Confession of judgment - Breach of contract - Motion to compel discovery

- 1. The title or heading prefixed to a chapter of rules shall not be considered to control but may be used in construing the rules.
- 2. In ascertaining the intention of the Supreme Court in the promulgation of a rule, it is presumed that the Supreme Court does not intend a result that is absurd, impossible of execution or unreasonable.
- 3. It is not appropriate to attach additional claims in a Complaint in Confession of Judgment for Money.
- 4. Plaintiff filed a Complaint for Confession of Judgment and for Breach of Contract and sought discovery on the latter count and, when discovery was not produced, filed a motion to compel discovery. Because the Court had granted Defendant's Petition to Strike off the Confessed Judgment and a plaintiff cannot include a breach of contract claim with a confession of judgment, the Court concluded the breach of contract claim, for which discovery was sought, was a legal nullity and denied the motion to compel discovery.

#### **MEMORANDUM**

On January 21, 2021, Plaintiff filed a Complaint in Confession of Judgment for Money alleging that Defendant breached a commercial lease and owes at least \$1,322,288.10. Plaintiff set forth two (2) counts. The first count Plaintiff entitled Count I – Confession of Judgment for Money. The second count Plaintiff entitled Count II: Breach of Contract. The Prothonotary entered a confessed judgment in favor of Plaintiff on January 21, 2021 which this court struck on June 4, 2021 when it granted Defendant's Petition to Strike off Confessed Judgment, filed March 3, 2021.

Now before this court is Plaintiff's Motion to Compel Discovery Responses, filed June 24, 2021. By its Motion, Plaintiff asked this court to compel Defendant to answer Plaintiff's Requests for Interrogatories and Requests for Production of Documents that Plaintiff served on May 18, 2021. Motion, 6/24/2021, ¶¶ 8, 11-13, 22. Plaintiff argued that "the case is not over as [Plaintiff] has asserted a claim for Breach of Contract claim [sic] against [Defendant.]" Motion, 6/24/2021, ¶ 14. Plaintiff argued that "[i]n accordance with Pa.R.C.P. No. 4003.1, a party may obtain discovery regarding any matter, not privileged, which is relevant to the subject matter involved in the pending action." Motion, 6/24/2021, ¶ 17.

Defendant objected to Plaintiff's discovery asserting that Count II: Breach of Contract does not exist because it cannot be joined to a claim for confession of judgment. Defendant argued that the rules of procedure that govern confession of judgment, Pa.R.C.P. No. 2950, *et seq.*, do not expressly authorize joinder of another claim which is to be expected since a proceeding to confess judgment is a unique form of action to which the other rules of procedure governing other forms of action do not apply. *See* Brief, 7/12/2021, pp. 3-8. Plaintiff countered that Count II: Breach of Contract exists because it was pled and Defendant never attacked it by Petition or Preliminary Objection. Motion, 6/24/2021, ¶¶ 3, 5, 14-15. To that, Defendant countered that any such attack would have been unauthorized by law. Brief, 7/12/2021, p. 9 ("The Rules of Civil Procedure do not offer any specific remedy where plaintiff has wrongfully included a count for Breach of Contract in a confession of judgment action.").

This court has given the matter some thought. First, it should be noted that Plaintiff rested its request for discovery solely on the existence of Count II. See, e.g. Motion, 6/24/2021, ¶ 14 ("However, [Defendant] has conveniently ignored that the case is not over as [Plaintiff] has asserted a claim for Breach of Contract claim [sic] against [Defendant]. That cause of action remains viable and [Plaintiff] is entitled to take discovery related to that claim."). Plaintiff did not argue to this court that Count I remains viable and thus Plaintiff tacitly acknowledged that the order that struck the confessed judgment also struck Count I – Confession of Judgment for Money. That tacit acknowledgment was in accord with <u>United Parcel Service v. Hohider</u>, 954 A.2d 13 (Pa.Super. 2008) which held that the lower court order that struck the confessed judgment ended the litigation as to all parties

and claims and was immediately appealable as a final order as defined by Pa.R.A.P. 341(b).

Second, as to the existence of Count II, there seems to be no controlling rule of procedure that expressly allows or disallows additional claims in a Complaint in Confession of Judgment for Money. Similarly, neither Plaintiff nor Defendant provided this court with a case where a Complaint for Confession of Judgment contained a second claim and this court's own research failed to find such an example for guidance. Under such circumstances, this court believes the better view is the one advocated by Defendant which is that an Action for Confession of Judgment for Money is an action governed by Pa.R.C.P. Nos. 2950-2967 which stands apart from a Civil Action governed by Pa.R.C.P. Nos. 1001-1042.71. See Pa.R.C.P. No. 129(d) ("The title or heading prefixed to a chapter of rules shall not be considered to control but may be used in construing the rules.").

This court thinks it is telling that Pa.R.C.P. No. 2952(b) commands that a Complaint for Confession of Judgment "shall neither contain a notice to defend nor be endorsed with a notice to plead". See also id. at Note ("Neither Rule 1018.1 nor Rule 1361 applies to a complaint in confession of judgment."). Pa.R.C.P. No 1018.1 commands that "[e]very [Civil Action] complaint filed by a plaintiff and every [Civil Action] complaint filed by a defendant against an additional defendant shall begin with a notice to defend." It cannot be true that a Civil Action claim, such as a claim for Breach of Contract, can be pled together with a Confessed Judgment claim because then a notice to plead or defend would be both required and prohibited at the same time. That result is prohibited by Pa.R.C.P. No. 128(a) ("In ascertaining the intention of the Supreme Court in the promulgation of a rule, [it is to be presumed that] the Supreme Court does not intend a result that is absurd, impossible of execution or unreasonable.").

Such an approach is bolstered by the recognition of the courts that a confession of judgment complaint is not, in and of itself, an adversarial proceeding. Midwest Fin. Acceptance Corp., 78 A.3d 614, 622, 626 (Pa. Super. 2013) (opining that a confession of judgment for money is not governed by the same rules of notice and adversarial protections as ordinary civil complaints) (citing Newton v. First Union Nat. Bank, 316 F.Supp.2d 225, 233-34 (E.D.Pa. 2004)). Accordingly, as the complaint for confession has its own set of rules, a suggested form with mandated inclusions, no notice to plead, and is not wholly adversarial in nature, it is not appropriate to attach additional claims.

For the reasons set forth above, this court concludes that Plaintiff's Count II: Breach of Contract is a legal nullity and that there remains pending no legally cognizable claim filed to docket number 2021-00494-JD. Accordingly, for the reasons set forth above, this court will enter an order denying Plaintiff's Motion to Compel.
