



## Lake Ariel Man Charged in Drug Overdose Death

William Henry Motz, 31, of Lake Ariel, Wayne County PA, has been charged with drug delivery resulting in death, a first-degree felony, involuntary manslaughter, a first degree misdemeanor, possession with intent to deliver, an ungraded felony, and criminal use of a communication facility, a third degree felony, for the overdose death of Edward Lawrence Keane, 30, of Hawley, Wayne County PA. Mr. Motz was arraigned before Magisterial District Judge Bonnie Carney who set bail at \$50,000.00. Mr. Motz is currently serving a 36-72 month state sentence for his prior guilty plea to an unrelated possession with intent to deliver conviction stemming from incidents in Pike County PA.

According to the complaint, Mr. Keane was found dead in the basement living area of his residence on the morning of September 29, 2020. Pennsylvania State Police initially found in the corner of the room a rolled up \$1.00 bill and tin foil that had appeared to be burned. Upon initially reviewing the victim's cell phone, the victim had several text messages exchanged with William Motz. The messages suggested there was an exchange of drugs during the days leading up to the victim's death. A search of Facebook Messenger also discovered that the victim and Billy Motz corresponded via messenger and Facebook calling on September 29, 2020. They agreed to meet on Main Street, Hawley Borough on the night of September 29, 2020.

Also discovered in the residence was drug paraphernalia and heroin in a small black pouch. The pouch contained 6 suspected heroin packets stamped "Tropicana", 6 suspected heroin packets stamped "Paid in full", 3 empty heroin packets stamped " Paid in full", 2 empty heroin packets stamped "Tropicana", 14 empty heroin packets without stamps and 4 rubber bands.

On March 8, 2021, the Pennsylvania State Police Bureau of Forensic Services laboratory report details the results analyzed from the suspected heroin seized from the victim's residence. The six (6) white glassine bags stamped "Tropicana" contained heroin and fentanyl. The five (5) glassine bags stamped, "Paid in Full", contained heroin and fentanyl. In another investigation, on February 10, 2021, the Defendant was taken into custody and found to be in possession of a large amount of heroin. In an interview, the Defendant related that he knew the victim, that he's pretty sure the victim had overdosed, and that he saw the victim on Main Street, Hawley, right before he died.

On May 3, 2021, the victim's autopsy and toxicology report from Northern Tier Research showed at the time of the victim's death that the victim had a total of 19ng/mL Fentanyl, 3 ng/mL of Nor fentanyl, and 12.6 ng/mL Morphine present within his system. The manner of the victim's death was ruled accidental and cause was listed as pharmacologic effects of fentanyl.

Motz is scheduled for central court on Wednesday, October 19, 2022.

\*The filing of criminal charges is not evidence of guilt but simply a description of the charge made by the Commonwealth against a defendant. A charged Defendant is presumed innocent until a jury returns a unanimous finding that the Commonwealth has proven the defendant's guilt beyond a reasonable doubt or until the defendant enters a guilty plea to the charges.

## **CRIMINAL CASES**

Wayne County District Attorney A.G. Howell announced the following case was addressed by the Honorable Janine Edwards, President Judge Wayne County Court:

## HONESDALE, PA- September 29, 2022

JOSEPH A. CASTELLANO, age 61 of Lake Ariel PA, was sentenced to undergo incarceration in a State Correctional Facility for a period of not less than 12 months nor more than 60 months for two counts Possession of Controlled Substance with Intent to Deliver – Cocaine (F). He was also ordered to pay the costs of prosecution. The incident occurred on January 11, 2022 in Texas Township.

TROY FRABLE, age 48 of Palmerton PA, was sentenced to undergo incarceration in a State Correctional Facility for a period of not less than 33 months nor more than 120 months for one count of Fail to Register with PSP – 1st Offense (F2). He was also ordered to pay the costs of prosecution. The incident occurred between November 4, 2020 and April 23, 2021 in Lehigh Township.

JOSEPH F. GOONAN, age 53 of Scranton PA, was placed on probation for a period of 12 months for one count Disorderly Conduct (M3). He was also ordered to pay the costs of prosecution, refrain from having contact with the victim, continue with mental health treatment and comply with any and all recommendations for treatment, and undergo a drug and alcohol evaluation and comply with any and all recommendations for treatment. The incident occurred on January 27, 2021 in Hawley Borough.

SAMANTHA PRU GUEVREKIAN, age 37 of Carbondale PA, was placed on the Accelerated Rehabilitation Disposition Program for a period of 6 months related to False Statements. She was also ordered to pay all costs, complete 20 hours of community service, undergo a drug and alcohol evaluation and comply with any recommendations for treatment. The incident occurred on April 21, 2022 in Honesdale Borough.

THOMAS W. HAAS, age 52 of Chesterfield NJ, was placed on probation for a period of 6 months for one count of Disorderly Conduct – Hazardous/Offensive Condition (M3). He was also ordered to pay the costs of prosecution, pay a fine of \$500.00, undergo a drug and alcohol evaluation in the County he resides in, comply with any and all recommendations and provide a copy to Wayne County Probation, and maintain employment while or provide documentation from a doctor precluding him from employment. The incident occurred on Salem Township.

MELVINA JAMIE HARDLER, age 34 of Honesdale PA, was placed on probation for a period of 12 months for one count Recklessly Endangering Another Person (M2). She was also ordered to pay the costs of prosecution, maintain employment while on supervision or provide documentation from a doctor precluding her from employment, undergo a mental health evaluation that includes anger management treatment and comply with any recommendations for treatment, and relinquish any firearm and any ammunition to law enforcement. The incident occurred on November 17, 2021 in Lebanon Township. KEVIN EDWARD KELLOGG, age 30 of Scranton PA, was sentenced to undergo incarceration in a State Correctional Facility for a period of not less than 16 months nor more than 60 months for one count Fleeing or Attempting to Elude a Police Officer (F3). He was also ordered to pay the costs of prosecution. The incident occurred on September 25, 2020 in Salem Township.

TASEAN JAMES MULDROW, age 28 of Wilkes Barre PA, was sentenced to undergo incarceration in the Wayne County Correctional Facility for a period of not less than 11 ½ months nor more than 23 ½ months for one count Unlawful Contact with Minor – Sexual Offenses (F1). He was also ordered to pay the costs of prosecution, have no unsupervised with any child under the age of 18, undergo a sex offender evaluation while incarcerated and comply with all treatment recommendations, and register as a Tier II offender subject to a 25 year registration period.


ENRIQUE M. OLVERA, age 28 of Bronx NY, was sentenced to undergo incarceration in the Wayne County Correctional Facility for a period of not less than 7 months nor more than 23 ½ months for one count Simple Assault (M2). He was also ordered to pay the costs of prosecution, undergo a mental health evaluation that includes anger management counseling and comply with all recommendations for treatment, obtain his GED while on supervision, have no contact with the victim, excluding the provision set forth in the PFA, and relinquish any firearm and any ammunition to law enforcement within 24 hours. The incident occurred on March 17, 2022 in Palmyra Township.

RICHARD PUGLIESE, age 30 of Honesdale PA, previously sentenced on September 9, 2021 to 36 months probation with 12 months House Arrest with Electronic Monitoring through the SCRAM program, was resentenced to undergo incarceration in the Wayne County Correctional Facility for a period of not less than 90 days nor more than 60 months. He was also ordered to pay the costs of prosecution, pay a fine of \$1,500.00, participate in and cooperate with drug and alcohol addiction treatment in accordance with his assessment, complete the Alcohol Highway Safety Program, and obtain employment within 60 days of parole or provide documentation from a doctor precluding him from employment. The defendant was found in violation of Probation when he failed to attend a scheduled appointment on July 12, 2022 with probation, failed to contact probation, and failed to return to his approved residence on July 11, 2022.

CHRISTOPHER NOVITZKE, age 31 of Honesdale PA, was issued a Bench Warrant for failure to appear at court.

JESSE J. SWINGLE, age 37 of Lake Ariel PA, was issued a Bench Warrant for failure to appear at court.

NISHA DEANNA THOMAS, age 37 of Baltimore MD, was issued a Bench Warrant for failure to appear at court.
