FIRST JURY TRIAL SINCE PANDEMIC LEADS TO CONVICTION FOR ASSAULT

July 13, 2021 — Wayne County District Attorney A.G. Howell announced that on Monday, July 12, 2021, the first jury seated in Wayne County since the beginning of the pandemic, and presided over by President Judge Janine Edwards, convicted Daniel Candelario, 53, of Browndale PA, for the assault upon his 80-year-old neighbor. The jury convicted Mr. Candelario of the lead charge of Simple Assault. Judge Edwards set the sentencing date for August 19, 2021.

On October 17, 2020, the 80-year-old victim was helping the defendant's wife change a headlight on her car. Mr. Candelario came out of his residence yelling, screaming and shoving his wife. Mr. Candelario pushed his wife out of the way, confronted the victim and punched the victim in the face. Mr. Candelario's attack on the victim caused a golf ball size red lump on the side of his head. Two (2) other independent individuals also witnessed the assault.

District Attorney Howell praised the court and his office for their preparation and organization in conducting jury selection and the trial in a safe and efficient manner. The District Attorney's office continues the pursuit of justice either by pleas from defendants or by jury trial when defendants refuse to accept responsibility for their actions.

District Attorney Howell also expressed his gratitude to Assistant District Attorney Rich Henry and the Pennsylvania State Police for their thorough, thoughtful and convincing presentation of the assault upon the victim.



CRIMINAL CASES

Wayne County District Attorney A.G. Howell announces the following cases were addressed by the Honorable Janine Edwards, President Judge Wayne County Court:

HONESDALE, PA — July 8, 2021

FRANK GEORGE AMBROSIO III, age 27 of Cooperstown NY, was sentenced to undergo incarceration at the Wayne County Correctional Facility for a period of 10 days followed by 18 months' probation with 60 days of House Arrest through the SCRAM program for one count of Driving Under the Influence (M) and one count of Resisting Arrest (M2). He was also ordered to pay the costs of prosecution, pay a mandatory minimum fine of \$1,000.00, participate and cooperate with the drug and alcohol addiction treatment in accordance with his assessment, complete the Alcohol Highway Safety Program, undergo a mental health evaluation and comply with any recommendations for treatment and obtain employment within 30 days of sentencing or provide documentation form a doctor precluding him from employment. The incident occurred on September 12, 2020 in Salem Township.

GERALD C. FABRI, age 35 of Lakeville Pa, was sentenced to undergo incarceration in the Wayne County Correctional Facility for a period of not less than 3 months nor more than 60 months for one count of Corruption of Minors (F3). He was also ordered to pay the costs of prosecution, pay restitution in the amount of \$1,200.00, have no contact with the victim, have no unsupervised contact with any child under the age of 18, continue with sex offender treatment and comply withal treatment recommendations, and register with Megan's Law as a Tier I Offender for 15 years. The incident occurred on August 27, 2020 in Paupack Township.

Mitchell Gilpin, age 23 of Lake Ariel Pa, was previously sentenced on March 4, 2021 to undergo incarceration in the Wayne County Correctional Facility for a period of not less than 1 month nor more than 12 months. The Defendant was found in violation of his probation, was resentenced and remanded to the Wayne County Correctional Facility for the remainder of his sentence, September 22, 2022. On June 15, 2021 the Defendant tested positive for Drugs.

TIMOTHY DAVID HOLMES, age 543 of Felton Pa, was placed on the Accelerated Rehabilitative Disposition Program for a period of 6 months related to a DUI. He was also ordered to pay all costs, have his driving privileges suspended for a period of 60 days, complete the Alcohol Highway Safety Program, and complete 20 hours of community service. The incident occurred on August 25, 2020 in Canaan Township.

STEPHANIE L. KRESGE, age 38 of Bangor Pa, was previously sentenced on April 8, 2021 to undergo incarceration in the Wayne County Correctional Facility for a period of not less than 5 months nor more than 23 1/2 months. The Defendant was found in violation of her probation, was resentenced and remanded to the Wayne

County Correctional Facility for the remainder of her sentence, November 22, 2022. On May 24, 2021 and. June 8, 2021, the defendant failed to report for scheduled appointments with Probation.

STEPHEN J. RUFFINO, age 54 of Lake Ariel Pa, was sentenced to undergo incarceration for a period of not less than 30 days nor more than 12 months for one count of Possess/Sell/Use/Display Documents (M1). He was also ordered to pay the costs of prosecution, and undergo a drug and alcohol evaluation and comply with any recommendations for treatment. The incident occurred on February 11, 2021 in Salem Township.
