NOTICE IS HEREBY GIVEN THAT Articles of Incorporation were filed in the Department of State of the Commonwealth of Pennsylvania, at Harrisburg, Pennsylvania on the 2nd day of May, 2014 for the purpose of incorporating a nonprofit corporation under the Pennsylvania Nonprofit Corporation Law of 1988. The name of the Corporation is **HOPE CENTER FOR ARTS AND TECHNOLOGY, INC.** The purposes for which it has been organized are as follows:

The corporation is incorporated under the Pennsylvania Nonprofit Corporation Law of 1988 or any successor act (as amended) exclusively for those purposes permitted by §501(c)(3) of the Internal Revenue Code, including without limitation:

(a) Educate and inspire youth through the arts on their way to becoming productive citizens;

(b) Engage the community in the process of art making and artistic communication as a way to stimulate intercultural understanding, appreciation and enhancement of the quality of life;

(c) Reduce or eliminate the dependence of persons in government provided or subsidized programs, relieve poverty, by teaching job skills, raising self-esteem and self-respect, personal responsibility, reliability, attendance, work ethics;

(d) Develop training vocational and remedial training programs primarily to disadvantaged persons and dislocated workers.

To maximize Corporation's impact on current efforts, Corporation may seek to collaborate with other non-profit organizations which fall under Section 501(c) (3) of the internal revenue code and are operated exclusively for educational and charitable purposes.

At times, per the discretion of the

board of directors, Corporation may provide internships or volunteer opportunities which will provide opportunities for involvement in said activities and programs in order to have a greater impact for change.

(e) In addition to the foregoing, to engage in any and all other activities permitted of an organization exempt from Federal taxation pursuant to Section 501 (c) (3) of the Code subject to the limitations of the Code. To these ends, the Corporation may do and engage in any and all lawful activities that may be incidental or reasonably necessary to any of the purposes set forth above.
