# The Pennsylvania State Troopers Assoc. et al. v. Thomas P. Hogan

Equity Action – Injunctive relief – Declaratory judgment – Motion to dismiss – Mootness - Ripeness

- 1. The adjudicatory power of the court depends upon the existence of a live controversy.
- Where there are intervening changes in the factual circumstances of a case which eliminate an actual controversy and make it impossible to grant the requested relief, the legal question is rendered moot and the case should be dismissed.
- 3. An issue before the court is moot if, in ruling on the issue, the court cannot enter an order that has any legal force or effect.
- 4. The court should not decide a moot or abstract question except in rare instances when the question presented is one of great public importance, or when the question presented is capable of repetition, yet escaping judicial review. However, in particular, constitutional questions are not to be dealt with abstractly.
- When circumstances change, a matter pending before the court can be rendered moot.
- 6. A declaratory judgment action requires a real controversy.
- 7. A declaratory judgment must not be employed to determine rights in anticipation of events which may never occur or for consideration of moot cases or as a medium for the rendition of an advisory opinion which may prove to be purely academic.
- 8. It is well-established that declaratory judgments are not obtainable as a matter of right. Rather, whether a court should exercise jurisdiction over a declaratory judgment proceeding is a matter of sound judicial discretion.
- A declaratory judgment action may proceed only if the issues are ripe for determination.
- 10. Ripeness is analyzed using a two-part test. The court must consider first whether the issues are adequately developed for judicial review and, second, what hardship the parties will suffer if review is delayed.
- 11. A court should look to (a) the fitness of the issues for judicial decision, and (b) the hardship to the parties of withholding court consideration.
- 12. Under the fitness for review inquiry, a court considers whether the issues presented are purely legal, as opposed to factual, and the degree to which the challenged action is final. The various factors that enter into a court's assessment of fitness include: whether the claim involves uncertain and contingent events that may not occur as anticipated or at all; the extent to which a claim is bound up in the facts; and whether the parties to the action are sufficiently adverse.
- 13. The determination whether hardship is cognizable turns on whether the challenged action creates a direct and immediate dilemma for the parties, such that the lack of pre-enforcement review will put the plaintiffs to costly choices.
- 14. Plaintiff filed an equity action seeking injunctive and declaratory judgment

relief from defendant in his capacity as District Attorney of Chester County. Defendant filed a motion to dismiss, which the Court originally denied. The defendant sought and obtained reconsideration of the denial of the motion to dismiss. Following reconsideration of the motion, the Court *Held*, that the motion was granted and plaintiffs' complaint was dismissed with prejudice.

## **MEMORANDUM OPINION & ORDER**

This matter is before us on a motion to dismiss filed by Defendant, Thomas P. Hogan, in his capacity as District Attorney of Chester County ("Hogan").

# Background:

Hogan filed a motion to dismiss this action on September 6, 2019 ("Motion"). Plaintiffs, the Pennsylvania State Troopers Association and Brandon Daniels ("State Troopers", "Lt. Daniels", or together "Plaintiffs"), responded on September 10, 2019 by filing preliminary objections in the nature of a motion to strike, asserting that the Motion was another attempt to preliminarily object to the complaint. On September 27, 2019, Hogan preliminarily objected to the Plaintiffs' preliminary objections. On November 7, 2019, we entered an order striking the Motion, finding that it was an effort to resurrect the preliminary objections to the complaint.

On November 19, 2019, Hogan sought reconsideration. On January 21, 2020, we granted reconsideration, vacated the November 7, 2019 Order pending reconsideration, and directed the parties to brief one issue, "whether this suit should be dismissed because the case is moot and there is no actual controversy due to the fact that District Attorney Hogan's term of office has expired." The parties have duly filed their briefs.

Plaintiffs commenced this action with a two-count complaint on September 6, 2018. The individual plaintiff, Brandon Daniels, was at the time a Lieutenant with the Pennsylvania State Police, serving as Commander of the Troop J Criminal

Investigation Section and responsible for leading investigations of significant crimes in Chester County. Lt. Daniels has since retired.

The events leading up to this suit began May 23, 2018 when the Pennsylvania State Police were involved in a shooting. Lt. Daniels conducted the investigation at the scene. Hogan had previously issued protocols requiring that he be notified early on in police related shootings. Hogan asserts that Lt. Daniels ignored the protocols, was not truthful in explaining why he failed to follow the protocols, and that the investigation was mishandled. On July 26, 2018, Hogan advised Pennsylvania Homeland Security and the Pennsylvania State Police in a memorandum ("Memorandum") that he was placing Lt. Daniels on a do not use list ("List"). Hogan also disclosed that there were already two current or former members of the Pennsylvania State Police on the List and that he was contemplating placing another member of the Pennsylvania State Police, in addition to Lt. Daniels, on the List.

The complaint at Count I seeks injunctive relief. Plaintiffs asked to have Hogan, his agents or employees barred from further publication of the Memorandum and anchor this request to Article I, Sections I<sup>3</sup> and XI<sup>4</sup> of the Pennsylvania Constitution. Count I complains that Lt. Daniels was deprived of due process having been denied notice, an opportunity to be heard and the chance to defend himself before a fair and impartial tribunal before being placed on the List.

The complaint at Count II seeks declaratory and injunctive relief. The declaration sought is:

The act of placing a State Police Officer on the District Attorney Office's "do not call list" without adequate notice, opportunity to be heard, or the chance to defend oneself before a fair and impartial tribunal is in violation of Article I, Sections I, IX and XI of the Constitution of Pennsylvania.

Additionally, Plaintiffs sought to enjoin Hogan from placing Lt. Daniels or any other member of the Pennsylvania State Police on the List without "constitutionally sufficient due process" and, further, to prohibit Hogan from disclosing the identities of any persons on the List until due process is provided.

Plaintiffs did not seek any relief at law against Hogan, only equitable relief in the form of an injunction and a declaration.

While this action has been pending, Hogan left office in January 2020, having not sought reelection in the fall 2019 general election. Deb Ryan ("D.A. Ryan") was sworn in as Chester County's district attorney on January 3, 2020.

### Discussion:

Plaintiffs brought this action against Hogan *in his capacity as district attorney of Chester County*. Hogan is now, and has been since January 3, 2020, a private citizen, no longer serving in his former capacity as district attorney. As a private citizen, Hogan no longer has the ability to control the operation, policies, processes or procedures of the Chester County District Attorney's Office.

The adjudicatory power of the court depends upon the existence of a live controversy. "[W]here there are intervening changes in the factual circumstances of a case which eliminate an actual controversy and make it impossible to grant the requested relief, the legal question is rendered moot and the case should be dismissed." Johnston v. Lehman, 676 A.2d 1287, 1289 (Pa.Cmwlth. 1996). An issue before the court is moot if in ruling on the issue, the court cannot enter an order that has any legal force or effect. Johnson v. Martofel, 2002 PA Super 79, 8, 797 A.2d 943, 946 (Pa. Super. Ct. 2002). The court should not decide a moot or abstract question "except in rare instances when the question presented is one of great public importance, or when the question presented is capable of repetition yet escaping judicial review." Id. However, in particular, "[c]onstitutional questions are not to be dealt with abstractly." Harris v. Rendell, 982 A.2d 1030, 1035 (Pa. Cmwlth. 2009)(quoting In re Gross, 476 Pa. 203, 211, 382 A.2d 116, 120 (1978)). Plaintiffs have not argued that the issue before us is of great public importance or one where the question presented is capable of repetition yet escaping judicial review.

The holding in Zemprelli v. Thornburgh, 78 Pa.Cmwlth. 45, 466 A.2d 1123 (1983), illustrates the point that when circumstances change, a matter pending before the court can be rendered moot. The Zemprelli plaintiffs, a group of state senators, filed suit, inter alia, to oust the Secretary of the Department of Revenue. The Secretary resigned before the matter was resolved and the court held the case was moot because the relief plaintiffs sought, the ouster of the Secretary, could no longer be granted.

Similarly, in <u>Harris</u>, 982 A.2d 1030, a group of prisoners sought a mandamus and declaratory judgment against the Commonwealth after a policy was implemented for a temporary moratorium on parole. The action was dismissed as moot when the prisoners were subsequently granted parole and the requested relief was therefore unavailable.

In the instant matter, there is no actual controversy and the lawsuit is moot

given the change in circumstances since the lawsuit was filed. The injunctive relief Plaintiffs seek can never be granted because Hogan is out of office and does not have power to direct any action within the District Attorney's Office. Any injunction that may issue would have no legal effect.

Similarly, a declaratory judgment action requires a real controversy. <u>Gulnac by Gulnac v. S. Butler Cty. Sch. Dist.</u>, 526 Pa. 483, 488, 587 A.2d 699, 701 (1991). "A declaratory judgment must not be employed to determine rights in anticipation of events which may never occur or for consideration of moot cases or as a medium for the rendition of an advisory opinion which may prove to be purely academic." <u>Id.</u> "It is well established that '[d]eclaratory judgments are not obtainable as a matter of right. Rather, whether a court should exercise jurisdiction over a declaratory judgment proceeding is a matter of sound judicial discretion." <u>City Council of Philadelphia v. Com.</u>, 806 A.2d 975, 978 (Pa.Cmwlth. 2002)(citing <u>Pa. State Lodge v. Department of Labor & Indus.</u>, 692 A.2d 609, 613 (Pa.Cmwlth.1997)). A declaratory judgment action may proceed only if the issues are ripe for determination. Ripeness is analyzed using a two-part test. <u>Id.</u> "The court must consider [first] whether the issues are adequately developed for judicial review and [second] what hardship the parties will suffer if review is delayed." Id.

When considering whether a declaratory judgment action is ripe, the Commonwealth Court has cited the test set forth in <u>Philadelphia Fed'n of Teachers</u>, <u>Am. Fed'n of Teachers</u>, <u>Local 3</u>, <u>AFL-CIO v. Ridge</u>, 150 F.3d 319, 323 (3d Cir. 1998) with approval:

A court should look to (1) "the fitness of the issues for judicial decision," and (2) "the hardship to the parties of withholding court consideration." Under the "fitness for review" inquiry, a court considers whether the issues presented are purely legal, as opposed to factual, and the degree to which the challenged action is final. The various factors that enter into a court's assessment of fitness include: whether the claim involves uncertain and contingent events that may not occur as anticipated or at all; the extent to which a claim is bound up in the facts; and whether the parties to the action are sufficiently adverse.

The second prong focuses on the hardship that may be entailed in denying judicial review, and the determination whether any such hardship is cognizable turns on whether the challenged action creates a "direct and immediate" dilemma for the parties, such that the lack of pre-enforcement review will put the plaintiffs to costly choices.

City Council of Philadelphia, 806 A.2d at 979-80.

Here, Plaintiffs sought declaratory relief because of Hogan's actions. Hogan

is out of office; there is no risk that he will use the List. Any deprivation of rights Plaintiffs allege to justify declaratory relief are hypothetical and contingent upon uncertain future events. Plaintiffs have made no allegations that D.A. Ryan is continuing to use the List or that she has created her own. Any harm is speculative. Plaintiffs cannot meet the fitness prong of the ripeness test.

Plaintiffs also cannot establish any immediacy of harm under the second prong since Hogan is out of office and there is not even an allegation that D.A, Ryan maintains or will use a similar list. Plaintiffs will suffer no hardship by the denial of pre-enforcement review because Hogan no longer holds office and cannot use the List.

D.A. Ryan could have but has not voluntarily substituted her appearance for that of Hogan.

After being directed to brief the issue of mootness, Plaintiffs filed a praecipe to cause a rule to issue on D.A. Ryan in her capacity as District Attorney of Chester County to show cause why she should not be substituted as the defendant herein under Pa.R.C.P. No. 2352(b). Rule 2352(b) provides, "[i]f the successor does not voluntarily become a party, the prothonotary, upon praecipe of an adverse party setting forth the material facts shall enter a rule upon the successor to show cause why the successor should not be substituted as a party." The praecipe has languished in the Prothonotary's Office; a rule to show cause has not issued.

Although the issue of D.A. Ryan's substitution is not before us at this juncture, we note that this dispute is between Plaintiffs and Hogan and a number of difficulties would ensue if Ryan is substituted as defendant. The complaint is directed to specific conduct of Hogan. For example, Plaintiffs aver:

- 12. On July 26, 2018, District Attorney Hogan sent a Memorandum to Marcus L. Brown, Pennsylvania Director of Homeland Security, Lt. Col. Robert Evanchick, Acting Commissioner of the Pennsylvania State Police and Captain James Fisher, the Commander of PSP Troop J. (Exhibit "B").
- 13. In this Memorandum, District Attorney Hogan makes multiple untrue assertions concerning Daniels' investigation into the incident damaging to his reputation. Among these untrue assertions was:
  - (a) Daniels was not truthful with Hogan as to issues concerning notification of the incident;
  - (b) Daniels disobeyed lawful orders by failing to follow District Attorney Protocol in the investigation and "willfully subverted" District Attorney's Office Policy;

- (c) Daniels' maintenance of the scene of the incident as "an abysmal failure";
- (d) Daniels permitted a PSTA Representative to transport the involved Troopers from the scene suggesting the appearance of a "cover-up";
- (e) Daniels endangered the integrity of the investigation in a manner which was "both dangerous and foolish".
- 14. Contrary to the untrue assertions of District Attorney Hogan, Daniels conducted a full, fair and thorough investigation of the incident in strict accordance with Pennsylvania State Police rules, regulations, policies and directives.

\* \* \*

17. The untrue assertions made by District Attorney Hogan concerning Daniels are inherently damaging to his reputation in the law enforcement community. Publishing these untrue assertions to individuals within State Government outside of the State Police similarly risks even greater reputational damage.

\* \* \*

- 20. Prior to placing Daniels on the "do not use list", Hogan, as District Attorney of Chester County, did not provide advanced notice to Daniels, or permit him an opportunity for hearing.
- 21. It appears that there is no mechanism by which Hogan, as District Attorney of Chester County, provides advanced notice or opportunity for hearing, for any member of the Pennsylvania State Police before being placed on the "do not use list". Nor are there any apparent standards for being placed on that list other than the arbitrary and capricious whim of District Attorney Hogan.

\* \* \*

38. It is believed, and therefore averred that Hogan maintains no published and available guidelines or standards for the placement of members of the Pennsylvania State Police to be placed on the "do not use list". Each decision to do so (or not as the case may be) is therefore the potentially the arbitrary choice of the District Attorney all undertaken with no adequate notice, opportunity to be heard, or the chance to defend oneself before a fair and impartial tribunal

These allegations are highly personal as to Hogan. These allegations are specific about facts that do not involve D.A. Ryan. Pleadings have closed and the parties have engaged in discovery. The highly personal and factually specific

nature of the allegations raised by Plaintiffs make it legally and logically absurd to substitute D.A. Ryan into this lawsuit in Hogan's place. D.A. Ryan would have no direct knowledge of how Hogan created or used the List. Substitution would assign Hogan's pleading admissions and denials to D.A. Ryan and would also bind her to Hogan's discovery responses and statements. Substitution would compel D.A. Ryan to defend items and things about which she would have no knowledge. Due process concerns are implicated when a party is not provided with an opportunity to fully participate in proceedings before the court. Sunset Golf Course v. W.C.A.B. (Dep't of Pub. Welfare), 141 Pa.Cmwlth. 103, 110–11, 595 A.2d 213, 217 (1991) (party's due process rights were violated when board substituted it for a prior employer because it did not have the opportunity to participate in prior proceedings). There is no mechanism to "undo" the pleadings, admissions and denials already made by Hogan to allow D.A. Ryan to fully participate in this matter if she were to be compelled to substitute in as defendant.

D.A. Ryan's position concerning the creation and use of do not call or do not use lists may not be in opposition to the position taken by Plaintiffs. Her position may change over her tenure in office. At this juncture, with Hogan out of office and the List no longer in use, a real controversy does not exist.

For all of the reasons stated, we enter this

## **ORDER**

AND NOW, this 24th day of April, 2020, upon reconsideration of Defendant's motion to dismiss, Plaintiffs' response and all related filings, it is hereby ORDERED that the motion is GRANTED and this matter is dismissed with prejudice.
