## Custer v. Johnson

## Petition to transfer venue

- 1. Pursuant to Pa.R.C.P. 1006(d), for the convenience of parties and witnesses, upon a petition of any party, a court may transfer an action to the appropriate court of any other county where the action could originally have been brought.
- 2. A plaintiff's choice of forum should be given deference and only be disturbed based on Pa.R.C.P. 1006(d)(1) upon a showing by a defendant that the plaintiff's choice of forum was designed to harass the defendant or that the trial in the chosen forum is oppressive to him.
- 3. Mere inconvenience remains insufficient to obtain a change in venue, but there is no burden to show near-draconian consequences.
- 4. 23 Pa.C.S. § 5427 lays out the factors to consider for an inconvenient forum argument in custody matters relating to another state exercising jurisdiction: (a) the distance between the court in this Commonwealth and the court in the county that would assume jurisdiction; (b) the relative financial circumstances of the parties; (c) any agreement of the parties as to which county should assume jurisdiction; (d) the nature and location of the evidence required to resolve the pending litigation, including testimony of the child; (e) the ability of the court of each county to decide the issue expeditiously and the procedures necessary to present the evidence; and (f) the familiarity of the court of each county with the facts and issues in the pending litigation. The court deemed some of these factors relevant to this petition.
- 5. Delay in filing a Petition to Transfer Venue until the eve of trial is looked upon with disfavor.
- This case involves the unusual situation where it was not the defendant who sought to transfer venue due to forum non conveniens, but the plaintiff; accordingly, the court disregarded the normal deference afforded to plaintiff's initial choice regarding venue. When plaintiff filed for divorce, she owned homes in both Lancaster County and Chester County and split time between the two counties. The parties agree that a certificate of trial readiness was filed prior to the instant petition and that, for this docket, two to four days of hearings remain to finalize equitable distribution and an outstanding exception regarding the date of separation and related matters remain in Chester County. Plaintiff argued her originally chosen forum is inconvenient because the parties reside in Lancaster County and her witnesses and some of defendant's witnesses are located in Lancaster County, and that, in addition to the expense and time to travel to court, finding care for the parties' child would be more difficult when she travels outside of Lancaster County. Defendant responded that Chester County has had the present divorce matter since its filing in 2017, the hearing officer and/or judges have familiarity with the case and parties, that his expert witness is coming from east of Chester County and would have to travel significantly farther to get to

Lancaster County, and that it would cost him significant funds as his current counsel does not and will not practice in Lancaster County. Considering all the factors involved in this case, the court <u>Held</u> Plaintiff's Petition to Transfer Venue was denied.

## **MEMORANDUM**

Plaintiff initially filed a divorce complaint on June 5, 2017. At that time, Plaintiff owned homes in both Lancaster County and Chester County and split time between the two counties. Plaintiff worked in Wilmington, Delaware and bought the Chester County location as it was more convenient for travel to work. However, during the pendency of this action, Plaintiff moved back to Lancaster County full time in 2019 due to a change in jobs. In a related custody matter, Plaintiff filed a Petition to Relocate, which was granted in October of 2019.¹ Defendant originally lived and worked out of houses in both Landenberg and Avondale in Chester County but he currently resides and is looking for work in Lancaster County.

This Court heard extensive testimony and arguments regarding the long and heavily-litigated history of this divorce action as well as related actions. In addition, both parties submitted case law regarding the appropriate venue and the factors this Court should consider in determining if the case sub judice should remain in Chester County. The parties agree that a certificate of trial readiness was filed (6/15/2020) for this matter prior to the instant petition and that, for this docket, 2-4 days of hearings remain to finalize equitable distribution and an outstanding exception regarding the date of separation. In addition, related matters remain in Chester County. The Hearing Officer assigned to the matter is awaiting this Court's decision on the petition to transfer prior to scheduling the final hearing on equitable distribution. The parties disagree on the extent that prior documentation submitted will be useful in that hearing but both agree that updated financials must be submitted for the equitable distribution hearing in front of the Hearing Officer.

Pursuant to Pa.R.C.P. No. 1006(d), this Court "[f]or the convenience of parties and witnesses . . . upon a petition of any party may transfer an action to the appropriate court of any other county where the action could originally have been brought." Presently, there is no dispute that at the time Plaintiff brought the action, it could have been brought in Lancaster County as the parties owned and resided, at least part-time, in a home there. Plaintiff chose to originally bring the action in Chester County due to her filing and litigating a PFA based on events in the Chester County home and her work near Chester County. Plaintiff also asks for a transfer as special relief pursuant to 231 Pa. Code Rule 1920.43(a)(3), which provides a general catch all that at any time after the filing of a complaint in divorce upon petition of a party, the court may "grant other appropriate relief".

Both parties cite to <u>Cheeseman v. Lethal Exterminator</u>, 701 A.2d 156 (Pa. 1997) for the standards regarding forum non conveniens. In <u>Cheeseman</u>, the Pennsylvania Supreme Court stated, inter alia, that a plaintiff's choice of forum should: (1) be given deference; and (2) only be disturbed based on Pa.R.C.P. No. 1006(d)(1) upon a showing by a defendant "that the plaintiff's choice of forum was designed to harass the defendant" or "that the trial in the chosen forum is oppressive to him". <u>Id.</u> at 162. Court further opined that "the defendant must show more than that the chosen forum is merely inconvenient to him." <u>Id. See also Bratic v. Rubendall</u>, 99 A.3d 1, 10 (Pa. 2014) (discussing and affirming the reasoning of <u>Cheeseman</u> and clarifying that "[m]ere inconvenience remains insufficient, but there is no burden to show near-draconian consequences.").

Presently, we are confronted with the unusual situation where it is not the defendant seeking to transfer the matter due to forum non conveniens but the Plaintiff. However, Rule 1006(d)(1) is clear that the court may transfer a matter upon the petition "of any party" and thus this court will disregard the normal deference afforded to Plaintiff's *initial* choice. The Court finds that it is without doubt that Plaintiff could have filed the action originally in Lancaster County but did not choose to do so at that time. Further, based on the testimony presented, it is understandable why Plaintiff chose Chester County originally and why, based on changes in circumstances, Plaintiff now wishes to have the matter heard in Lancaster County. Case law is scarce on the issue of Plaintiff changing her mind regarding the forum desired or the deference that should be afforded Plaintiff's *subsequent* choice of forum; however, this Court will analyze the Rule 1006(d) factors as if Plaintiff was the traditional defendant seeking to transfer the action due to forum non conveniens.

- 23 Pa.C.S. § 5427 lays out the factors to consider for an inconvenient forum argument in custody matters relating to another state exercising jurisdiction, some of which, in addition to the <u>Cheeseman</u> test, were argued by the parties and are helpful here:
  - **(b) Factors.-**Before determining whether it is an inconvenient forum, a court of this Commonwealth shall consider whether it is appropriate for a court of another state to exercise jurisdiction. For this purpose, the court shall allow the parties to submit information and shall consider all relevant factors, including:

\* \* \*

- (3) the distance between the court in this Commonwealth and the court in the [county] that would assume jurisdiction;
- (4) the relative financial circumstances of the parties;
- (5) any agreement of the parties as to which [county] should assume jurisdiction;
- (6) the nature and location of the evidence required to resolve the pending litigation, including testimony of the child;
- (7) the ability of the court of each [county] to decide the issue expeditiously and the procedures necessary to present the evidence; and
- (8) the familiarity of the court of each [county] with the facts and issues in the pending litigation.

Presently, Plaintiff argues that her originally chosen forum is inconvenient due to the fact that both Plaintiff and Defendant reside in Lancaster County and need to travel to court, the witnesses she intends to call are located in Lancaster County, some of the witnesses Defendant intend to call are in Lancaster County, and that, in addition to the **Custer v. Johnson** 43 (2021)]

expense and time to travel to court, finding care for the parties' child would be more difficult when she travels outside of Lancaster County.

Countering that, Defendant states that Chester County has had the present divorce matter since its filing in 2017, the Hearing Officer and/or judges have familiarity with the case and parties, that his expert witness is coming from east of Chester County and would have to travel significantly farther to get to Lancaster County, and that it would cost him significant funds as his current counsel does not and will not practice in Lancaster County.

Ultimately, the scales of convenience tip in favor of keeping the matter in Chester County given: the limited days of hearings remaining; the delay that would result from a transfer of the matter frustrating the desire of the parties (and courts) to resolve the issue with finality<sup>2</sup>; the increase in cost to both Plaintiff (by virtue of having to pay present counsel to drive to Lancaster County for any hearings — an amount presumably considerably more than the cost of child care for the same time period) as well as Defendant (in his need to hire new counsel on a matter with a convoluted and lengthy history); the limited number of witnesses required for the remaining equitable distribution arguments in this matter; the relative proximity of the courts (being a little over one hour apart)<sup>3</sup>; and the familiarity of this Court with the history of the parties and the instant matter. Accordingly, the Petition is denied.
