2. Entity must have an endowment or establish an
endowment eligible to receive donated funds, and must
file proof thereof with its application;
3. Entity must provide accredited education for
caregivers, ideally with an emphasis on elder care,
through nursing assistant training and/or a practical
nursing program approved by the Pennsylvania State
Board of Nursing; and
4. Entity must serve students primarily in Franklin
County, Pennsylvania and the surrounding environs.
5. Each application should also include supporting
materials such as affidavits, mission statements, proof
of accreditation, etc.

for a distribution and permitted to participate in
the hearing.**

The ultimate decision regarding eligibility for a
distribution will be made by the Court.
