Program Description

This Continuing Education Program is presented by the Wilkes-Barre Law and Library Association, the Luzerne County Medical Society, and Wilkes University. It is sponsored by the Association's Medical-Legal/Disabilities Committee, Chaired by Jacqueline A. The program will be moderated by Mark Hiller of WBRE TV and will be broadcasted on that station.

The course is designed to provide information for the lawyer, doctor and layperson on the use and abuse of opioids in Luzerne County with legal/medical issues being explored, including involvement by the Drug Court of Luzerne County and treatment options for abusers. For those attorneys staying for the full duration of the program, this CLE program offers and is approved by the CLE Board for two hours of substantive continuing legal education credit.
