A Petition has been filed asking the Court to put an end to all rights you

The Court has set a hearing to consider ending your rights to your children. That hearing will be held in the Lycoming County Courthouse in Courtroom No. 5, 48 West Third Street, Williamsport, Pennsylvania on November 25, 2013 at 2:30 p.m. If you do not appear at this hearing the Court may decide that you are not interested in retaining your rights to your children and your failure to appear may affect the Court's decision on whether to end your rights to your children.
