In these three alleged errors, A.K. implicitly suggests that the evidence was insufficient to prove beyond a reasonable doubt that he committed the delinquent acts alleged against him. Consistent with his counsel's argument during the adjudicatory hearing, A.K. does not contest that the offenses occurred, just that he was found to be the offender. A review of the above-referenced findings of fact, and the reasonable inferences derived from them, clearly demonstrate that these alleged errors are without merit, and that the court did not abuse its discretion when it found that A.K. committed the offenses.

The standard of review for sufficiency of evidence claims is well settled:

[W]hether, viewing the evidence in the light most favorable to the Commonwealth, and drawing all reasonable inferences favorable to the Commonwealth, there is sufficient evidence to find every element of the crime beyond a reasonable doubt....The Commonwealth may sustain its burden of proving every element of the crime beyond a reasonable a reasonable doubt by means of wholly circumstantial evidence.....Moreover, in applying the above test, the entire trial record must be evaluated and all evidence actually received must be considered.... Finally, the trier of fact, while passing upon the credibility of witnesses and the weight to be afforded the evidence produced, is free to believe all, part or none of the evidence.

*Commonwealth v. Hunter*, 768 A.2d 1136, 1141-1142 (Pa. Super. 2001) (internal citations and quotations omitted).

Although a conviction must be based on "more than mere suspicion or conjecture, the Commonwealth need not establish guilt to a mathematical certainty." *Commonwealth v. Coon*, 695 A.2d 794, 797 (Pa. Super. 1997) (internal citation omitted).

> [T]he facts and circumstances established by the Commonwealth need not be absolutely incompatible with the defendant's innocence, but the question of any doubt is for the trier of fact unless the evidence [is] so weak and inconclusive that, as a matter of law, no probability of fact can be drawn from the combined circumstances.

*Commonwealth v. Seibert*, 622 A.2d 361, 363 (Pa. Super. 1993), *appeal denied*, 642 A.2d 485 (Pa. 1994) (internal citations omitted).

In accordance with the credible facts, within approximately a day and a half prior to the discovery of the black painted swastika in the T.J. Maxx store bathroom, A.K. was recorded on the store video camera walking toward the bathroom and then leaving the store after a few minutes, possessing a can of black spray paint in his pocket. A.K. had purchased nothing in the store. When asked by the police a few days later if he was in the T.J. Maxx store on the date he was shown to have been there, A.K. lied, denying his presence there. A long recognized evidentiary principle holds that the making of a false statement by the accused to the police may be inferred by

the fact finder to demonstrate an intent to avert suspicion and an indication of guilt. *See Commonwealth v. Boyle*, 447 A.2d 250, 255-256, (Pa. 1982). A.K. appeared to have no purpose for entering the store other than using his spray paint. His intent to avert suspicion significantly enhanced that conclusion.

This extremely strong evidence that A.K. spray-painted the swastika in T.J. Maxx's bathroom is exponentially augmented, and strengthened, when it includes the Valley Forge Middle School video evidence. That camera evidence depicts a male wearing all dark clothing, sneakers, and a backpack, consistent with the clothes, shoes and backpack A.K. was wearing at the T.J. Maxx store a few hours earlier, walking up to the two Valley Forge Middle School signs which are undamaged, but then shown spray-painted with black swastikas immediately after he and his male companion leave them. It is a reasonable inference that A.K. painted those swastikas, as well as the T.J. Maxx swastika, with his can of black spray paint, before walking, in accordance with his video-depicted direction of travel, to the Middle School athletic pavilion, and once there, also spray painting the black swastika found on the pavilion exterior. Each of these four symbols of racial hatred are identical, each are painted with the exact type of paint, spray paint, and with the same color paint, black, A.K. had on his person that evening. It is an additional reasonable deduction that A.K. used his black spray paint to then deface the interior of the pavilion with racial slurs and a derogatory remark against his female neighbor and fellow student. Importantly, A.K.'s last police contact related to his ongoing acrimonious relationship with her, was just days before this targeted verbal attack. Therefore, at the time of the spray painting, A.K. had a unique and timely reason to disparage her.

Consistent with, and supportive of, these inferences, the evidence proved A.K. was out with his cousin the evening of March 25, 2023, after coming home from the T.J. Maxx store. Both A.K. and his cousin were wearing clothes which exactly matched the clothes worn by the two males depicted walking on the Middle School property. Indeed, the black Brooks sneakers with white markings A.K. is seen wearing in school a few days after the crimes, and which were shortly thereafter found at his home, exactly matched the shoes worn by the male wearing all dark clothes at the Middle School. Valley Forge Middle School offenses, A.K. had used his computer for information regarding the particular "shiesty" mask that both males were wearing that evening. Just as significantly, A.K.'s computer searches also included racially charged language against African Americans, including the identical racial slur spray-painted in the Middle School pavilion. It is reasonable to infer that soon after A.K. typed this racial slur into his computer, he spray-painted that same racial slur, and other related racial disparagements, inside the pavilion.

Consequently, the direct and circumstantial evidence, along with all reasonable inferences derived therefrom, provided more than sufficient evidence for the court to conclude that A.K. committed these offenses. Certainly, the evidence was not so weak and inconclusive that no probability of fact could be drawn from the combined circumstances. To the contrary, a suggestion that all of this evidence implicates A.K.

merely by a coincidence of events would be wholly unreasonable.7

#### Alleged Error No. 4

"4. The Court committed an error of law and/or abused its discretion when the Court overruled Appellant's objection and allowed witness testimony where the witnesses had no personal knowledge. Both Chris Groppe, the School District's Director of Safety and Student Services, and Corp. Christopher Middleton, testified to a relationship of some sort between Appellant and the student named as a 'whore' on the interior of the school bathrooms, and neither parties had personal knowledge of said relationship. *See* Notes of Testimony, N.T. 10/2/2023 at 31-32; *See also* Exhibit C-13."

This issue was not properly preserved and is therefore waived. Even if the issue had been preserved, and had merit, any error by the court would have been harmless. A.K.'s counsel did not contest that there was an acrimonious relationship between A.K. and the subject female, that they were neighbors, or that they were fellow students. A.K.'s own witness, his mother, testified at length regarding A.K.'s rancorous relationship with the targeted girl and acknowledged she was a neighbor.

As to Commonwealth witness Chris Groppe ("Mr. Groppe"), A.K.'s defense counsel only made a general objection when Mr. Groppe was asked if the female student named by the graffiti had any relation to A.K. When the court requested the basis of his objection, A.K.'s counsel simply responded with the question, "How would he know about a relationship between - -". (N.T., 10/2/23, at 31-32). Because no specific basis for the objection was raised, but only a question presented, the court had no basis upon which to sustain the objection. In response to counsel's question, the court invited counsel to ask the witness his question when it was counsel's turn to ask questions on cross examination. Additionally, when Mr. Groppe answered the question the Commonwealth's attorney had presented to him, he simply said that he had learned that A.K. and the female were neighbors and had "some sort of relationship." (N.T., 10/2/23, at 32). Later, A.K.'s counsel did not ask Mr. Groppe any questions about the relationship, including how Mr. Groppe would know about the two of them being neighbors – the only sort of relationship which Mr. Groppe testified he knew about the two of them. (N.T., 10/2/23, at 35-42).

The Pennsylvania Rules of Evidence limit the extent to which evidentiary rulings may be treated as sources of reversable error. Pa.R.E. 103(a)(1) requires the objecting

<sup>&</sup>lt;sup>7</sup> Alleged errors 1, 2, and 3 pertain only to the felony and misdemeanor offenses A.K. was found to have committed. They do not relate to the summary offense of criminal mischief which A.K. was also found to have committed beyond a reasonable doubt. That summary offense relates exclusively to the graffiti A.K. left in the T.J. Maxx store. The offense was listed as a summary because the Commonwealth did not allege the damage caused resulted in a loss exceeding \$150.00. 18 Pa.C.S. § 3304(b). If A.K. has properly preserved an allegation of error as to that summary offense, the court's above discussion responding to alleged errors 1, 2, and 3 fully explain the reasons why the court found that A.K. committed it.

party to state the specific ground of objection, if the specific ground is not apparent from the context. If the specific ground of objection is not raised at trial, it cannot be argued on appeal and it is deemed waived. *See, Commonwealth v. Shank*, 883 A.2d, 658, 672 (Pa. Super. 2005). Here, the specific ground of the objection cannot be gleaned from the context of the objection since the only explanation offered was defense counsel's question regarding the source of Mr. Groppe's knowledge of the relationship. The record is left silent as to whether Mr. Groppe knew A.K. and the subject female were neighbors from personal knowledge, obtained the information from A.K. himself or learned it from another person. Even if defense counsel had implied that his objection was hearsay, the court could not rule on that objection since the source of Mr. Groppe's information about the relationship was never made known, including by any questions from A.K.'s attorney.

When Corporal Christopher Middleton ("Cpl. Middleton") testified regarding A.K. and the named female student, no objection at all was made to his direct testimony regarding their relationship. (N.T., 10/2/23, at 88-89). A.K.'s counsel himself, on cross examination, elicited from Cpl. Middleton that the female was a "direct neighbor" and that Cpl. Middleton had been to both her house, and A.K.'s house, regarding incidents alleged to have involved one or the other. (N.T., 10/2/23, at 102-104). Consequently, any issue now as to Cpl. Middleton's testimony concerning the relationship between A.K. and his female neighbor was not preserved and is waived.

Even if a proper objection had been made to Mr. Groppe and Cpl. Middleton's testimony concerning A.K.'s relationship with his female neighbor, any error made by the court would be harmless error since A.K.'s own witness, his mother, [C.T.] testified about it on direct examination in A.K.'s case. In response to questions presented to her by counsel for A.K., [C.T.] did not contest that A.K. and the female were fellow students, agreed they were neighbors, and described examples of concerning, possibly harassing, incidents involving A.K. and this female, some of which involved police contact. (N.T., 10/2/23, at 125-129). Therefore, A.K.'s unfriendly relationship with this neighborhood girl would have been considered by the court even if the testimony regarding their relationship had never been testified to by Mr. Groppe or Cpl. Middleton. Consequently, this issue is waived, or if not waived, is without merit.

#### Alleged Error No. 5

"5. The Court committed an error of law and/or abused its discretion when the Court denied Appellant's oral motion for a dismissal after the Commonwealth presented its case, and Appellant's guilt was not proven beyond a reasonable doubt."

No error of law or abuse of discretion could have been made by the court when it denied A.K.'s oral motion for summary judgment/dismissal of the charges. (N.T., 10/2/23, at 108). In contrast to the procedures in criminal court, where a defendant may make a motion for judgment of acquittal at the close of the Commonwealth's case-in-chief, Pa.R.Crim.P. 606(A)(1), there is no parallel procedure in juvenile court.

To the contrary, the adjudicatory hearing in juvenile court is held in an "informal" manner without many of the procedures available in adult criminal court. Pa.R.J.C.P. 406(A). Even if the juvenile court procedures did permit the equivalent of a motion for judgment of acquittal, the standard to evaluate the motion would have been the same standard used to determine whether the evidence was sufficient to sustain the court's conclusion that the offenses were proven beyond a reasonable doubt. *See, Commonwealth v. Sunealitis,* 153 A.3d 414, 420 (Pa. Super. 2016). As the court has described above in response to alleged errors 1, 2 and 3, the evidence was amply sufficient.

As to the last portion of this alleged error, that A.K.'s "guilt" was not proven beyond a reasonable doubt, "guilt" is not a term recognized in juvenile court. Rather, at the conclusion of the adjudicatory hearing, the juvenile court judge is obligated to rule on the alleged offenses to determine which, if any offenses, were proven by the Commonwealth beyond a reasonable doubt. Pa.R.J.C.P. 408. The court's discussion above in response to alleged errors 1, 2, and 3, fully set forth the facts, inferences and conclusions made by the court in support of its ruling that certain offenses were proven against A.K. Therefore, this alleged error is without merit.

### Alleged Error Nos. 6, 9 and 10

"6. The Court committed an error of law and/or abused its discretion when the Court failed to consider the initial targeting of Appellant as a prime suspect by law enforcement with no basis. The Court disregarded the testimony presented that Appellant was almost immediately declared the prime suspect, while at the same time, law enforcement testified that they were unaware of the reasoning or basis for Appellant being declared a prime suspect.

9. The Court committed an error of law and/or abused its discretion when it failed to consider [C.T.]'s relevant testimony relating to the incidents that led up to the accusations against Appellant.

10. The Court committed an error of law and/or abused its discretion when it failed to consider the testimony presented establishing similar subsequent acts of purported vandalism were discovered, and Corp. Middleton's testimony confirming there was no way Appellant could have committed the subsequent acts."

Each of these three issues allege that the court erred or committed an abuse of discretion when it "failed to consider" or "disregarded" certain evidence presented during the adjudicatory hearing. To the contrary, the court considered all of the evidence, and disregarded none of it, before deciding issues of witness credibility and ruling on the alleged offenses. As it is required to do as fact finder, before passing on

the credibility of witnesses and the weight to be afforded the evidence produced, the court was free to believe all, part, or none of the evidence. *Commonwealth v. Hunter, supra*. The court specifically considered all of the evidence provided by A.K.'s mother and Cpl. Middleton before making its credibility and weight determinations. The result of those factual and credibility determinations is largely described above in the court's Findings of Fact. Consequently, these alleged errors are without merit.

## Alleged Error No. 7

"7. The Court committed an error of law and/or abused its discretion when it disregarded witness [C.T.]'s testimony as to the whereabouts of Appellant during the time frames in which the acts were suspected to occur. The Court erred in precluding Appellant from offering alibi evidence where Appellant was not afforded notice of the dates and times of the acts alleged to have occurred, prior to the bench trial."

As with other errors alleged by A.K., this issue was not preserved and is therefore waived. Even if not waived, it is without merit. When A.K.'s counsel was requested for an offer of proof as to [C.T.]'s testimony, counsel at first stated that a portion of her testimony could possibly be related to an alibi. (N.T. 10/2/23, at 109). After [C.T.] testified on direct examination and the Rule of Juvenile Court Procedure pertaining to alibi, Pa.R.J.C.P. 341, was discussed, A.K.'s attorney conceded that the delinquency petition against A.K. provided A.K. and him notice that the alleged offenses occurred on Saturday, March 25, 2023, between 5:00 pm and midnight. A.K.'s counsel agreed that he could not represent to the court that he did not have notice that the offenses were allegedly committed in that time period. He further agreed that for [C.T.]'s testimony to be admitted as alibi testimony, A.K.'s counsel would have had to give notice of that alibi defense to the Commonwealth prior to the hearing. (N.T., 10/2/23, at 131-132). A.K.'s counsel then represented to the court that, "I wasn't calling her as an alibi witness." (N.T., 10/2/23, at 132). Her testimony was only offered, according to A.K.'s counsel, to describe her conversations with the police, in A.K.'s presence, after the police came to her home on March 28, 2023. Consequently, A.K. cannot now suggest that he preserved offering [C.T.]'s testimony as alibi evidence, or that he did not have notice of the dates and times of the alleged delinquent acts. This alleged error has therefore been waived.

Furthermore, as a result of A.K.'s attorney specifically informing the court that he was not calling [C.T.] as an alibi witness, the court never ruled on A.K.'s failure to give notice to the Commonwealth that [C.T.] would be providing an alibi defense. If the court had been in a position to rule on that failure to give notice, it could have made any one of various rulings in accordance with Pa.R.J.C.P. 341(B). Pursuant to Rule 341(B), the court could have excluded [C.T.]'s testimony as to alibi, granted a continuance of the Commonwealth to investigate [C.T.]'s alibi evidence, or make another ruling "as the interests of justice" required. Pa.R.J.C.P. 341(B). Because the court was never in a position to rule on A.K.'s failure to provide notice of alibi, it never had the opportunity to preclude [C.T.] from testifying as an alibi witness, reschedule her testimony to another date after the Commonwealth had investigated the alibi, or make another ruling.

In any event, any error the court committed with regard to alibi would be harmless because the court allowed [C.T.] to testify, did not strike it from the record and considered it before making a decision. Ultimately however, her testimony was not deemed credible as to A.K.'s location at the time the Valley Forge Middle School camera recorded the two males intruding onto the Middle School property on the evening of March 25, 2023. Therefore, this alleged error is waived, but if not waived, is without merit.

## Alleged Error No. 8

"8. The Court committed an error of law and/or abused its discretion when it found irrelevant certain testimony and materials offered by [C.T.] where the evidence was material to the instant case, and the Commonwealth failed to disclose certain material items required to be disclosed, pursuant to Pa.R.Crim.P. 573; *Brady v. Maryland*, 373 U.S. 83 (1963). ie. Certain relevant incident reports and events, video footage, and relevant school records."

This alleged error, predicated as it is on "certain" testimony and materials offered by [C.T.] having been found irrelevant by the court, and the failure of the Commonwealth to disclose "certain" material items is too vague for the court to properly address and is therefore waived. *See, Commonwealth v. Hernandez*, 39 A.3d 406, 411 (Pa. Super. 2012). Nowhere in the record has the court found that it prevented [C.T.] from offering any testimony or materials based on a relevancy objection by the Commonwealth (N.T., 10/2/23, at 108-134). In fact, the only Commonwealth objection to relevancy made during [C.T.]'s testimony was overruled by the court (N.T., 10/2/23, at127-128). Furthermore, the court has found nothing in the record to suggest that A.K. preserved any claim, or made the court aware, that the Commonwealth failed to disclose material items to him, including any incident reports, video footage, or school records. Because of the vagueness and lack of preservation of this alleged error, the court is stymied in its ability to address it.<sup>8</sup> For these reasons, this issue is waived and should be dismissed.

<sup>&</sup>lt;sup>8</sup> Additionally, A.K. again cites a Rule of Criminal Procedure, Pa.R.Crim.P. 573, which is not applicable to a juvenile delinquency proceeding.
