Notice is hereby given that the Neshannock Creek Watershed Joint Municipal Authority, in compliance with the Municipality Authorities Act of 1945, P.L. 382, as amended (53 Pa.C.S. §5601 et seq.), (the "Act") will file in the office of the Secretary of the Commonwealth of Pennsylvania on or about the 10th day of May, 2017, Articles of Amendment of the Articles of Incorporation of the Neshannock Creek Watershed Joint Municipal Authority, pursuant to Ordinances adopted by the Borough of Mercer, the Township of Findley, the Township of Coolspring, the Township of Springfield, the Township of East Lackawannock and the County of Mercer, comprising all of the member municipalities of the Neshannock Creek Watershed Joint Municipal Authority, as well as a Resolution of the Neshannock Creek Watershed Joint Municipal Authority, each providing that the Neshannock Creek Watershed Joint Municipal Authority, which was formed by filing of Articles of Incorporation on September 9, 2003, pursuant to the Act, hereby extends its term of existence to fifty years from the date of the approval and filing of the Articles of Amendment of the Articles of Incorporation.

(1) The name of the Authority is the "Neshannock Creek Watershed Joint Municipal Authority" having the location of a registered office at 369 McClelland Road, Mercer, PA 16137.

(2) The Articles of Amendment are to be filed with the Secretary of the Commonwealth under the provisions of and pursuant to the requirements of the Act.

(3) The nature and character of the proposed Amendment to the Articles of Incorporation of the Authority is that the Articles of Incorporation of the Authority are hereby amended by the addition of Section SEVENTH to the Articles of Incorporation and stated as follows:

"SEVENTH: The term of existence of the Neshannock Creek Watershed Joint Municipal Authority shall be increased to fifty years from the date of approval and filing of these Articles of Amendment of the Articles of Incorporation."

(4) The Articles of Amendment of the Articles of Incorporation of the Neshannock Creek Watershed Joint Municipal Authority will be filed with

the Secretary of the Commonwealth of Pennsylvania on or about May 10, 2017.
