**AMENDED COMPLAINT IN DIVORCE**

Request for a No-Fault Divorce Under  
Section 3301(d) of the Divorce Code

1. Plaintiff is Ariane Davis, an adult individual who resides at 8214 Stockton Road, Elkins Park, Montgomery County, Pennsylvania 19027.

2. Defendant is Adam Davis, an adult individual with an unknown current mailing address. His last known mailing address was 1700 N. Peach Street, Philadelphia County, Pennsylvania 19131.

3. The parties were married on June 14, 2014, in Philadelphia County, Pennsylvania.

4. The parties lived together until their separation in February of 2022.

5. After a good faith investigation, no leads to Defendant's current whereabouts have been found. Plaintiff had exhausted all possible options to locate Defendant.

6. On August 16, 2023, the Court entered an Order approving service by publication.

7. There has been no prior action for divorce or annulment instituted by either of the parties in this or any other jurisdiction.

8. Neither the Plaintiff nor Defendant is currently in active-duty military service of the United States or its allies.

9. Plaintiff is proceeding for divorce from Defendant on the following grounds: 3301(d).

WHEREFORE, Plaintiff respectfully requests the Honorable Court to enter a Decree of Divorce divorcing Plaintiff from Defendant pursuant to 23 Pa. C.S.A Section 3301(d).
