PIKE COUNTY DISTRICT ATTORNEY PRESS RELEASE PIKE COUNTY SENTENCING INFORMATION

January 08, 2021 — Pike County District Attorney Raymond J. Tonkin announced the following criminal sentences were issued by Pike County Court of Common Pleas President Judge Gregory Chelak:

Dominic Joseph Mastri, age 77, of South Abington Township, PA, was sentenced to 6 months of probation and fined \$300.00 for the crime of Harassment. The state police were dispatched to a neighbor dispute at a residence in Greene Township on November 15, 2019, where Mastri communicated in a threatening manner in an attempt to harass and annoy the individual.

Brittany Lynn Rodriguez, age 23, Dingmans Ferry, PA, was sentenced to 6 months of probation and fined \$100.00 for the crime of Disorderly conduct. The state police were dispatched to a disturbance at a parking lot in Lehman Township on August 9, 2019. When Rodriguez was ordered to cease her behavior, she engaged in disruptive behavior.

Jessica Marie Vazquez, age 29, of Glen Spey, NY, was sentenced to 12 months of probation and fined \$300.00 for the crime of Retail Theft. Vazquez took merchandise valued at \$199.00 from a retail store in Westfall Township on January 24, 2014, without paying for it.

Carl Joseph Braunagel, age 23, of Montague, NJ, was sentenced to 18 months of probation and fined \$300.00 for the crime of Possession with Intent to Manufacture or Deliver a Controlled or Counterfeit Substance. Eastern Pike Regional Police stopped Braunagel on January 8, 2020, at Westfall Town Center for an expired registration. Upon speaking with Braunagel, the officer detected the smell of Marihuana. A search of Braunagel's vehicle revealed 39.6 grams of Marihuana.

Casey Theodore Homer, age 25, of Matamoras, PA, was sentenced to 3 years of probation and fined \$600.00 for the crimes of Retail Theft, Possession of Drug Paraphernalia and Possession of a Controlled Substance. Homer was found in possession of hypodermic needles, a spoon, glass pipe, glassine packets and additional items of paraphernalia while at a business in Matamoras on May 27, 2019. Homer took items with a retail value of \$224.98 from a retail store in Westfall Township on July 9, 2019. Homer was found in possession of Heroin at a residence in Matamoras Borough on July 23, 2019.

Michael A. Chalhoub, age 54, of Milford, PA, was sentenced to a fine of \$200.00 for the Summary Offense of Harassment. On August 27, 2020, Chalhoub did harass, annoy, alarm, strike, shove or threaten an individual with physical contact at a residence in Dingman Township.

Lisa Ann Schmidt, age 50, presently incarcerated in the Pike County Jail, was sentenced to 1 month to 6 months in a state correctional facility to run concurrent to her prior sentence, a fine of \$1,400.00 and will have her driver's license suspended for a duration to be determined by PennDOT for the crimes of Driving Under the

Influence of Alcohol or a Controlled Substance and 2 counts of Possession of a Controlled Substance. The state police encountered Schmidt stumbling and staggering as she walked along Whipporwhill Drive in Lehman Township on May 11, 2018. When asked if she was in possession of any illegal substance, she provided the trooper with a pipe used to smoke controlled substances. The state police stopped Schmidt for failing to use a turn signal upon entering Mink Pond Road in Lehman Township on June 20, 2018. A consent to search the vehicle revealed a crack pipe. Field Sobriety Tests indicated impairment and a blood test confirmed the presence of Benzoylecgonine and Oxycodone in her blood.

Mark Andrew Cunning, age 36, of Mt. Pocono, PA, was sentenced to 8 months to 18 months in the Pike County Jail and fined \$800.00 for the crimes of Endangering the Welfare of Children and Possession of a Controlled Substance. The state police were dispatched to a residence in Lehman Township where Cunning reported someone was attempting to break in. Cunning, who was found under the influence of a controlled substance while in the presence of a minor child was also found in possession of Cocaine and Methamphetamine.

Mark Anthony Hosang, age 39, of Bushkill, PA, was sentenced to 10 days to 2 years in the Pike County Jail and fined \$525.00 and had his driver's license suspended for 12 months for the crime of Driving Under the Influence and the Summary Offense of Careless Driving. The state police were dispatched to Bristol Way in Lehman Township where Hosang had crashed into another vehicle. When speaking with Hosang, the trooper detected the smell of an alcoholic beverage and observed Hosang to have bloodshot, glassy eyes. Hosang admitted to drinking prior to driving. Field Sobriety Tests showed impairment and a blood test confirmed a blood alcohol content of .084%.

Kirk J. Olsen, age 44, of Bushkill, PA, was sentenced to 6 months of the Pike Care Probation with Restrictive Conditions Program, which will include 30 days of GPS Electronically Monitored House Arrest combined with Soberlink Monitoring, a fine \$750.00 and a driver's license suspension of 12 months for the crime of Driving Under the Influence. The state police responded to a one-vehicle accident along Whipporwill Drive in Lehman Township where Olsen went off the road and hit an embankment on June 10, 2020. When contact was made with Olsen, the trooper detected the smell of an alcoholic beverage and observed Olsen to have glassy, blood shot eyes and slurred speech. Olsen denied consuming any alcoholic beverages. Field Sobriety tests showed multiple clues of impairment and a breath test confirmed a blood alcohol content of .115%.
