# Balcavage Landscape Services, LLC vs. Schoolhouse Lane Community Association

Preliminary objections – Appeal from magisterial district court judgment - Res judicata - Collateral estoppel

- 1. A membership interest in a limited liability company is an ownership interest and is akin to an interest in stock of a corporation.
- 2. A party aggrieved by a magisterial district court judgment for money must file a notice of appeal with the prothonotary of the court of common pleas within 30 days of the date judgment is entered. If an aggrieved party timely files the notice and otherwise perfects the appeal, the district court judgment is nullified and the case proceeds *de novo* in the court of common pleas. Conversely, if an aggrieved party fails to file the notice of appeal, the district court judgment is final and the action is unappealable.
- 3. A party is not at liberty to bypass appealing a magisterial district court judgment and instead file an original action in the court of common pleas on the same claim against the same defendant. If he or she does so, the defenses of res judicata or collateral estoppel may bar the claim.
- 4. Res judicata and collateral estoppel are defenses which should be pled in an answer as new matter and are typically considered by a trial court only after the pleadings have closed.
- 5. The defense of res judicata only applies when there is, *inter alia*, an identity of the persons and parties in the present and prior actions.
- 6. Res judicata is also available when the party against whom the defense is asserted is in privity with the party to the prior action.
- 7. When parties are in privity with one another, they are considered to be identical for purposes of res judicata.
- 8. Defendant argues that Plaintiff's complaint must be dismissed because Plaintiff's representative previously filed suit against Defendant in magisterial district court on the exact same landscaping contract and Plaintiff failed to lodge an appeal from the district court judgment within thirty days. The district court action was not actually filed by Plaintiff, a limited liability company, but instead by an individual who holds a membership interest in Plaintiff. Because Plaintiff was not a party to the district court action, Plaintiff was not obligated to file a notice of appeal from the district court judgment, despite the fact that, on the face of the pleadings, the claim asserted by the Plaintiff in the district court action and claim asserted by the Plaintiff in the instant action appear to be identical. Upon consideration of Defendant's Preliminary Objection to Plaintiff's Complaint, the Objection is overruled and Defendant is granted leave to file an Answer to the Complaint.

#### ORDER

**AND NOW**, this 13th day of November, 2020, upon consideration of Defendant's Preliminary Objection to Plaintiff's Complaint and Plaintiff's Response thereto, it is hereby **ORDERED** and **DECREED** that the Objection is **OVER-RULED** and Defendant is granted leave to file an Answer to the Complaint within twenty (20) days of the entry of this Order on the docket.<sup>1</sup>

Defendant argues that Plaintiff's complaint must be dismissed because Plaintiff's representative previously filed suit against it in magisterial district court on "the exact same 2019 landscaping contract" which is the subject matter of the instant action, and Plaintiff failed to lodge an appeal from the district court judgment within thirty days. As Defendant recognizes in its preliminary objection, the district court action was not actually filed by Plaintiff — a limited liability company — but instead by an individual identified as Conor Balcavage. Both parties acknowledge that Mr. Balcavage holds a membership interest in Plaintiff. See generally, Missett v. Hub Int'l Pennsylvania, LLC, 6 A.3d 530, 537 (Pa. Super. 2010) (Explaining that a "membership interest" in a limited liability company is an owner-

ship interest, and "is akin to an interest in stock of a corporation."). Both parties also acknowledge that

The rules pertaining to the timeliness of an appeal from a magisterial district court judgment are well-settled. Under Rule 1002A of the rules governing district court judges, a party aggrieved by a judgment for money must file a notice of appeal with the prothonotary of the court of common pleas within 30 days of the date judgment is entered. Pa.R.C.P.M.D.J. 1002A. If an aggrieved party timely files the notice and otherwise perfects the appeal, see, id., Nos. 1004 – 1005, 1008, then the district court judgment is nullified and the case proceeds de novo in the court of common pleas. Indep. Tech. Servs. v. Campo's Exp., Inc., 812 A.2d 1238, 1241 (Pa. Super. 2002). Conversely, if an aggrieved party fails to file the notice of appeal pursuant to Rule 1002A, then the district court judgment is final and the action is unappealable. See, e.g., id., 1002A (Providing generally that the prothonotary "shall not accept an appeal from an aggrieved party which is presented for filing more than thirty (30) days after the date

of entry of the judgment[.]").

Notably, the filing of a notice of appeal under Rule 1002A is the exclusive method of having an action heard in the court of common pleas on a claim previously litigated in district court. A party is not at liberty to bypass Rule 1002A following the entry of an adverse district court judgment and instead file an original action in the court of common pleas on the same claim against the same defendant. If he or she does so, the defenses of res judicata or collateral estoppel may bar the claim. See, e.g., Huey v. Parris, 12 Pa. D. & C.4th 16, 21 (Com. Pl. 1991) (Holding that district court judgment had res judicata effect on defendant's counterclaim against plaintiff where defendant failed to file an appeal from the judgment on the same claim).

In this case, the district court entered judgment against Mr. Balcavage for failure to attend the hearing on his complaint. To appeal that judgment, Mr. Balcavage was required to file a notice of appeal within 30 days pursuant to Rule 1002A. The Court agrees with Plaintiff that Rule 1002A is not applicable to the circumstances of this case because Plaintiff was not a claimant in the district court action. As explained above, Rule 1002A requires a "party" aggrieved by a judgment for money to file a notice of appeal. Here, both parties acknowledge that Plaintiff was not a party to the district court action. Consequently, Plaintiff was not obligated to file a notice of appeal from the district court judgment, despite the fact that, on the face of the pleadings, the claim asserted by Mr. Balcavage in the district court action and claim asserted by Plaintiff in the instant action appear to be identical.

The Court therefore overrules Defendant's preliminary objection and grants Defendant leave to file an answer to the complaint. However, the Court's holding should not be construed as an ultimate determination of the merits of res judicata or collateral estoppel as a bar to Plaintiff's action. For starters, both defenses should be pled in an answer as new matter and are typically considered by a trial court only after the pleadings have closed. See, Pa. R.C.P. 1030(a) (Specifying affirmative defenses to be pled in new matter, including estoppel and res judicata). Further, while Plaintiff is correct that the defense of res judicata only applies when there is, inter alia, an "identity of the persons and parties" in the present and prior actions, Tobias v. Halifax Twp., 28 A.3d 223, 226 (Pa. Cmwlth. 2011), res judicata is also available when the party against whom the defense is asserted is in privity with the party to the prior action. See, e.g., Khalil v. Cole, \_\_\_\_\_ A.3d \_\_\_\_, \_\_\_\_, 2020 WL 5858628 (Pa. Super. Oct. 2, 2020) (Explaining that "parties are considered to meet the 'identical parties' requirement of res judicata if the party against whom the plea is asserted was a party or in privity with a party to the prior adjudication.") (cleaned up); DeRaffele v. City of Williamsport, 2019 WL 3779708, at \*3 (Pa. Cmwlth. Aug. 12, 2019) ("When parties are in privity with one another, they are considered to be identical for purposes of res judicata."). The Court expresses no opinion at this juncture on whether a member of a LLC is a party in "privity" with the LLC for purposes of res judicata.
