NOTICE HEREBY IS GIVEN that
the Board of Directors of the Munic-
ipal Authority of the Borough of
Ringtown (the "Authority"), a Penn-
sylvania municipality authority having
its registered address at 31 S. Center
Street, Ringtown, County of Schuyl-
kill, Pennsylvania, has adopted a
resolution proposing a certain amend-
ment to its Articles of Incorporation;
the Authority HAS SUBMITTED
THE PROPOSED AMENDMENT
TO THE Borough Council of
Ringtown, County of Schuylkill,
Pennsylvania (the "Municipality"),
the governing authority of the Munic-
ipality composing the Authority; the
governing authority of the Municipal-
