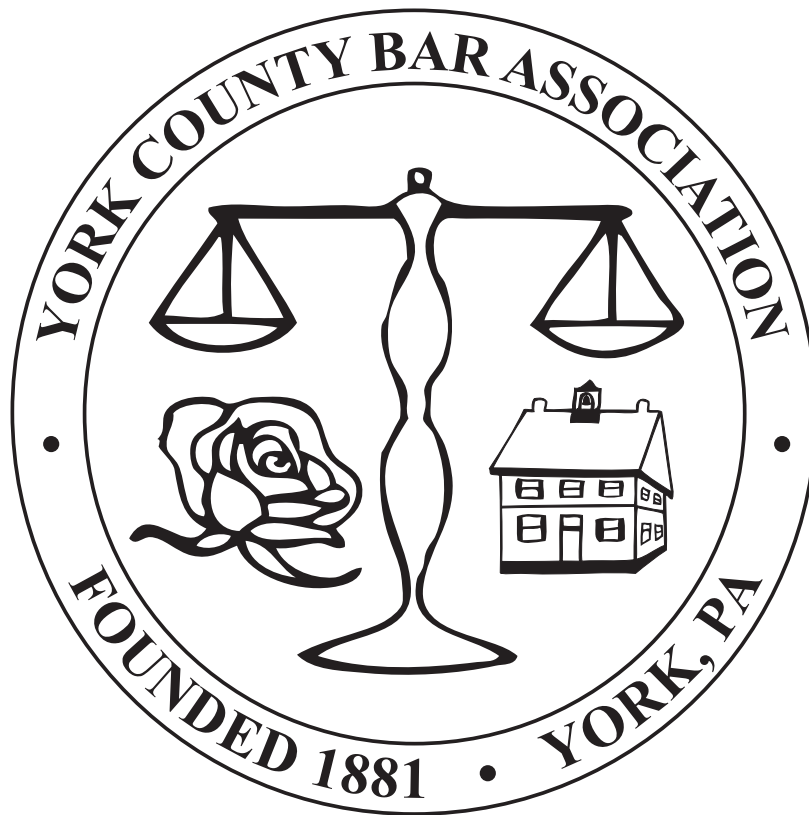

**THERE WAS A TIME**

By J. Ross McGinnis

1953 was a time like no other: from the potato fields of New Park to the lecture halls of Princeton to the Socratic discipline of Harvard Law to a direct commission in the Air Force to membership in an elite professional institution whose antecedents reached back to Magna Carta and the meadows of Runnymede, this was the York County Bar.

The Bar was an exclusive, all male bastion with the exception of one individual whose life would end the following year – Mary Jane Yohe. At her memorial, the Honorable Walter Anderson with remarkable prescience said, “I have no doubt that in the future there will be other members of the fair sex admitted to the Bar of York County, but I gravely question that there will ever be one who will be more beloved than was our gracious and friendly Mary Jane.”

Of course, other females quickly followed in the area of domestic relations, then in all other areas of the practice, then onto the bench with Sheryl Dorney in 1987.

Most bar members in those years – the fifties and sixties were fiercely independent, motivated and inspired by the high calling of the law, universally considered a learned profession and in no way a business.

This sense of commitment and dedication rendered them fierce combatants in the court room while in normal venues they remained the best of friends.

The notion that the practice of law was a business was totally repugnant and the rankest of heresies and advertising was equally abhorrent as being worse than allied with the devil. An enterprising soul innocently posted a sign in the hallway of his building, “honest lawyer upstairs” and he was roundly hooted down for his insensitivity.

In 1957, a Southern York County doctor was indicted and charged with the crime of performing an abortion {it was rumored that this had happened before}. I was retained to represent him and decided I needed help. I invited a young lawyer – Emmanuel Cassimatis to join me and the two of us defended him at trial. We came away with a hung jury – the District Attorney went on the bench and the new District Attorney decided not to retry the case. The doctor went free. This was the last abortion case tried in York County – shortly thereafter abortion was decriminalized. After twenty years as a partner in Stock and Leader, Emmanuel Cassimatis went on the bench – his life ended in 2009 on a tour bus in Rome.

The York County Bar was an early advocate of racial equality. Mattie Chapman, the first African American Prothonotary became the first honorary female member of the Bar. Mattie always provided delightful conversation and a welcome respite to the dreary task of checking the various dockets in the Prothonotary’s Office. At her memorial, the Honorable James Buckingham said, “I believe when Mattie passed, a light went out of this courthouse”.

In 2008 another African American, the Honorable Clarence N. Patterson, Jr. was elected to the bench. His death in November 2011 was sudden and totally unanticipated. At his memorial the Honorable John S. Kennedy said, “He was

just a great man and he's a great loss to our bench and a great loss to the York Legal Community and the community at large."

The Bar Association--before there was an administrative staff and a permanent location and the advent of the Bar Foundation and before it became with the Foundation one of the principle engines of charity in the community--was primarily concerned with regulating lawyer conduct and ethics, sponsoring the annual bar banquet in the winter and the summer golf outing at the Hanover Country Club.

While the gloss of professionalism and fraternity – the hallmarks of my generation – has been clouded by lawyer advertising and commercialization, it must be said that the spirit of social awareness and obligation is alive and well. This has been brought about by the Bar Foundation and the role the Bar has taken on in serving the ideals of social justice and equality. Women are firmly and totally involved and racial equity and social justice efforts are continuing to advance. We can and should be very proud of the York County Bar.



**Sandy Feliz, Esq., Assistant Public Defender**

Sandy Feliz is an Assistant Public Defender in York County. Before becoming an Assistant Public Defender, Sandy interned with the PD's office for approximately a year while he was still in law school. 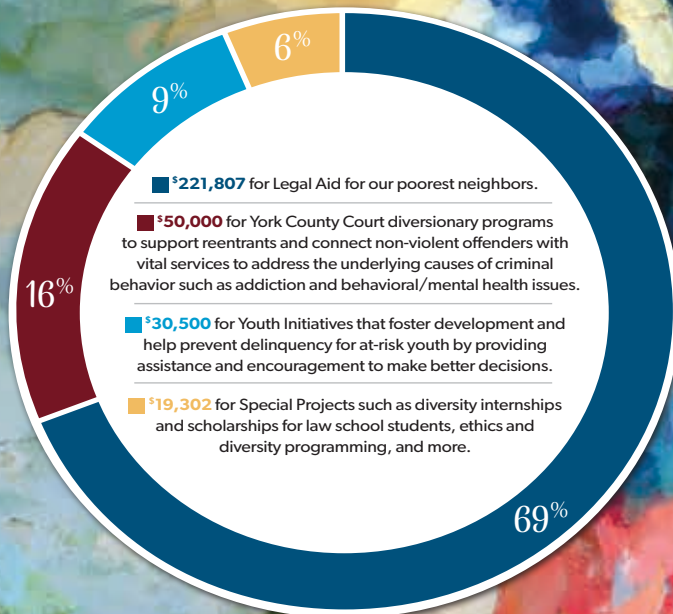

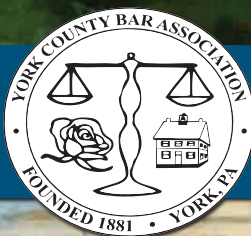

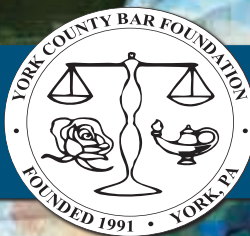
