COMMONWEALTH VS. BROWN

- 1. The Commonwealth need not prove a defendant's guilt to a mathematical certainty but rather may sustain its burden of proving every element of the crime beyond a reasonable doubt by means of wholly circumstantial evidence.
- 2. A critical element of both possession of an instrument of crime and possession of a prohibited offensive weapon is the possession of the prohibited item. Although proof of actual possession is sufficient to satisfy this element, actual possession is not necessary. The Commonwealth may sustain its burden of proof by establishing constructive possession.
- 3. Constructive possession is an inference arising from a set of facts that possession of the prohibited item was more likely than not.
- 4. Our appellate courts have defined constructive possession as "conscious dominion," i.e., the power to control the contraband and the intent to exercise that control.
- 5. Circumstantial evidence, including a defendant's knowledge about the existence of the prohibited item, is sufficient to satisfy the Commonwealth's burden.

OPINION

On March 27, 2007, following jury trial, the Defendant, Parish Lee Brown ("Brown"), was convicted of three counts of robbery¹, criminal conspiracy to commit robbery², possessing instruments of crime³, and possessing prohibited offensive weapons⁴. As a result of the convictions, Brown was sentenced to an aggregate sentence of no less than nine years nor more than 30 years in a State Correctional Institution to be followed by two years of consecutive probation. In his Post-Sentence Motions, Brown challenges the sufficiency of the evidence on the convictions related to possession of an instrument of crime and possession of prohibited offensive weapons. Brown contends that the evidence supporting the convictions was legally insufficient because a co-defendant, rather than he, actually possessed the weapon at issue during the underlying criminal episode. I find this issue meritless and deny Brown's Post-Sentence Motions.

In examining a challenge to the sufficiency of the evidence, a court must determine whether, viewing all the evidence admitted at trial in the light most favorable to the Commonwealth, there is sufficient evidence to enable the fact-finder to find every element of the crime beyond a reasonable doubt. *Commonwealth v. Gooding*, 818 A.2d 546, 549 (Pa.Super. 2003). In meeting its evidentiary burden, the Commonwealth need not prove a defendant's guilt to a mathematical certainty but rather may sustain its burden of proving every element of the crime beyond a reasonable doubt by means of wholly circumstantial evidence. *Commonwealth v. Morgan*, 625 A.2d 80, 82 (Pa.Super. 1993). A trial court may not disturb the verdict of the jury, as fact-finder, provided there is factual support in the record for each element of the crime charged. *Commonwealth v. Hartle*, 894 A.2d 800, 804 (Pa.Super. 2006).

Undoubtedly, a critical element of both possession of an instrument of crime and possession of a prohibited offensive weapon is the possession of the prohibited item.⁵ Although proof of actual possession is sufficient to satisfy this element, actual possession is not necessary. The Commonwealth may sustain its burden of proof by establishing constructive possession.

Constructive possession is an inference arising from a set of facts that possession of the prohibited item was more likely than not. *Commonwealth v. Parker*, 847 A.2d 745, 750 (Pa.Super. 2004). Our appellate courts have defined constructive possession as "conscious dominion," i.e. the power to control the contraband and the intent to exercise that control. *Commonwealth v. Muderick*, 507 A.2d 1212, 1213 (Pa. 1986). Circumstantial evidence, including a defendant's knowledge about the existence of the prohibited item, is sufficient to satisfy the Commonwealth's burden. *Commonwealth v. Gladden*, 665 A.2d 1201, 1206-07 (Pa.Super. 1995).

Instantly, trial evidence revealed that during the morning hours of December 17, 2002, Joseph Bowden, Jonathan Talmadge, and Jason Talmadge interrupted Brown and his co-defendant, Lamar Brown ("co-defendant"), while they were committing a theft of Bowden's girlfriend's car. When confronted by Bowden, the co-defendant

pulled a sawed-off shotgun from under his coat and pointed it into Bowden's stomach. At the time, Brown was standing no more than two feet away from his co-defendant. Both Brown and his co-defendant advised Bowden to get on the ground and told Bowden not to look in their direction. Thereafter, Brown and his co-defendant went over to the Talmadge vehicle and removed Jonathan Talmadge from the vehicle at gunpoint. Once again, Brown was in close proximity to his co-defendant and participated in giving instructions to Jonathan Talmadge. After removing Jonathan Talmadge from the car, the co-defendant awoke Jason Talmadge who was asleep in the back seat of the Talmadge vehicle. While doing so, the co-defendant displayed the sawed-off shotgun and physically contacted Jason Talmadge with the weapon. As before, Brown was in close proximity to this action. On one occasion, Jonathan Talmadge related that the co-defendant stuck the barrel of the sawed-off shotgun in the back of his neck while Brown stood nearby and told him to shut up and look away. After taking personal belongings from the victims, Brown and his co-defendant fled the scene. Following his arrest, Brown related to Officer Harvey of the Gettysburg Borough Police that his co-defendant possessed the firearm and, following the robbery, placed the shotgun in the trunk of the vehicle in which they fled. Brown acknowledged that he was the operator of the get-away car. A subsequent search of the get-away vehicle revealed the presence of the sawed-off shotgun in the vehicle's trunk.

The trial evidence is more than sufficient to establish Brown's constructive possession of the firearm. Brown's extensive involvement in the robberies, conducted at the point of a gun visibly possessed by his co-defendant, is sufficient to establish that he knew of the gun's existence and had the apparent ability and intent to exercise control over its use. See *Commonwealth v. Nelson*, 582 A.2d 1115, 119 (Pa.Super. 1990).

Moreover, the factual circumstances following completion of the robberies establish constructive, if not actual, possession of the prohibited item. Brown was clearly aware of the existence and use of the sawed-off shotgun at the time the weapon was placed in the trunk of a car which he operated. This knowledge was combined with Brown's immediate control of the area in which it was located as he clearly had control of the trunk area in which the firearm was stored.

The totality of the circumstances indicates that Brown, the operator of the vehicle carrying the illegal firearm, had both the power to control the weapon and the intent to exercise that control. See *Commonwealth v. Griffin*, 326 A.2d 554, 556 (Pa.Super. 1974) (driver of a vehicle with knowledge of the criminal conduct had the power to control heroin in the trunk of the vehicle).

For the foregoing reasons, Brown's Post-Sentence Motions are denied.⁶

⁶The Commonwealth contends that Brown has waived any issues concerning trial error as the current Post-Sentence Motions were filed following a re-sentencing. In support of their claim, the Commonwealth correctly notes that Brown did not challenge the sufficiency of trial evidence following the imposition of original sentenc-The Commonwealth cites the Superior Court's recent Opinion in Commonwealth v. McKeever, 947 A.2d 782, 785-86 (Pa.Super. 2008) as support. In the McKeever Opinion, the Superior Court cites Commonwealth v. Gaito, 419 A.2d 1208, 1211, 1211 n. 4 (Pa.Super. 1980) for the proposition that underlying claims of trial error regarding non-vacated convictions could not be addressed on direct appeal following re-sentencing. However, both McKeever and Gaito were decided under former Pennsylvania Rule of Criminal Procedure 1123(a) which provided for the filing of post-verdict motions within ten days "after a finding of guilt." Post-sentence practice has been significantly modified as evidenced by current Rule of Criminal Procedure 720 which provides for the filing of post-sentence motions, including challenges to the verdict, within ten days "after imposition of sentence." See Pa. R.C.P. 720(a)(1). Accordingly, I do not find McKeever or Gaito to be controlling and, therefore, have ruled upon the issue on its merits.
