#### OPINION AND ORDER

Wagner, P.J. January 3, 2022

Before the Court is the Concise Statement for Appeal filed by Appellant, Larry Franklin Shaw, Jr. The Appellant entered pleas to four cases but the Appellant has only appealed his plea to the charges in the above numbered case which include: Aggravated Assault, 18 Pa. C.S. § 2702(a)(4); Possession of Firearm Prohibited, 18 Pa. C.S. § 6105 (a)(l); Terroristic Threats, 18 Pa. C.S. § 2706(a)(l); Simple Assault, 18 Pa.C.S. § 2701 (a)(3); and Recklessly Endangering Another Person, 18 Pa. C.S. 2705. The Appellant was sentenced to five (5) to ten (10) years incarceration at the charge of Possession of Firearm Prohibited, with the charges to run concurrent to the charges at Case Numbers 288 of 2020, 591 of 2020 and 575 of 2019 and consecutive to the sentence imposed at 287 of 2020.

#### CONCISE ISSUE RAISED ON APPEAL

Following the Notice of Appeal Nunc Pro Tune filed by the Appellant, this Court ordered the Appellant to file a concise statement of errors complained of on appeal. Appellant raised only the following issue on appeal: "Whether Appellant's guilty plea was knowing, voluntary and intelligent?"

#### FACTUAL BACKGROUND

At the time of his plea on four cases, the Appellant admitted to possessing a 45 caliber Industria Argentina handgun in his residence and admitted knowing he was not to possess a firearm in Case No. 288 of 2020. (N.T. of 7 /8/20 at pg. 6). At Case No. 591 of 2020, the Appellant entered a no contest plea to the charge Simple Assault for chasing a woman and hitting her in the head with the pistol. (N.T. at pg. 5). In this case, the Appellant did not recite the charges, the Commonwealth read from the criminal information. At No. 300 of 2020, the Uniontown Police were dispatched for a reported shooting that occurred at 221 Connellsville Street in the City of Uniontown. (N.T. at pg. 7). William Mattey, the victim, stated that he had gone to purchase drugs from the Appellant but he did not have any but was in need of some. Id. The Appellant and Mattey

then planned to rob another guy of his drugs. They attempted to commit the robbery but were unsuccessful. Id. As they were returning to the Appellant's residence, the Appellant and Mattey got into a verbal argument. Id. Mattey informed the police that the Appellant then pulled a 45 caliber handgun on him and fired the gun once at him before he fled and then fired the gun a second time. Id.

The Appellant denied that he fired the gun (N.T. at pg, 7). He admitted that it was the same gun but denied that he removed it from the residence in this case. (N.T. at pg. 8). The Appellant stated that Mattey intended to drop the charges against him in this case. The Court explained that Mattey could not drop the charges. (N.T. at 10).

The Commonwealth entered a nol pros to the attempted homicide charge. (N.T. at pg. 8). Later, Defense counsel stated that they were not going to contest that specific charge. (N.T. at 11). The 45 caliber handgun was located at the residence after it was searched pursuant to a search warrant.

On February 5, 2020, a criminal complaint was filed in this case. Thereafter, the Appellant entered into a plea agreement involving this case and three others. At the time of his plea, he was represented by counsel from the Fayette County Office of the Public Defender. On July 8, 2020, the Appellant entered a plea in this case and three others. No direct appeal was filed. On May 24, 2021, the Appellant filed a prose Post-Conviction Relief Act Petition (hereinafter "PCRA"). New counsel was appointed on June 3, 2021 and given forty-five days to file either an Amended Petition or a Finley No-Merit Letter. Counsel filed to withdraw on September 30, 2021, without having taken any action on the Appellant's behalf. This Court denied counsel's request on October 12, 2021. Counsel filed an Amended PCRA motion and one of his allegations was that he did not receive a direct appeal. The Court granted Appellant the right to an appeal nunc pro tune and one was subsequently filed. The Court requested a statement of concise issues be filed by the Appellant and this opinion is the result of the issues raised in his concise statement.

#### DISCUSSION

Appellant's issue on appeal challenges whether his plea to the charges was knowing, intelligent and voluntary. In his concise statement, the Appellant has failed to provide any specificity as to why his plea was unlawful. However, the Appellant in his Amended PCRA and in his prose Motion to Modify and Reduce Sentence, the Appellant in each of those filings asserts that he did not plead guilty to the charges in this case. It is apparent from the record that the Appellant did enter a plea to the charges in this case. A review of all the circumstances surrounding his entry of the plea in this case indicate that, to the contrary, his plea was knowing, intelligent and voluntary.

For a plea to be constitutionally valid, the Appellant must knowingly, intelligently, and voluntarily enter the plea. Commonwealth v. Fluharty, 632 A.2d 312 (Pa.Super. 1993). To determine whether the individual understood the connotations of his plea and its consequences requires an examination of the totality of the circumstances surrounding the enter of the plea. Commonwealth v. Moser, 921 A.2d 526 (Pa.Super. 2007). The law does not require that the Appellant be pleased with the outcome of his decision to enter a plea to the charges. All that is required is that his decision to plead is knowingly,

voluntarily. and intelligently made. Commonwealth v. Willis, 68 A.3d 997 (Pa.Super. 2013). A guilty plea colloquy must affirmatively demonstrate the Appellant understood what he was pleading to when he entered the plea and the consequences from the entry of his plea. Commonwealth v. Lewis, 708 A.2d 497 (Pa.Super. 1998).

Prior to the entry of his plea, the Appellant completed a written guilty plea colloquy which explained the Appellant's rights to him. At the time of the plea, the Appellant stated that the victim, William Mattey, intended to drop the charges and that he had written a statement that the charges were to be dropped. (N.T. at pg. 6). The Appellant denied that he had fired the gun at the victim. Id. As a result, the Commonwealth read into the record the facts of the case which the Appellant confirmed that some of the information was true but not all of it. He stated that they talked about a robbery and got into an argument but the gun was in his residence. (N.T. at pg. 6-7). As a result, the Commonwealth withdrew the attempted homicide charge. There was further discussion about the other charges. Defense counsel stated that he had advised the Appellant to take the deal. (N.T. at pg. 10). The discussion on this case ended when defense counsel stated that he and the Appellant were not going to contest the possession of a firearm charge which the Appellant was to be sentenced at in this case. (N.T. at pg. 11).

The Appellant did not contradict his counsel nor did he respond to the Common-wealth's statement that if he wanted to go to trial on this case, the victim would be sub-poenaed to come in and they would proceed on the charges. (N.T. at pg. 10). The circumstances surrounding the entry of the plea disclose that the Appellant had a full understanding of the nature and consequences of his plea and that he knowingly and voluntarily decided to enter the plea. As the record clearly demonstrates that a plea colloquy was conducted, during which it is evident that the Appellant understood the nature of the charges against him and those that had been withdrawn based on his statements, the voluntariness of the plea has been established.

It is apparent from the record that the Appellant was aware that he was entering a plea to the charges and that he was given the opportunity to go to trial if he did not want to enter a plea. His statement that he never entered a plea in this case clearly lacks credibility.

The Appellant's issue on appeal is without merit. For reasons stated above, this Court respectfully requests that the judgment and sentence be affirmed.
