IN RE: OPINION PURSUANT TO Pa. R.A.P. 1925 Before GUIDO, P.J. OPINION

GUIDO, P.J., January 24, 2017:—

On May 4, 2016, Defendant pled guilty to DUI—highest rate of alcohol second offense. On September 27, 2016, he filed a Motion to Withdraw Guilty Plea in light of the United States Supreme Court's decision in **Birchfield v. North Dakota**, 136 S. Ct. 2160 (2016). We denied his motion. On November 22, 2016, Defendant was sentenced to undergo a period of Intermediate Punishment for 60 months, including a commitment to the Work Release Program for a period of not less than 30 days or more than 90 days. He filed this timely appeal in which he alleges we erred by denying his motion to withdraw his guilty plea.

### FACTUAL BACKGROUND

On September 30, 2015, Defendant was in a car accident. Officer Lively of the North Middleton Police Department suspected that Defendant was under the influence of alcohol. Defendant consented to a blood draw after being read the DL-26 form . His blood alcohol level was .235.

After Defendant pled guilty, but before his sentencing, the United States Supreme Court issued its decision in **Birchfield**. Defendant alleged in his motion to withdraw his guilty plea that he wished to file a motion to suppress the results of his blood draw in light of the **Birchfield** decision.

#### DISCUSSION

Under Pennsylvania law, a defendant has no absolute right to withdraw his or her guilty plea and the trial court has the discretion to grant or deny such a motion. **United States ex rel. Culbreath v. Rundle,** 466 F.2d 730 (3d Cir. 1972). However, requests for withdrawal made prior to sentencing should be liberally allowed. **Commonwealth v. Forbes,** 450 Pa. 185, 299 A.2d 268 (1973). Any fair and just reason will suffice to support granting a request to withdraw, unless withdrawal would substantially prejudice the Commonwealth. **Commonwealth v. Carrasquillo,** 631 Pa. 692, 704, 115 A.3d 1284, 1292 (2015). The trial court's role is to determine "whether the accused has made some colorable demonstration, under the circumstances, such that permitting withdrawal of the plea would promote fairness and justice." **Id.** at 706, 115 A.3d at 1292.

Defendant's basis for his motion to withdraw was the possible suppression issue created by the **Birchfield** ruling regarding the voluntariness of his consent to the blood draw. He did not contest the validity of the results which showed he had a blood alcohol content almost three (3) times the legal limit.<sup>2</sup> Nor did Defendant contend that he was not under the influence of alcohol to a degree that he was incapable of driving safely.

Defendant waived any suppression issues by pleading guilty. A guilty plea waives all non-jurisdictional defects and defenses. Commonwealth v. Culbreath, 439 Pa. 21, 26, 264 A.2d 643, 645 (1970). Defendant was well aware that his guilty plea waived his right to file a suppression motion to challenge the admissibility of the evidence, as evidenced by the probing plea colloquy and Defendant's affirmation.<sup>3</sup> There is no question that Defendant's guilty plea was made knowingly, intelligently and voluntarily. The fact that the case law changed to give him an arguable suppression issue, did not, in our opinion, justify the withdrawal of his guilty plea. See Carrasquillo, supra at 705, 115 A.3d at 1292 (holding that a bald assertion of innocence does not amount to a fair and just reason for presentence withdrawal of the plea); Forbes, supra (recognizing that there is no absolute right to withdraw a guilty plea and that it is at the trial court's discretion to grant leave to withdraw only where there has been a demonstration that such is necessary to correct a manifest injustice).
