5. You did not have any physical contact with Decedent for more than Twenty-Eight (28) years;
6. You did not have any direct or indirect contact with Decedent for more than Twenty-Eight (28) years.
7. By virtue of the above actions, or lack thereof, and pursuant to 20 Pa.C.S.A. § 2106, you forfeited your right to claim a share of Decedent's estate and should not be considered an heir of Decedent's estate.
8. By virtue of the above actions, or lack thereof, Decedent's heirs are Decedent's one (1) niece and one (1) nephew as Decedent had no children, no surviving parents, no sur-

viving siblings.
